 1.2 relating to transportation; motor vehicles; amending fees for certain motor
 1.3 vehicle titling transactions; amending Minnesota Statutes 2012, section 168A.29,
 1.4 subdivision 1.

1.5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.6 Section 1. Minnesota Statutes 2012, section 168A.29, subdivision 1, is amended to read:

1.7 Subdivision 1. **Amounts.** (a) The department must be paid the following fees:

1.8 (1) for filing an application for and the issuance of an original certificate of title, the
 1.9 sum of ~~\$6.25~~ \$8.25, of which ~~\$3.25~~ \$4.25 must be paid into the vehicle services operating
 1.10 account of the special revenue fund under section 299A.705; ~~until June 30, 2012, a~~
 1.11 ~~surcharge of \$1.75 must be added to the fee and credited to the driver and vehicle services~~
 1.12 ~~technology account;~~ from July 1, 2012, to June 30, 2016, a surcharge of ~~\$1~~ \$1.25 must be
 1.13 added to the fee and credited to the driver and vehicle services technology account;

1.14 (2) for each security interest when first noted upon a certificate of title, including the
 1.15 concurrent notation of any assignment thereof and its subsequent release or satisfaction,
 1.16 the sum of \$2, except that no fee is due for a security interest filed by a public authority
 1.17 under section 168A.05, subdivision 8;

1.18 (3) ~~for the transfer of the interest of an owner and the issuance of a new certificate of~~
 1.19 ~~title, the sum of \$5.50 of which \$2.50 must be paid into the vehicle services operating~~
 1.20 ~~account of the special revenue fund under section 299A.705; until June 30, 2012, a~~
 1.21 ~~surcharge of \$1.75 must be added to the fee and credited to the driver and vehicle services~~
 1.22 ~~technology account; from July 1, 2012, to June 30, 2016, a surcharge of \$1 must be added~~
 1.23 ~~to the fee and credited to the driver and vehicle services technology account;~~

2.1 ~~(4)~~ for each assignment of a security interest when first noted on a certificate of title,
2.2 unless noted concurrently with the security interest, the sum of \$1; and

2.3 ~~(5)~~ (4) for issuing a duplicate certificate of title, the sum of \$7.25 of which \$3.25
2.4 must be paid into the vehicle services operating account of the special revenue fund under
2.5 section 299A.705; ~~until June 30, 2012, a surcharge of \$1.75 must be added to the fee~~
2.6 ~~and credited to the driver and vehicle services technology account;~~ from July 1, 2012,
2.7 to June 30, 2016, a surcharge of \$1 must be added to the fee and credited to the driver
2.8 and vehicle services technology account.

2.9 ~~(b) After June 30, 1994,~~ In addition to each of the fees required under paragraph (a),
2.10 ~~clauses clause (1) and (3),~~ the department must be paid \$3.50. The additional \$3.50 fee
2.11 collected under this paragraph must be deposited in the special revenue fund and credited
2.12 to the public safety motor vehicle account established in section 299A.70.
