1.5	Section 1. CONTINUING EDUCATION PROGRAM.
1.6	Subdivision 1. Definition. "Northwest Regional Partnership" means a voluntary
1.7	association of the Lakes Country Service Cooperative, the Northwest Service Cooperative,
1.8	and Minnesota State University-Moorhead that works together to provide coordinated
1.9	higher learning opportunities for teachers.
1.10	Subd. 2. Establishment. Lakes Country Service Cooperative, in consultation with
1.11	Northwest Service Cooperative, may develop a continuing education program to allow
1.12	eligible teachers to attain the requisite graduate credits necessary to be qualified to teach
