

A bill for an act

relating to state government; appropriating money or making reductions to certain state government programs or activities; changing provisions for expenses of governor-elect, income earned by the permanent school fund, lease-purchase agreements, general services, resource recovery, payment of aids and credits to school districts, tax return preparers, and implied consent; imposing fees; amending Minnesota Statutes 2008, sections 4.51; 11A.16, subdivision 5; 16B.04, subdivision 2; 16B.48, subdivision 2; 79.34, subdivision 1; 115A.15, subdivision 6; 127A.46; 169A.52, subdivision 6; 169A.53; 169A.60, subdivision 10; Minnesota Statutes 2009 Supplement, sections 16A.82; 270C.145; 289A.08, subdivision 16; Laws 2009, chapter 101, article 1, section 31; proposing coding for new law in Minnesota Statutes, chapter 357.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

7.8 Sec. 31. **PROBLEM GAMBLING APPROPRIATION.**

7.9 \$225,000 in fiscal year 2010 and ~~\$225,000~~ \$175,000 in fiscal year 2011 are
7.10 appropriated from the lottery prize fund to the Gambling Control Board for a grant to the
7.11 state affiliate recognized by the National Council on Problem Gambling. The affiliate
7.12 must provide services to increase public awareness of problem gambling, education
7.13 and training for individuals and organizations providing effective treatment services to
7.14 problem gamblers and their families, and research relating to problem gambling. These
7.15 services must be complimentary to and not duplicative of the services provided through
7.16 the problem gambling program administered by the commissioner of human services. Of

7.22 Sec. 25. **ADDITIONAL OPERATING BUDGET REDUCTIONS.**

7.23 By July 30, 2010, the commissioner of management and budget shall allocate a
7.24 reduction of \$9,000,000 per year to the operating budgets of executive branch state
7.25 agencies, as defined in Minnesota Statutes, section 16A.011, subdivision 12a. To the
7.26 extent possible, this reduction must be achieved through estimated savings in expenditures
7.27 for technology, space, or services. If expenditure reductions are achieved in dedicated
7.28 funds other than those established in the state constitution or protected by federal law,
7.29 the commissioner of management and budget may transfer the amount of the savings to
7.30 the general fund. Executive branch state agencies shall cooperate with the commissioner
7.31 of management and budget in developing and implementing these reductions. Any
7.32 amount of the reduction that cannot be achieved through savings in the expenditure types
7.33 described in this section must be allocated to executive state agency operating budgets
7.34 by the commissioner. Reductions in fiscal year 2011 shall cancel to the general fund

8.1 and future reductions shall be reflected as reductions in agency base budgets for fiscal
8.2 years 2012 and 2013. The commissioner of management and budget shall report to the
8.3 chairs and ranking minority members of the senate Finance Committee and the house
8.4 of representatives Ways and Means and Finance Committees regarding the amount of
8.5 reductions in spending by each agency under this section.

8.8 Section 1. Minnesota Statutes 2008, section 4.51, is amended to read:

8.9 **4.51 EXPENSES OF GOVERNOR-ELECT.**

8.10 Subdivision 1. **Definitions.** This section applies after a state general election
8.11 in which a person who is not the current governor is elected to take office as the next
8.12 governor. The commissioner of administration must request a transfer from the general
8.13 fund contingent account of an amount equal to 1.5 percent of the amount appropriated
8.14 for operation of the Office of the Governor and Lieutenant Governor for the current
8.15 fiscal year. This request is subject to the review and advice of the Legislative Advisory
8.16 Commission pursuant to section 3.30. If the transfer is approved, the commissioner of
8.17 administration must make this amount available to the governor-elect before he or she
8.18 takes office. The commissioner must provide office space for the governor-elect and for
8.19 any employees the governor-elect hires. (a) "Governor-elect" means the person who is
8.20 not currently governor and is the apparent successful candidate for the office of governor
8.21 following a general election.

8.22 (b) "Commissioner" means the commissioner of the Department of Management
8.23 and Budget.

8.24 Subd. 2. **Transition expenses.** In the fiscal year of a gubernatorial election and
8.25 subject to availability of funds, the commissioner shall transfer up to \$162,000 from the
8.26 general contingent account in the general fund to the Department of Management and
8.27 Budget. This transfer is subject to the review and advice of the Legislative Advisory
8.28 Commission pursuant to section 3.30. In consultation with the governor-elect, the
8.29 commissioner shall use the transferred funds to pay expenses of the governor-elect
8.30 associated with preparing for the assumption of official duties as governor. The
8.31 commissioner may use the transferred funds for expenses necessary and prudent for
8.32 establishment of a transition office prior to the election and for dissolution of the office if
8.33 the incumbent governor is reelected or after the inauguration of a new governor. Expenses
8.34 of the governor-elect may include suitable office space and equipment, communications

9.1 and technology support, consulting services, compensation and travel costs, and other
9.2 reasonable expenses. Compensation rates for temporary employees hired to support the
9.3 governor-elect and rates paid for consulting services for the governor-elect shall be
9.4 determined by the governor-elect.

9.5 Subd. 3. **Unused funds.** No new obligations shall be incurred for expenses of
9.6 the governor-elect after the date of the inauguration. By March 31 of the year of the
9.7 inauguration, the commissioner shall return to the general contingent account any funds
9.8 transferred under this section that the commissioner determines are not needed to pay
9.9 expenses of the governor-elect.

9.10 Sec. 2. Minnesota Statutes 2008, section 11A.16, subdivision 5, is amended to read:

9.11 Subd. 5. **Calculation of income.** As of the end of each fiscal year, the state
9.12 board shall calculate the investment income earned by the permanent school fund. The
9.13 investment income earned by the fund shall equal the amount of interest on debt securities
9.14 ~~and~~, dividends on equity securities, and interest earned on certified monthly earnings prior
9.15 to the transfer to the Department of Education. Gains and losses arising from the sale of
9.16 securities shall be apportioned as follows:

9.17 (a) If the sale of securities results in a net gain during a fiscal year, the gain shall
9.18 be apportioned in equal installments over the next ten fiscal years to offset net losses in
9.19 those years. If any portion of an installment is not needed to recover subsequent losses
9.20 identified in paragraph (b) it shall be added to the principal of the fund.

9.21 (b) If the sale of securities results in a net loss during a fiscal year, the net loss shall
9.22 be recovered first from the gains in paragraph (a) apportioned to that fiscal year. If these
9.23 gains are insufficient, any remaining net loss shall be recovered from interest and dividend
9.24 income in equal installments over the following ten fiscal years.

9.25 **EFFECTIVE DATE.** This section is effective the day following final enactment.
