1.9	Subdivision 1. <b>Definitions.</b> (a) For the purposes of this section, the terms in this

An assisted living A facility may apply to the 2.3 commissioner for designation as a disproportionate share facility. Applications must be 2.4 submitted annually between October September 1 and October 31 September 30. The 2.5 applying facility must apply in a manner determined by the commissioner. The applying 2.6 facility must document as a percentage the census of elderly waiver participants each of the 2.7 following on the application: 2.8 (1) the number of customized living residents in the facility on September 1 of the 2.9 application year, broken out by specific waiver program; and 2.10 (2) the total number of people residing in the facility on October September 1 of the 2.11 application year. 2.12 Subd. 3. Rate adjustment eligibility criteria. Only facilities with a census of at least 2.13 80 percent elderly waiver participants satisfying all of the following conditions on October 2.14 September 1 of the application year are eligible for designation as a disproportionate share 2.15 facility: 2.16 (1) at least 80 percent of the residents of the facility are customized living residents; and 2.17 (2) at least 50 percent of the customized living residents are elderly waiver participants. 2.18 Subd. 4. Designation as a disproportionate share facility. (a) By November October 2.19 15 of each application year, the commissioner must designate as a disproportionate share 2.20 facility a facility that complies with the application requirements of subdivision 2 and meets 2.21 the eligibility criteria of subdivision 3. 2.22 (b) An annual designation is effective for one rate year. 2.23 Subd. 5. Rate adjustment; rate floor. (b) (c) The commissioner must adjust the rate floor at least annually in the manner 3.1 described under section 256S.18, subdivisions 5 and 6. 3.2 (e) (d) The commissioner shall not implement the rate floor under this section if the 3.3 customized living rates established under sections 256S.21 to 256S.215 will be implemented 3.4 at 100 percent on January 1 of the year following an application year. 3.5 Subd. 6. Budget cap disregard. The value of the rate adjustment under this section 3.6 must not be included in an elderly waiver client's monthly case mix budget cap. 3.7 **EFFECTIVE DATE.** This section is effective July 1, 2022, or upon federal approval, 3.8 whichever is later, and applies to services provided on or after October 1, 2022, or on or 3.9 after the date upon which federal approval is obtained, whichever is later. DIRECTION TO THE COMMISSIONER OF HUMAN SERVICES; 3.12 PARTIAL YEAR IMPLEMENTATION OF DISPROPORTIONATE SHARE RATE 3.13 ADJUSTMENTS. 3.14 Subdivision 1. **Definitions.** For the purposes of this section, the definitions in Minnesota 3.15 Statutes, section 256S.205, apply. 3.16 Subd. 2. **Partial year implementation.** (a) Notwithstanding the provisions of Minnesota 3.17 Statutes, section 256S.205, subdivisions 2 to 5, regarding application dates, eligibility dates, 3.18 designation dates, and payment adjustment dates, during the first partial year of 3.19 implementation of the amendments in this act to Minnesota Statutes, section 256S.205, a 3.20 facility may apply between July 1, 2022, and July 31, 2022, to be designated a 3.21 disproportionate share facility on the basis of the conditions outlined in Minnesota Statutes, 3.22 section 256S.205, subdivision 3, as of July 1, 2022. The commissioner shall designate 3.23 disproportionate share facilities by August 15, 2022.
