1.5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.6	Section 1. Minnesota Statutes 2016, section 609.344, subdivision 1, is amended to read:
1.7	Subdivision 1. Crime defined. A person who engages in sexual penetration with another
1.8	person is guilty of criminal sexual conduct in the third degree if any of the following
1.9	circumstances exists:
1.10	(a) the complainant is under 13 years of age and the actor is no more than 36 months
1.11	older than the complainant. Neither mistake as to the complainant's age nor consent to the
1.12	act by the complainant shall be a defense;
1.13	(b) the complainant is at least 13 but less than 16 years of age and the actor is more than
1.14	24 months older than the complainant. In any such case if the actor is no more than 120
1.15	months older than the complainant, it shall be an affirmative defense, which must be proved
1.16	by a preponderance of the evidence, that the actor reasonably believes the complainant to

(n) the actor provides or is an agent of an entity that provides special transportation
service, the complainant used the special transportation service, and the sexual penetration
occurred during or immediately before or after the actor transported the complainant. Consent
by the complainant is not a defense; or
