(1) has completed rehabilitation according to rules adopted by the commissioner or been granted a variance from the rules by the commissioner; and (2) has submitted verification of abstinence from alcohol and controlled substances under paragraph (c), as evidenced by the person's use of an ignition interlock device or other chemical monitoring device approved by the commissioner.
