[256.9755] CAREGIVER SUPPORT PROGRAMS. 1.6 Subdivision 1. Program goals. It is a goal of all area agencies on aging and caregiver 17 support programs to support family caregivers of persons with amyotrophic lateral sclerosis 1.8 (ALS) who are living in the community by: 1.9 (1) promoting caregiver support programs that serve Minnesotans in their homes and 1.10 communities; 1.11 (2) providing, within the limits of available funds, the caregiver support services that 1.12 enable the family caregiver to access caregiver support programs in the most cost-effective 1.13 and efficient manner; and 1.14 (3) providing information, education, and training to respite caregivers and volunteers 1.15 about caring for, managing, and coping with care for a person with ALS. 1.16 Subd. 2. Authority. The Minnesota Board on Aging shall allocate to area agencies on 1.17 aging the state funds which are received under this section for the caregiver support program 1.18 in a manner consistent with federal requirements. The board shall give priority to those 1.19 areas where there is a high need of respite services as evidenced by the data provided by 1.20

Subd. 3. Caregiver support services. Funds allocated under this section to an area

2.14	(a) \$20,000,000 in fiscal year 2023 is appropriated from the general fund to the
2.15	commissioner of the Office of Higher Education to award competitive grants to applicants
2.16	for research into amyotrophic lateral sclerosis (ALS). The commissioner may work with
2.17	the Minnesota Department of Health to administer the grant program, including identifying
2.18	clinical and translational research and innovations, developing outcomes and objectives
2.19	with the goal of bettering the lives of individuals with ALS and finding a cure for the disease,
2.20	and application review and grant recipient selection. Not more than \$400,000 may be used
2.21	by the commissioner to administer the grant program.
