1.6	Section 1. COMMISSION ON FATHERHOOD.
1.7	Subdivision 1. Creation and duties. (a) A Commission on Fatherhood is established
1.8	and consists of 12 members. Members must be appointed by August 1, 2020.
1.9	(b) The Commission on Fatherhood must examine:
1.10	(1) how to enhance the well-being of children by providing opportunities for fathers to
1.11	become better parents, partners, and providers;
1.12	(2) the potential for improved economic stability when fathers have stable and adequate
1.13	employment;
1.14	(3) how to improve access to skills-based classes and provide mentors to fathers; and
1.15	(4) how to promote healthy relationships through conflict resolution and communication
1.16	<u>skills.</u>
1.17	(c) The Commission on Fatherhood must (1) engage community and local government
1.18	leaders, (2) develop policy and funding recommendations, and (3) share the recommendations

Subd. 2. **Membership.** (a) The Commission on Fatherhood consists of the following 2.1 individuals or the individuals' designees: 2.2 (1) two members of the senate, one appointed by the majority leader and one appointed 2.3 by the minority leader; 2.4 2.5 (2) two members of the house of representatives, one appointed by the speaker of the house and one appointed by the minority leader; 2.6 (3) the commissioner of the Department of Human Services; 2.7 (4) the commissioner of economic development; 2.8 2.9 (5) one representative from the judicial branch, appointed by the chief justice of the supreme court; and 2.10 2.11 (6) five representatives from the public who work with or for father-focused nonprofits, legal nonprofit organizations, and nonprofit organizations working to help employ fathers, 2.12 appointed by the governor. 2.13 (b) Members of the commission serve at the pleasure of the appointing authority or until 2.14 the commission expires. Vacancies in commissioner-appointed positions must be filled by 2.15 the commissioner consistent with the qualifications of the vacating member required by 2.16 2.17 this subdivision. Subd. 3. Officers; meetings. (a) The commission members must annually elect a chair 2.18 and vice-chair from among the commission's members and may elect other officers as 2.19 necessary. The commission must meet at least quarterly, or upon the call of its chair, and 2.20 may hold meetings throughout the state.
