BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

- Section 1. Minnesota Statutes 2022, section 84.943, subdivision 5, is amended to read: 1.6
 - Subd. 5. Pledges and contributions. (a) The commissioner of natural resources may accept contributions and pledges to the critical habitat private sector matching account. A pledge that is made contingent on an appropriation is acceptable and shall must be reported with other pledges as required in this section. The commissioner may agree to match a contribution contingent on a future appropriation. In the budget request for each biennium, the commissioner shall must report the balance of contributions in the account and the amount that has been pledged for payment in the succeeding two calendar years.
 - (b) Money in the account is appropriated to the commissioner of natural resources only for the direct acquisition, restoration, or enhancement of land or interests in land as provided in section 84.944. Acquisition includes:
 - (1) purchase of land or an interest in land by the commissioner; or
- (2) acceptance by the commissioner of gifts of land or interests in land as program 1.18 projects. 1.19
- (c) (b) To the extent of available appropriations other than bond proceeds, the money 1.20 matched to the nongame wildlife management account may be used for: 1.21
- (1) the management of nongame wildlife projects as specified in section 290.431; 1.22
