1.5	Section 1. FIRE SERVICE CONSOLIDATION WORKING GROUP.
1.6	Subdivision 1. Creation. The fire service consolidation working group consists of the
1.7	following members, who shall represent rural, suburban, and metropolitan areas of the state:
1.8	(1) the state fire marshal or the marshal's designee;
1.9	(2) up to three members of the Minnesota State Fire Chiefs Association, including
1.10	association members who have actively pursued the establishment of fire districts or other
1.11	forms of fire and emergency service consolidation;
