1.6	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.7	Section 1. [299P.01] LEGISLATIVE FINDINGS AND PURPOSE.
1.8	The legislature finds that animal cruelty is linked to human violence and criminal activity
1.9	and that there is an ongoing need across the state to better prevent and respond to incidents
1.10	of animal cruelty. The purpose of this act is to address animal cruelty in a more
1.11	comprehensive and centralized manner by creating an Office of Animal Protection and
1.12	giving the office the authority and duties prescribed in this chapter so as to protect the
1.13	public's peace, health, and safety.
1.14	Sec. 2. [299P.02] DEFINITIONS.
1.15	Subdivision 1. Application. As used in this chapter, the following terms have the
1.16	meanings given.
1.17	Subd. 2. Animal. "Animal" has the meaning given in section 343.20, subdivision 2.
1.18	Subd. 3. Animal cruelty. "Animal cruelty" has the meaning given to "cruelty" in section
1.19	343.20, subdivision 3.
1.20	Subd. 4. Commissioner. "Commissioner" means the commissioner of public safety.

- 3.7 Subd. 3. Annual performance report. On or before January 15 of each year, the director
   3.8 shall submit an annual report to the chairs and ranking minority members of the legislative

   3.10 and any recommendations for changes in law relating to animal protection.
- 3.11 Sec. 4. [299P.04] ADVISORY COMMITTEE.
- 3.12 Subdivision 1. Advisory committee. The commissioner shall establish and appoint the
- 3.13 members of an advisory committee pursuant to section 15.059. The committee shall adopt
- 3.14 procedures to govern the committee's conduct as necessary and select a chair from among
- 3.15 its members. The committee shall act in an advisory capacity, providing assistance and
- 3.16 advice to the office in the development and execution of its duties, including outreach to
- 3.17 <u>communities and stakeholders.</u>
- 3.18 Subd. 2. Committee members. Committee members shall possess knowledge, skills,
- 3.19 <u>or experiences in the prevention, investigation, or prosecution of animal cruelty and the</u>
- 3.20 care of animals, reflecting the five disciplines described in section 299P.03, subdivision 2,
- 3.21 clause (1), items (i) to (v). The committee shall also include members of the public with
- 3.22 knowledge of animal law and animal cruelty or experiences with animal cruelty as a victim,
- 3.23 <u>including trauma of victims.</u>
- 3.24 Subd. 3. Subcommittees. The committee may establish subcommittees to identify,
- 3.25 discuss, and make recommendations on specific topics related to animal cruelty and effective
- 3.26 <u>enforcement efforts of animal cruelty statutes, including but not limited to animal cruelty</u>
- 3.27 reporting, victim services, crime data collection, cross-reporting, courtroom advocates, and
- 3.28 <u>crime prevention.</u>

#### Sec. 6. [299P.06] AGREEMENTS AND CONTRACTS; LOCAL AUTHORITY. 4.11

- Subdivision 1. Agreements and contracts. The director may enter into contracts with 4.12
- 4.13 parties to assist with fulfilling the office's powers and duties under this chapter.

Subd. 2. Authority of local governing bodies. This chapter shall not be construed to 4.14

4.15 limit or preempt additional requirements imposed on or possessed by any city, town, or 4.16 county.

#### Sec. 7. [299P.07] ANIMAL PROTECTION ACCOUNT; GRANTS. 4.17

Subdivision 1. Money received from other sources. The director may accept money 4.18

received as gifts, grants, or contributions from any source to support the purposes of the 4.19

office under this chapter. The director may apply for and accept grants of money from the 4.20

federal government, the state, any foundation, or any person to support the purposes of the 4.21 office. 4.22

Subd. 2. Animal protection account. An animal protection account is created in the 4.23

special revenue fund. All money received under subdivision 1 shall be deposited into the 4.24

- account. Money in the account, including interest, is annually appropriated to the 4.25
- commissioner to administer this chapter. 4.26
- Subd. 3. Grants authorized. The commissioner may use money in the animal protection 4.27 account to make grants to state and local units of government and nonprofit organizations 4.28 to promote animal protection efforts as described in this chapter. 4.29

## 5.26 EFFECTIVE DATE. This section is effective August 1, 2024, and applies to crimes 5.27 committed on or after that date.

### 5.28 Sec. 9. OFFICE OF ANIMAL PROTECTION; APPROPRIATION.

# 5.29 \$350,000 in fiscal year 2025 is appropriated from the general fund to the commissioner 5.30 of public safety to establish and operate the Office of Animal Protection established under 5.31 this act.
