1.14 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.15 Section 1. Minnesota Statutes 2016, section 245C.03, subdivision 1, is amended to read:

1.16 Subdivision 1. **Licensed programs.** (a) The commissioner shall conduct a background
1.17 study on:

1.18 (1) the person or persons applying for a license;

1.19 (2) an individual age 13 and over living in the household where the licensed program
1.20 will be provided who is not receiving licensed services from the program;

1.21 (3) current or prospective employees or contractors of the applicant who will have direct
1.22 contact with persons served by the facility, agency, or program;

1.23 (4) volunteers or student volunteers who will have direct contact with persons served
1.24 by the program to provide program services if the contact is not under the continuous, direct
1.25 supervision by an individual listed in clause (1) or (3);

2.1 (5) an individual age ten to 12 living in the household where the licensed services will
2.2 be provided when the commissioner has reasonable cause;

2.3 (6) an individual who, without providing direct contact services at a licensed program,
2.4 may have unsupervised access to children or vulnerable adults receiving services from a
2.5 program, when the commissioner has reasonable cause; and

2.6 (7) all managerial officials as defined under section 245A.02, subdivision 5a.

2.7 (b) For ~~family~~ child foster care ~~settings~~ when the license holder resides in the home
2.8 where foster care services are provided, a short-term substitute caregiver providing direct
2.9 contact services for a child for less than 72 hours of continuous care is not required to receive
2.10 a background study under this chapter.

2.11 **EFFECTIVE DATE.** This section is effective the day following final enactment.

2.12 Sec. 2. Minnesota Statutes 2016, section 245C.04, subdivision 1, is amended to read:

2.13 Subdivision 1. **Licensed programs.** (a) The commissioner shall conduct a background
2.14 study of an individual required to be studied under section 245C.03, subdivision 1, at least
2.15 upon application for initial license for all license types.

2.16 (b) The commissioner shall conduct a background study of an individual required to be
2.17 studied under section 245C.03, subdivision 1, at reapplication for a license for family child
2.18 care.

2.19 (c) The commissioner is not required to conduct a study of an individual at the time of
2.20 reapplication for a license if the individual's background study was completed by the
2.21 commissioner of human services and the following conditions are met:

2.22 (1) a study of the individual was conducted either at the time of initial licensure or when
2.23 the individual became affiliated with the license holder;

2.24 (2) the individual has been continuously affiliated with the license holder since the last
2.25 study was conducted; and

2.26 (3) the last study of the individual was conducted on or after October 1, 1995.

2.27 (d) The commissioner of human services shall conduct a background study of an
2.28 individual specified under section 245C.03, subdivision 1, paragraph (a), clauses (2) to (6),
2.29 who is newly affiliated with a child foster care license holder-;

2.30 (1) the county or private agency shall collect and forward to the commissioner the
2.31 information required under section 245C.05, subdivisions 1 and 5-, when the child foster

3.1 care applicant or license holder resides in the home where child foster care services are
3.2 provided;

3.3 (2) the child foster care license holder or applicant shall collect and forward to the
3.4 commissioner the information required under section 245C.05, subdivisions 1 and 5, when
3.5 the applicant or license holder does not reside in the home where child foster care services
3.6 are provided; and

3.7 (3) the background study conducted by the commissioner of human services under this
3.8 paragraph must include a review of the information required under section 245C.08,
3.9 subdivisions 1, 3, and 4.

3.10 (e) The commissioner shall conduct a background study of an individual specified under
3.11 section 245C.03, subdivision 1, paragraph (a), clauses (2) to (6), who is newly affiliated
3.12 with an adult foster care or family adult day services license holder: (1) the county shall
3.13 collect and forward to the commissioner the information required under section 245C.05,
3.14 subdivision 1, paragraphs (a) and (b), and subdivision 5, paragraphs (a) and (b), for
3.15 background studies conducted by the commissioner for all family adult day services and
3.16 for adult foster care when the adult foster care license holder resides in the adult foster care
3.17 residence; (2) the license holder shall collect and forward to the commissioner the information
3.18 required under section 245C.05, subdivisions 1, paragraphs (a) and (b); and 5, paragraphs
3.19 (a) and (b), for background studies conducted by the commissioner for adult foster care
3.20 when the license holder does not reside in the adult foster care residence; and (3) the
3.21 background study conducted by the commissioner under this paragraph must include a
3.22 review of the information required under section 245C.08, subdivision 1, paragraph (a),
3.23 and subdivisions 3 and 4.

3.24 (f) Applicants for licensure, license holders, and other entities as provided in this chapter
3.25 must submit completed background study requests to the commissioner using the electronic
3.26 system known as NETStudy before individuals specified in section 245C.03, subdivision
3.27 1, begin positions allowing direct contact in any licensed program.

3.28 (g) For an individual who is not on the entity's active roster, the entity must initiate a
3.29 new background study through NETStudy when:

3.30 (1) an individual returns to a position requiring a background study following an absence
3.31 of 120 or more consecutive days; or

3.32 (2) a program that discontinued providing licensed direct contact services for 120 or
3.33 more consecutive days begins to provide direct contact licensed services again.

4.1 The license holder shall maintain a copy of the notification provided to the commissioner
4.2 under this paragraph in the program's files. If the individual's disqualification was previously
4.3 set aside for the license holder's program and the new background study results in no new
4.4 information that indicates the individual may pose a risk of harm to persons receiving
4.5 services from the license holder, the previous set-aside shall remain in effect.

4.6 (h) For purposes of this section, a physician licensed under chapter 147 is considered to
4.7 be continuously affiliated upon the license holder's receipt from the commissioner of health
4.8 or human services of the physician's background study results.

4.9 (i) For purposes of family child care, a substitute caregiver must receive repeat
4.10 background studies at the time of each license renewal.

4.11 **EFFECTIVE DATE.** This section is effective the day following final enactment.

4.12 Sec. 3. Minnesota Statutes 2016, section 245C.05, subdivision 2a, is amended to read:

4.13 Subd. 2a. **County or private agency.** For background studies related to child foster care
4.14 when the applicant or license holder resides in the home where child foster care services
4.15 are provided, county and private agencies must collect the information under subdivision
4.16 1 and forward it to the commissioner.

4.17 **EFFECTIVE DATE.** This section is effective the day following final enactment.

4.18 Sec. 4. Minnesota Statutes 2016, section 245C.10, subdivision 9, is amended to read:

4.19 Subd. 9. **Human services licensed programs.** The commissioner shall recover the cost
4.20 of background studies required under section 245C.03, subdivision 1, for all programs that
4.21 are licensed by the commissioner, except child foster care when the applicant or license
4.22 holder resides in the home where child foster care services are provided, and family child
4.23 care, through a fee of no more than \$20 per study charged to the license holder. The fees
4.24 collected under this subdivision are appropriated to the commissioner for the purpose of
4.25 conducting background studies.

4.26 **EFFECTIVE DATE.** This section is effective the day following final enactment.

4.27 Sec. 5. Minnesota Statutes 2016, section 245C.17, subdivision 5, is amended to read:

4.28 Subd. 5. **Notice to county or private agency.** For studies on individuals related to a
4.29 license to provide child foster care when the applicant or license holder resides in the home
4.30 where child foster care services are provided, the commissioner shall also provide a notice

5.1 of the background study results to the county or private agency that initiated the background
5.2 study.

5.3 **EFFECTIVE DATE.** This section is effective the day following final enactment.

5.4 Sec. 6. Minnesota Statutes 2016, section 245C.17, subdivision 6, is amended to read:

5.5 Subd. 6. **Notice to county agency.** For studies on individuals related to a license to
5.6 provide adult foster care when the applicant or license holder resides in the adult foster care
5.7 residence and family adult day services, the commissioner shall also provide a notice of the
5.8 background study results to the county agency that initiated the background study.

5.9 **EFFECTIVE DATE.** This section is effective the day following final enactment.

5.10 Sec. 7. Minnesota Statutes 2016, section 245C.21, subdivision 1a, is amended to read:

5.11 Subd. 1a. **Submission of reconsideration request.** (a) For disqualifications related to
5.12 studies conducted by county agencies for family child care, and for disqualifications related
5.13 to studies conducted by the commissioner for child foster care, adult foster care, and family
5.14 adult day services when the applicant or license holder resides in the home where services
5.15 are provided, the individual shall submit the request for reconsideration to the county agency
5.16 that initiated the background study.

5.17 (b) For disqualifications related to studies conducted by the commissioner for child
5.18 foster care providers monitored by private licensing agencies under section 245A.16, the
5.19 individual shall submit the request for reconsideration to the private agency that initiated
5.20 the background study.

5.21 (c) A reconsideration request shall be submitted within 30 days of the individual's receipt
5.22 of the disqualification notice or the time frames specified in subdivision 2, whichever time
5.23 frame is shorter.

5.24 (d) The county or private agency shall forward the individual's request for reconsideration
5.25 and provide the commissioner with a recommendation whether to set aside the individual's
5.26 disqualification.

5.27 **EFFECTIVE DATE.** This section is effective the day following final enactment.

5.28 Sec. 8. Minnesota Statutes 2016, section 245C.23, subdivision 2, is amended to read:

5.29 Subd. 2. **Commissioner's notice of disqualification that is not set aside.** (a) The
5.30 commissioner shall notify the license holder of the disqualification and order the license

6.1 holder to immediately remove the individual from any position allowing direct contact with
6.2 persons receiving services from the license holder if:

6.3 (1) the individual studied does not submit a timely request for reconsideration under
6.4 section 245C.21;

6.5 (2) the individual submits a timely request for reconsideration, but the commissioner
6.6 does not set aside the disqualification for that license holder under section 245C.22, unless
6.7 the individual has a right to request a hearing under section 245C.27, 245C.28, or 256.045;

6.8 (3) an individual who has a right to request a hearing under sections 245C.27 and 256.045,
6.9 or 245C.28 and chapter 14 for a disqualification that has not been set aside, does not request
6.10 a hearing within the specified time; or

6.11 (4) an individual submitted a timely request for a hearing under sections 245C.27 and
6.12 256.045, or 245C.28 and chapter 14, but the commissioner does not set aside the
6.13 disqualification under section 245A.08, subdivision 5, or 256.045.

6.14 (b) If the commissioner does not set aside the disqualification under section 245C.22,
6.15 and the license holder was previously ordered under section 245C.17 to immediately remove
6.16 the disqualified individual from direct contact with persons receiving services or to ensure
6.17 that the individual is under continuous, direct supervision when providing direct contact
6.18 services, the order remains in effect pending the outcome of a hearing under sections 245C.27
6.19 and 256.045, or 245C.28 and chapter 14.

6.20 (c) If the commissioner does not set aside the disqualification under section 245C.22,
6.21 and the license holder was not previously ordered under section 245C.17 to immediately
6.22 remove the disqualified individual from direct contact with persons receiving services or
6.23 to ensure that the individual is under continuous direct supervision when providing direct
6.24 contact services, the commissioner shall order the individual to remain under continuous
6.25 direct supervision pending the outcome of a hearing under sections 245C.27 and 256.045,
6.26 or 245C.28 and chapter 14.

6.27 (d) For background studies related to child foster care when the applicant or license
6.28 holder resides in the home where services are provided, the commissioner shall also notify
6.29 the county or private agency that initiated the study of the results of the reconsideration.

6.30 (e) For background studies related to adult foster care programs when the applicant or
6.31 license holder resides in the home where services are provided and family adult day services,
6.32 the commissioner shall also notify the county that initiated the study of the results of the
6.33 reconsideration.

7.1 **EFFECTIVE DATE.** This section is effective the day following final enactment.

7.2 Sec. 9. Minnesota Statutes 2016, section 245D.02, is amended by adding a subdivision to
7.3 read:

7.4 Subd. 20b. **Natural support.** "Natural support" means an individual who provides direct
7.5 services or supports without direction from nor under the supervision of the license holder
7.6 or the license holder's representative.

7.7 **EFFECTIVE DATE.** This section is effective the day following final enactment.

7.8 Sec. 10. Minnesota Statutes 2016, section 245D.02, subdivision 36, is amended to read:

7.9 Subd. 36. **Volunteer.** "Volunteer" means an individual who, under the direction of the
7.10 license holder, provides direct services without pay to a person served by the license holder.
7.11 A natural support is not a volunteer.

7.12 **EFFECTIVE DATE.** This section is effective the day following final enactment.

7.13 Sec. 11. Minnesota Statutes 2016, section 245D.03, subdivision 1, is amended to read:

7.14 Subdivision 1. **Applicability.** (a) The commissioner shall regulate the provision of home
7.15 and community-based services to persons with disabilities and persons age 65 and older
7.16 pursuant to this chapter. The licensing standards in this chapter govern the provision of
7.17 basic support services and intensive support services.

7.18 (b) Basic support services provide the level of assistance, supervision, and care that is
7.19 necessary to ensure the health and welfare of the person and do not include services that
7.20 are specifically directed toward the training, treatment, habilitation, or rehabilitation of the
7.21 person. Basic support services include:

7.22 (1) in-home and out-of-home respite care services as defined in section 245A.02,
7.23 subdivision 15, and under the brain injury, community alternative care, community access
7.24 for disability inclusion, developmental disability, and elderly waiver plans, excluding
7.25 out-of-home respite care provided to children in a family child foster care home licensed
7.26 under Minnesota Rules, parts 2960.3000 to 2960.3100, when the child foster care license
7.27 holder complies with the requirements under section 245D.06, subdivisions 5, 6, 7, and 8,
7.28 or successor provisions; and section 245D.061 or successor provisions, which must be
7.29 stipulated in the statement of intended use required under Minnesota Rules, part 2960.3000,
7.30 subpart 4;

8.1 (2) adult companion services as defined under the brain injury, community access for
8.2 disability inclusion, and elderly waiver plans, excluding adult companion services provided
8.3 under the Corporation for National and Community Services Senior Companion Program
8.4 established under the Domestic Volunteer Service Act of 1973, Public Law 98-288;

8.5 (3) personal support as defined under the developmental disability waiver plan;

8.6 (4) 24-hour emergency assistance, personal emergency response as defined under the
8.7 community access for disability inclusion and developmental disability waiver plans;

8.8 (5) night supervision services as defined under the brain injury waiver plan; and

8.9 (6) homemaker services as defined under the community access for disability inclusion,
8.10 brain injury, community alternative care, developmental disability, and elderly waiver plans,
8.11 excluding providers licensed by the Department of Health under chapter 144A and those
8.12 providers providing cleaning services only.

8.13 (c) Intensive support services provide assistance, supervision, and care that is necessary
8.14 to ensure the health and welfare of the person and services specifically directed toward the
8.15 training, habilitation, or rehabilitation of the person. Intensive support services include:

8.16 (1) intervention services, including:

8.17 (i) behavioral support services as defined under the brain injury and community access
8.18 for disability inclusion waiver plans;

8.19 (ii) in-home or out-of-home crisis respite services as defined under the developmental
8.20 disability waiver plan; and

8.21 (iii) specialist services as defined under the current developmental disability waiver
8.22 plan;

8.23 (2) in-home support services, including:

8.24 (i) in-home family support and supported living services as defined under the
8.25 developmental disability waiver plan;

8.26 (ii) independent living services training as defined under the brain injury and community
8.27 access for disability inclusion waiver plans; ~~and~~

8.28 (iii) semi-independent living services; and

8.29 (iv) individualized home supports services as defined under the brain injury, community
8.30 alternative care, and community access for disability inclusion waiver plans;

8.31 (3) residential supports and services, including:

9.1 (i) supported living services as defined under the developmental disability waiver plan
 9.2 provided in a family or corporate child foster care residence, a family adult foster care
 9.3 residence, a community residential setting, or a supervised living facility;

9.4 (ii) foster care services as defined in the brain injury, community alternative care, and
 9.5 community access for disability inclusion waiver plans provided in a family or corporate
 9.6 child foster care residence, a family adult foster care residence, or a community residential
 9.7 setting; and

9.8 (iii) residential services provided to more than four persons with developmental
 9.9 disabilities in a supervised living facility, including ICFs/DD;

9.10 (4) day services, including:

9.11 (i) structured day services as defined under the brain injury waiver plan;

9.12 (ii) day training and habilitation services under sections 252.41 to 252.46, and as defined
 9.13 under the developmental disability waiver plan; and

9.14 (iii) prevocational services as defined under the brain injury and community access for
 9.15 disability inclusion waiver plans; and

9.16 (5) supported employment as defined under the brain injury, developmental disability,
 9.17 and community access for disability inclusion waiver plans.

9.18 **EFFECTIVE DATE.** This section is effective the day following final enactment.

9.19 Sec. 12. Minnesota Statutes 2016, section 245D.04, subdivision 3, is amended to read:

9.20 Subd. 3. **Protection-related rights.** (a) A person's protection-related rights include the
 9.21 right to:

9.22 (1) have personal, financial, service, health, and medical information kept private, and
 9.23 be advised of disclosure of this information by the license holder;

9.24 (2) access records and recorded information about the person in accordance with
 9.25 applicable state and federal law, regulation, or rule;

9.26 (3) be free from maltreatment;

9.27 (4) be free from restraint, time out, seclusion, restrictive intervention, or other prohibited
 9.28 procedure identified in section 245D.06, subdivision 5, or successor provisions, except for:

9.29 (i) emergency use of manual restraint to protect the person from imminent danger to self
 9.30 or others according to the requirements in section 245D.061 or successor provisions; or (ii)

10.1 the use of safety interventions as part of a positive support transition plan under section
10.2 245D.06, subdivision 8, or successor provisions;

10.3 (5) receive services in a clean and safe environment when the license holder is the owner,
10.4 lessor, or tenant of the service site;

10.5 (6) be treated with courtesy and respect and receive respectful treatment of the person's
10.6 property;

10.7 (7) reasonable observance of cultural and ethnic practice and religion;

10.8 (8) be free from bias and harassment regarding race, gender, age, disability, spirituality,
10.9 and sexual orientation;

10.10 (9) be informed of and use the license holder's grievance policy and procedures, including
10.11 knowing how to contact persons responsible for addressing problems and to appeal under
10.12 section 256.045;

10.13 (10) know the name, telephone number, and the Web site, e-mail, and street addresses
10.14 of protection and advocacy services, including the appropriate state-appointed ombudsman,
10.15 and a brief description of how to file a complaint with these offices;

10.16 (11) assert these rights personally, or have them asserted by the person's family,
10.17 authorized representative, or legal representative, without retaliation;

10.18 (12) give or withhold written informed consent to participate in any research or
10.19 experimental treatment;

10.20 (13) associate with other persons of the person's choice;

10.21 (14) personal privacy, including the right to use the lock on the person's bedroom or unit
10.22 door; and

10.23 (15) engage in chosen activities; and

10.24 (16) access to the person's personal possessions at any time, including financial resources.

10.25 (b) For a person residing in a residential site licensed according to chapter 245A, or
10.26 where the license holder is the owner, lessor, or tenant of the residential service site,
10.27 protection-related rights also include the right to:

10.28 (1) have daily, private access to and use of a non-coin-operated telephone for local calls
10.29 and long-distance calls made collect or paid for by the person;

10.30 (2) receive and send, without interference, uncensored, unopened mail or electronic
10.31 correspondence or communication;

11.1 (3) have use of and free access to common areas in the residence and the freedom to
 11.2 come and go from the residence at will; and

11.3 (4) choose the person's visitors and time of visits and have privacy for visits with the
 11.4 person's spouse, next of kin, legal counsel, religious ~~advisor~~ adviser, or others, in accordance
 11.5 with section 363A.09 of the Human Rights Act, including privacy in the person's bedroom;

11.6 (5) have freedom and support to access food and potable water at any time;

11.7 (6) have the freedom to furnish and decorate the person's bedroom or living unit;

11.8 (7) a setting that is clean and free from accumulation of dirt, grease, garbage, peeling
 11.9 paint, mold, vermin, and insects;

11.10 (8) a setting that is free from hazards that threaten the person's health or safety; and

11.11 (9) a setting that meets the definition of a dwelling unit within a residential occupancy
 11.12 as defined in the State Fire Code.

11.13 (c) Restriction of a person's rights under paragraph (a), clauses (13) to ~~(15)~~ (16), or
 11.14 paragraph (b) is allowed only if determined necessary to ensure the health, safety, and
 11.15 well-being of the person. Any restriction of those rights must be documented in the person's
 11.16 coordinated service and support plan or coordinated service and support plan addendum.
 11.17 The restriction must be implemented in the least restrictive alternative manner necessary
 11.18 to protect the person and provide support to reduce or eliminate the need for the restriction
 11.19 in the most integrated setting and inclusive manner. The documentation must include the
 11.20 following information:

11.21 (1) the justification for the restriction based on an assessment of the person's vulnerability
 11.22 related to exercising the right without restriction;

11.23 (2) the objective measures set as conditions for ending the restriction;

11.24 (3) a schedule for reviewing the need for the restriction based on the conditions for
 11.25 ending the restriction to occur semiannually from the date of initial approval, at a minimum,
 11.26 or more frequently if requested by the person, the person's legal representative, if any, and
 11.27 case manager; and

11.28 (4) signed and dated approval for the restriction from the person, or the person's legal
 11.29 representative, if any. A restriction may be implemented only when the required approval
 11.30 has been obtained. Approval may be withdrawn at any time. If approval is withdrawn, the
 11.31 right must be immediately and fully restored.

11.32 **EFFECTIVE DATE.** This section is effective the day following final enactment.

12.1 Sec. 13. Minnesota Statutes 2016, section 245D.071, subdivision 3, is amended to read:

12.2 Subd. 3. **Assessment and initial service planning.** (a) Within 15 days of service initiation
12.3 the license holder must complete a preliminary coordinated service and support plan
12.4 addendum based on the coordinated service and support plan.

12.5 (b) Within the scope of services, the license holder must, at a minimum, complete
12.6 assessments in the following areas before the 45-day planning meeting:

12.7 (1) the person's ability to self-manage health and medical needs to maintain or improve
12.8 physical, mental, and emotional well-being, including, when applicable, allergies, seizures,
12.9 choking, special dietary needs, chronic medical conditions, self-administration of medication
12.10 or treatment orders, preventative screening, and medical and dental appointments;

12.11 (2) the person's ability to self-manage personal safety to avoid injury or accident in the
12.12 service setting, including, when applicable, risk of falling, mobility, regulating water
12.13 temperature, community survival skills, water safety skills, and sensory disabilities; and

12.14 (3) the person's ability to self-manage symptoms or behavior that may otherwise result
12.15 in an incident as defined in section 245D.02, subdivision 11, clauses (4) to (7), suspension
12.16 or termination of services by the license holder, or other symptoms or behaviors that may
12.17 jeopardize the health and welfare of the person or others.

12.18 Assessments must produce information about the person that describes the person's overall
12.19 strengths, functional skills and abilities, and behaviors or symptoms. Assessments must be
12.20 based on the person's status within the last 12 months at the time of service initiation.

12.21 Assessments based on older information must be documented and justified. Assessments
12.22 must be conducted annually at a minimum or within 30 days of a written request from the
12.23 person or the person's legal representative or case manager. The results must be reviewed
12.24 by the support team or expanded support team as part of a service plan review.

12.25 (c) Within 45 days of service initiation, the license holder must meet with the person,
