1.2 relating to natural resources; modifying Clean Water Legacy Act; providing for

1.3 coordinated watershed management; amending Minnesota Statutes 2016, sections

1.4 103B.3369, subdivisions 5, 9; 103B.801, subdivisions 2, 5; 114D.15, subdivisions

1.5 7, 11, 13, by adding subdivisions; 114D.20, subdivisions 2, 3, 5, 7, by adding

1.6 subdivisions; 114D.26; 114D.35, subdivisions 1, 3; proposing coding for new law

1.7 in Minnesota Statutes, chapter 114D.

1.8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.9 Section 1. Minnesota Statutes 2016, section 103B.3369, subdivision 5, is amended to read:

1.10 Subd. 5. **Financial assistance.** A base grant, contract, or payment may be awarded to a

1.11 county or other local unit of government that provides a match utilizing a water

1.12 implementation tax or other local source. A water implementation tax that a county or other

1.13 local unit of government intends to use as a match to the base grant must be levied at a rate

1.14 sufficient to generate a minimum amount determined by the board. The board may award

1.15 performance-based or watershed-based grants, contracts, or payments to local units of

1.16 government that are responsible for implementing elements of applicable portions of

1.17 watershed management plans, comprehensive plans, local water management plans, or

1.18 comprehensive watershed management plans, developed or amended, adopted and approved,

1.19 according to chapter 103B, 103C, or 103D. Upon request by a local government unit, the

1.20 board may also award performance-based grants to local units of government to carry out

1.21 TMDL implementation plans as provided in chapter 114D, if the TMDL implementation

1.22 plan has been incorporated into the local water management plan according to the procedures

1.23 for approving comprehensive plans, watershed management plans, local water management

1.24 plans, or comprehensive watershed management plans under chapter 103B, 103C, or 103D,

1.25 or if the TMDL implementation plan has undergone a public review process. Notwithstanding

2.1 section 16A.41, the board may award ~~performance-based grants, contracts, or payments~~ on
2.2 an advanced basis. The fee authorized in section 40A.152 may be used as a local match or
2.3 as a supplement to state funding to accomplish implementation of comprehensive plans,
2.4 watershed management plans, local water management plans, or comprehensive watershed
2.5 management plans under this chapter and chapter 103C or 103D.

2.7 Subd. 9. **Performance-based criteria.** The board ~~shall~~ may develop and utilize
2.8 performance-based criteria for local water resources restoration, protection, and management
2.9 programs and projects. The criteria may include but are not limited to science-based
2.10 assessments, organizational capacity, priority resource issues, community outreach and
2.11 support, partnership potential, potential for multiple benefits, and program and project
2.12 delivery efficiency and effectiveness.

2.13 Sec. 3. Minnesota Statutes 2016, section 103B.801, subdivision 2, is amended to read:

2.14 Subd. 2. **Program purposes.** The purposes of the comprehensive watershed management
2.15 plan program under section 103B.101, subdivision 14, paragraph (a), are to:

2.16 (1) align local water planning purposes and procedures under this chapter and chapters
2.17 103C and 103D on watershed boundaries to create a systematic, watershed-wide,
2.18 science-based approach to watershed management;

2.19 (2) acknowledge and build off existing local government structure, water plan services,
2.20 and local capacity;

2.21 (3) incorporate and make use of data and information, including watershed restoration
2.22 and protection strategies under section 114D.26, which may serve to fulfill all or some of
2.23 the requirements under chapter 114D;

2.24 (4) solicit input and engage experts from agencies, citizens, and stakeholder groups;

2.25 (5) focus on implementation of prioritized and targeted actions capable of achieving
2.26 measurable progress; and

3.5 statewide transition to comprehensive watershed management plans by 2025. The
3.6 metropolitan area may be considered for inclusion in the transition plan. The board may
3.7 amend the transition plan no more often than once every two years.

5.29 and establish and report outcome-based performance measures that monitor the progress
5.30 and effectiveness of protection and restoration measures;

5.31 (8) monitor and enforce cost-sharing contracts and impose monetary damages in an
5.32 amount up to 150 percent of the financial assistance received for failure to comply; and

6.1 (9) identify and encourage implementation of measures to prevent groundwater from
6.2 becoming degraded and measures that restore groundwater resources.

6.4 Subd. 5. **Priorities for preparing WRAPSs AND TMDL's.** In consultation with the
6.5 Clean Water Council shall recommend, the commissioner of the Pollution Control Agency
6.6 must coordinate with the commissioners of natural resources, health, and agriculture and
6.7 with the Board of Water and Soil Resources to establish priorities for scheduling and
6.8 preparing WRAPSs and TMDL's and TMDL implementation plans, taking into account,

6.21 and organization of human, technical, and financial resources necessary to undertake the
6.22 work; and

6.23 (5) where there is demonstrated coordination and cooperation among cities, counties,
6.24 watershed districts, and soil and water conservation districts in planning and implementation
6.25 of activities that will assist in carrying out the responsibilities.

6.27 Subd. 7. **Priorities for funding prevention actions.** The Clean Water Council shall

6.29 priorities for funding actions to prevent groundwater and surface waters from becoming
6.30 degraded or impaired and to improve the quality of surface waters that are listed as impaired
6.31 ~~but do not have an approved TMDL.~~

7.3 Subd. 8. **Alternatives; TMDL, TMDL implementation plan, or WRAPS.** (a) If the

7.5 management plan or comprehensive local water management plan is sufficient and consistent
7.6 with guidance from the United States Environmental Protection Agency for category 4b

 9.21 Web site the progress toward implementation milestones and water quality goals for all
 9.22 adopted TMDL's and, where available, WRAPS's.

9.23 Subd. 3. **Timelines; administration.** ~~Each year, (a) The commissioner of the Pollution~~
 9.24 ~~Control Agency must complete WRAPS's for at least ten percent of watershed restoration~~
 9.25 ~~and protection strategies for the state's major watersheds. WRAPS shall be~~ by June 30,
 9.26 2023, unless the commissioner determines that a comprehensive watershed management
 9.27 plan or comprehensive local water management plan, in whole or part, is sufficient to provide
 9.28 reasonable assurance of progress toward water quality restoration or protection goals. As

 10.8 managers, and public and private organizations, in identifying impaired waters, in developing

11.2 Notwithstanding section 114D.50, subdivision 3a, the Board of Water and Soil Resources

11.4 for nonpoint sources under section 114D.50, subdivision 3a, and may use information from
11.5 comprehensive watershed management plans or comprehensive local water management
11.6 plans to estimate or summarize costs.
