BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA: 1.3 Section 1. PRIVATE SALE OF TAX-FORFEITED LANDS; ST. LOUIS COUNTY. 1.4 (a) Notwithstanding the public sale provisions of Minnesota Statutes, chapter 282, or 1.5 other law to the contrary, St. Louis County may sell by private sale the tax-forfeited lands 1.6 described in paragraph (c). 1.7 (b) The conveyances must be in a form approved by the attorney general.
