Aitkin County. BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA: 1.4 Section 1. PRIVATE SALE OF TAX-FORFEITED LAND; AITKIN COUNTY. 1.5 (a) Notwithstanding the public sale provisions of Minnesota Statutes, chapter 282, or 1.6 other law to the contrary, Aitkin County may sell by private sale the tax-forfeited lands 1.7 described in paragraph (c). 1.8 (b) The conveyances must be in a form approved by the attorney general.
