2.7 improvements at Sauk River Regional Park is available until June 30, ~~2022~~ 2024, and may  
2.8 be used to design, engineer, and construct a trail, including overlooks, fishing platforms,  
2.9 and pedestrian crossings, along the Mississippi River as part of improvements to Linear  
2.10 Park and Sartell Veterans Park in the city of Sartell.

2.11 **EFFECTIVE DATE.** This section is effective the day following final enactment.
