1.6	Subdivision 1. Authority. Notwithstanding any catch and release restrictions imposed
1.7	during an open season for walleye on Lake Mille Lacs, a person who has a Mille Lacs single
1.8	walleye license issued under this section may take a single walleye by angling from Lake
