1.7	Subdivision 1. Requirements. All sober homes must comply with applicable state laws
1.8	and regulations and local ordinances related to maximum occupancy, fire safety, and
1.9	sanitation. In addition, all sober homes must:
1.10	(1) maintain a supply of an opiate antagonist in the home in a conspicuous location and
1.11	post information on proper use;
1.12	(2) have written policies regarding access to all prescribed medications;
1.13	(3) have written policies regarding evictions;
1.14	(4) return all property and medications to a person discharged from the home and retain
1.15	the items for a minimum of 60 days if the person did not collect them upon discharge. The
1.16	owner must make an effort to contact persons listed as emergency contacts for the discharged
