1.2 relating to capital improvements; authorizing spending to acquire and better public

1.3 land and buildings and other improvements of a capital nature with certain

1.4 conditions; modifying previous appropriations; establishing new programs and

1.5 modifying existing programs; authorizing the sale and issuance of state bonds;

1.6 requiring a report; appropriating money; amending Minnesota Statutes 2018,

1.7 sections 16B.325, subdivision 3; 137.61; 137.62, subdivision 2, by adding a

1.8 subdivision; 137.63; 137.64; Laws 2014, chapter 294, article 1, section 7,

1.9 subdivision 11, as amended; Laws 2017, First Special Session chapter 8, article

1.10 1, sections 15, subdivisions 3, as amended, 4; 18, subdivision 3; 20, subdivision

1.11 21, as amended; Laws 2018, chapter 214, article 1, sections 16, subdivision 19;

1.13 section 2, subdivisions 3, 5; proposing coding for new law in Minnesota Statutes,

1.15 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.16 **ARTICLE 1**

1.17 **APPROPRIATIONS**

1.18 Section 1. **CAPITAL IMPROVEMENT APPROPRIATIONS.**

1.19 The sums shown in the column under "Appropriations" are appropriated from the bond

1.20 proceeds fund, or another named fund, to the state agencies or officials indicated, to be

1.21 spent for public purposes. Appropriations of bond proceeds must be spent as authorized by

1.22 the Minnesota Constitution, article XI, section 5, clause (a), to acquire and better public

1.23 land and buildings and other public improvements of a capital nature, or as authorized by

1.24 the Minnesota Constitution, article XI, section 5, clauses (b) to (j), or article XIV. Unless

1.25 otherwise specified, money appropriated in this act:

2.1 (1) may be used to pay state agency staff costs that are attributed directly to the capital
 2.2 program or project in accordance with accounting policies adopted by the commissioner of
 2.3 management and budget;

2.4 (2) is available until the project is completed or abandoned subject to Minnesota Statutes,
 2.5 section 16A.642;

2.6 (3) for activities under Minnesota Statutes, sections 16B.307, 84.946, and 135A.046,
 2.7 should not be used for projects that can be financed within a reasonable time frame under
 2.8 Minnesota Statutes, section 16B.322 or 16C.144; and

2.9 (4) is available for a grant to a political subdivision after the commissioner of management
 2.10 and budget determines that an amount sufficient to complete the project as described in this
 2.11 act has been committed to the project, as required by Minnesota Statutes, section 16A.502.

2.13 **Sec. 2. UNIVERSITY OF MINNESOTA**

2.14 **Subdivision 1. Total Appropriation** **\$ 85,000,000**

2.15 To the Board of Regents of the University of
 2.16 Minnesota for the purposes specified in this
 2.17 section.

2.18 **Subd. 2. Higher Education Asset Preservation**
 2.19 **and Replacement (HEAPR)** **55,800,000**

2.20 To be spent in accordance with Minnesota
 2.21 Statutes, section 135A.046.

2.22 **Subd. 3. Twin Cities - Child Development**
 2.23 **Building Replacement** **29,200,000**

2.24 To predesign, design, renovate, expand,
 2.25 furnish, and equip the Institute of Child
 2.26 Development building on the Twin Cities
 2.27 campus. This project includes the demolition
 2.28 and replacement of the 1968 building addition.

2.29 **Subd. 4. University Share**

2.30 Except for the appropriations for HEAPR, the
 2.31 appropriations in this section are intended to
 2.32 cover approximately two-thirds of the cost of

3.1 each project. The remaining costs must be paid
3.2 from university sources.

3.3 **Subd. 5. Unspent Appropriations**

3.4 Upon substantial completion of a project
3.5 authorized in this section and after written
3.6 notice to the commissioner of management
3.7 and budget, the Board of Regents must use
3.8 any money remaining in the appropriation for
3.9 that project for HEAPR under Minnesota
3.10 Statutes, section 135A.046. The Board of
3.11 Regents must report by February 1 of each
3.12 even-numbered year to the chairs of the house
3.13 of representatives and senate committees with
3.14 jurisdiction over capital investment and higher
3.15 education finance, and to the chairs of the
3.16 house of representatives Ways and Means
3.17 Committee and the senate Finance Committee,
3.18 on how the remaining money has been
3.19 allocated or spent.

3.20 **Sec. 3. MINNESOTA STATE COLLEGES AND**
3.21 **UNIVERSITIES**

3.22 **Subdivision 1. Total Appropriation** **\$ 85,000,000**

3.23 To the Board of Trustees of the Minnesota
3.24 State Colleges and Universities for the
3.25 purposes specified in this section.

3.26 **Subd. 2. Higher Education Asset Preservation**
3.27 **and Replacement (HEAPR)** **85,000,000**

3.28 To be spent in accordance with Minnesota
3.29 Statutes, section 135A.046.

3.30 **Subd. 3. Debt Service**

3.31 The board need not pay debt service on bonds
3.32 sold to finance HEAPR.

3.33 **Sec. 4. MINNESOTA STATE ACADEMIES** **\$ 1,500,000**

4.1 To the commissioner of administration for
 4.2 capital asset preservation improvements and
 4.3 betterments on both campuses of the
 4.4 Minnesota State Academies, to be spent in
 4.5 accordance with Minnesota Statutes, section
 4.6 16B.307.

4.7 **Sec. 5. NATURAL RESOURCES**

4.8 **Subdivision 1. Total Appropriation** **\$ 84,460,000**

4.9 (a) To the commissioner of natural resources
 4.10 for the purposes specified in this section.

4.11 (b) The appropriations in this section are
 4.12 subject to the requirements of the natural
 4.13 resources capital improvement program under
 4.14 Minnesota Statutes, section 86A.12, unless
 4.15 this section or the statutes referred to in this
 4.16 section provide more specific standards,
 4.17 criteria, or priorities for projects than
 4.18 Minnesota Statutes, section 86A.12.

4.19 **Subd. 2. Natural Resources Asset Preservation** **18,000,000**

4.20 For the renovation of state-owned facilities
 4.21 and recreational assets operated by the
 4.22 commissioner of natural resources to be spent
 4.23 in accordance with Minnesota Statutes, section
 4.24 84.946.

4.25 **Subd. 3. Flood Hazard Mitigation** **18,000,000**

4.26 (a) For the state share of flood hazard
 4.27 mitigation grants for publicly owned capital
 4.28 improvements to prevent or alleviate flood
 4.29 damage under Minnesota Statutes, section
 4.30 103F.161.

4.31 (b) To the extent practical, levee projects shall
 4.32 meet the state standard of three feet above the
 4.33 100-year flood elevation.

5.1 (c) To the extent practicable and consistent
 5.2 with the project, recipients of appropriations
 5.3 for flood control projects in this subdivision
 5.4 shall create wetlands that are eligible for
 5.5 wetland replacement credit to replace wetlands
 5.6 drained or filled as the result of repair,
 5.7 reconstruction, replacement, or rehabilitation

 5.32 not ready to proceed, this appropriation may
 5.33 be used for other projects on the

 7.32 sediment for a storm water retention basin.

68.5 (2) identify and apply all relevant criteria contained in enacted Minnesota or federal law,
68.6 or added by the commissioner;

68.7 (3) identify for stakeholders and the general public the candidate project selected under
68.8 each selection process and every project considered that was not selected;

68.9 (4) involve area transportation partnerships and other local authorities, as appropriate,
68.10 in the process of scoring and ranking candidate projects under consideration;

68.11 (5) publicize scoring and decision outcomes concerning each candidate project, including
68.12 the projects that were considered but not selected, and the reason each project was not
68.13 selected; and

68.14 (6) require that the projects in the state transportation improvement program include the
68.15 score assigned to the project.

68.16 (c) This section does not apply to the following: the safe routes to school program under
68.17 Minnesota Statutes, section 174.40; the local bridge replacement program under Minnesota
68.18 Statutes, section 174.50; the local road improvement program under Minnesota Statutes,
68.19 section 174.52; highway railroad grade crossing-warning devices replacement; statewide
68.20 freight safety improvements; or high priority bridges for the trunk highway system.

68.21 (d) For purposes of this section, a capital project means a project to purchase, replace,
68.22 or recondition the physical assets that make up the transportation system.

68.23 Subd. 2. **Report to legislature.** By February 1, 2022, the commissioner must submit a
68.24 report to the chairs, ranking minority members, and staff of the legislative committees with
68.25 jurisdiction over transportation policy and finance concerning the adopted policy and how
68.26 the policy is anticipated to improve the consistency, objectivity, and transparency of the
68.27 selection process. The report must include information on input from members of the public
68.28 and the organizations identified in subdivision 1.

68.29 **EFFECTIVE DATE.** This section is effective the day following final enactment.
