1.9 1.10	Section 1. Minnesota Statutes 2019 Supplement, section 504B.206, subdivision 1, is amended to read:
1.11	Subdivision 1. Right to terminate; procedure. (a) A tenant to a residential lease may
1.12	terminate a lease agreement in the manner provided in this section without penalty or liability,
1.13	if the tenant or another authorized occupant fears imminent violence after being subjected
1.14	to:
1.15	(1) domestic abuse, as that term is defined under section 518B.01, subdivision 2;
1.16	(2) criminal sexual conduct under sections 609.342 to 609.3451; or
1.17	(3) harass, as that term is defined harassment under section 609.749, subdivision 1.
1.18	(b) The tenant must provide signed and dated advance written notice to the landlord:

  or both.

Subd. 8. Harassment; stalking; firearms. (a) When a person is convicted of harassment 4.19 or stalking a crime under this section and the court determines that the person used a firearm 4.20 in any way during commission of the crime, the court may order that the person is prohibited 4.21 from possessing any type of firearm for any period longer than three years or for the 4.22 remainder of the person's life. A person who violates this paragraph is guilty of a gross 4.23 misdemeanor. At the time of the conviction, the court shall inform the defendant for how 4.24 long the defendant is prohibited from possessing a firearm and that it is a gross misdemeanor 4.25 to violate this paragraph. The failure of the court to provide this information to a defendant 4.26 does not affect the applicability of the firearm possession prohibition or the gross 4.27 misdemeanor penalty to that defendant. 4.28

(b) Except as otherwise provided in paragraph (a), when a person is convicted of
harassment or stalking a crime under this section, the court shall inform the defendant that
the defendant is prohibited from possessing a firearm for three years from the date of
conviction and that it is a gross misdemeanor offense to violate this prohibition. The failure

of the court to provide this information to a defendant does not affect the applicability of
the firearm possession prohibition or the gross misdemeanor penalty to that defendant.

(c) Except as otherwise provided in paragraph (a), a person is not entitled to possess a 5.3 pistol if the person has been convicted after August 1, 1996, of harassment or stalking a 5.4 crime under this section, or to possess a firearm if the person has been convicted on or after 5.5 August 1, 2014, of harassment or stalking a crime under this section, unless three years 5.6 have elapsed from the date of conviction and, during that time, the person has not been 5.7 convicted of any other violation of this section. Property rights may not be abated but access 5.8 may be restricted by the courts. A person who possesses a firearm in violation of this 5.9 paragraph is guilty of a gross misdemeanor. 5.10

(d) If the court determines that a person convicted of harassment or stalking a crime
under this section owns or possesses a firearm and used it in any way during the commission
of the crime, it shall order that the firearm be summarily forfeited under section 609.5316,
subdivision 3.

(e) Except as otherwise provided in paragraphs (d) and (g), when a person is convicted 5.15 of harassment or stalking a crime under this section, the court shall order the defendant to 5.16 transfer any firearms that the person possesses, within three business days, to a federally 5.17 licensed firearms dealer, a law enforcement agency, or a third party who may lawfully 5.18 receive them. The transfer may be permanent or temporary. A temporary firearm transfer 5.19 only entitles the receiving party to possess the firearm. A temporary transfer does not transfer 5.20 ownership or title. A defendant may not transfer firearms to a third party who resides with 5.21 the defendant. If a defendant makes a temporary transfer, a federally licensed firearms dealer 5.22 or law enforcement agency may charge the defendant a reasonable fee to store the person's 5.23 firearms and may establish policies for disposal of abandoned firearms, provided such 5.24 policies require that the person be notified via certified mail prior to disposal of abandoned 5.25 firearms. For temporary firearms transfers under this paragraph, a law enforcement agency, 5.26 federally licensed firearms dealer, or third party shall exercise due care to preserve the 5.27 quality and function of the transferred firearms and shall return the transferred firearms to 5.28 5.29 the person upon request after the expiration of the prohibiting time period imposed under this subdivision, provided the person is not otherwise prohibited from possessing firearms 5.30 under state or federal law. The return of temporarily transferred firearms to a defendant 5.31 shall comply with state and federal law. If a defendant permanently transfers the defendant's 5.32 firearms to a law enforcement agency, the agency is not required to compensate the defendant 5.33 and may charge the defendant a reasonable processing fee. A law enforcement agency is 5.34

not required to accept a person's firearm under this paragraph. The court shall order that the 6.1 person surrender all permits to carry and purchase firearms to the sheriff. 6.2

(f) A defendant who is ordered to transfer firearms under paragraph (e) must file proof 6.3 of transfer as provided for in this paragraph. If the transfer is made to a third party, the third 6.4 party must sign an affidavit under oath before a notary public either acknowledging that 6.5 the defendant permanently transferred the defendant's firearms to the third party or agreeing 6.6 to temporarily store the defendant's firearms until such time as the defendant is legally 6.7 permitted to possess firearms. The affidavit shall indicate the serial number, make, and 6.8 model of all firearms transferred by the defendant to the third party. The third party shall 6.9 acknowledge in the affidavit that the third party may be held criminally and civilly 6.10 responsible under section 624.7144 if the defendant gains access to a transferred firearm 6.11 while the firearm is in the custody of the third party. If the transfer is to a law enforcement 6.12 agency or federally licensed firearms dealer, the law enforcement agency or federally 6.13 licensed firearms dealer shall provide proof of transfer to the defendant. The proof of transfer 6.14 must specify whether the firearms were permanently or temporarily transferred and include 6.15 the name of the defendant, date of transfer, and the serial number, make, and model of all 6.16 transferred firearms. The defendant shall provide the court with a signed and notarized 6.17 affidavit or proof of transfer as described in this section within two business days of the 6.18 firearms transfer. The court shall seal affidavits and proofs of transfer filed pursuant to this 6.19 paragraph. 6.20

(g) When a person is convicted of harassment or stalking a crime under this section, the 6.21 court shall determine by a preponderance of the evidence if the person poses an imminent 6.22 risk of causing another person substantial bodily harm. Upon a finding of imminent risk, 6.23 the court shall order that the local law enforcement agency take immediate possession of 6.24 all firearms in the person's possession. The local law enforcement agency shall exercise due 6.25 care to preserve the quality and function of the defendant's firearms and shall return the 6.26 firearms to the person upon request after the expiration of the prohibiting time period, 6.27 provided the person is not otherwise prohibited from possessing firearms under state or 6.28 6.29 federal law. The local law enforcement agency shall, upon written notice from the person, transfer the firearms to a federally licensed firearms dealer or a third party who may lawfully 6.30 receive them. Before a local law enforcement agency transfers a firearm under this paragraph, 6.31 the agency shall require the third party or federally licensed firearms dealer receiving the 6.32 firearm to submit an affidavit or proof of transfer that complies with the requirements for 6.33 affidavits or proofs of transfer established in paragraph (f). The agency shall file all affidavits 6.34 or proofs of transfer received with the court within two business days of the transfer. The 6.35

court shall seal all affidavits or proofs of transfer filed pursuant to this paragraph. A federally 7.1 licensed firearms dealer or third party who accepts a firearm transfer pursuant to this

### APPENDIX Repealed Minnesota Statutes: 20-7881

## 609.749 HARASSMENT; STALKING; PENALTIES.

Subdivision 1. **Definition.** As used in this section, "harass" means to engage in conduct which the actor knows or has reason to know would cause the victim under the circumstances to feel frightened, threatened, oppressed, persecuted, or intimidated, and causes this reaction on the part of the victim regardless of the relationship between the actor and victim.

Subd. 1a. **No proof of specific intent required.** In a prosecution under this section, the state is not required to prove that the actor intended to cause the victim to feel frightened, threatened, oppressed, persecuted, or intimidated, or except as otherwise provided in subdivision 3, paragraph (a), clause (4), or paragraph (b), that the actor intended to cause any other result.
