BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA: 13 Section 1. CLEAN WATER FUND APPROPRIATIONS. 1.4 Subdivision 1. **Pollution Control Agency.** \$10,000 in fiscal year 2019 is appropriated 1.5 from the clean water fund to the commissioner of the Pollution Control Agency to support 16 activities of the Clean Water Council according to Minnesota Statutes, section 114D.30, 1.7 subdivision 1. This is a onetime appropriation. 1.8 Subd. 2. **Department of Natural Resources.** \$1,000,000 in fiscal year 2019 is 1.9 appropriated from the clean water fund to the commissioner of natural resources to acquire 1 10 permanent conservation easements in targeted areas to protect the forests and shorelands 1 11 1.12 that supply clean water to lakes, rivers, and streams under Minnesota Statutes, section 84.66. This is a onetime appropriation and is available until June 30, 2022. 1.13 Subd. 3. **Board of Water and Soil Resources.** (a) \$4,412,000 in fiscal year 2019 is 1.14 appropriated from the clean water fund to the Board of Water and Soil Resources for a pilot 1.15 program to provide performance-based grants to local government units. The grants may 1.16 be used to implement projects that protect, enhance, and restore surface water quality in 1.17 lakes, rivers, and streams; protect groundwater from degradation; and protect sources of 1.18 1.19 drinking water. Projects must be identified in a comprehensive watershed plan developed under the One Watershed, One Plan or metropolitan surface water management frameworks 1.20 or groundwater plans. Grant recipients must identify a nonstate match and may use other 1.21 legacy funds to supplement projects funded under this paragraph. 1.22

(b) \$5,000,000 in fiscal year 2019 is appropriated from the clean water fund to the Board 2.1 of Water and Soil Resources for grants to protect and restore surface water and drinking 2.2 2.3 water; to keep water on the land; to protect, enhance, and restore water quality in lakes, rivers, and streams; and to protect groundwater and drinking water, including feedlot water 2.4 quality and subsurface sewage treatment system projects and stabilization projects for stream 2.5 banks, stream channels, shoreline restorations, and ravines. The projects must use practices 2.6 demonstrated to be effective; be of long-lasting public benefit; include a match; and be 2.7 2.8 consistent with total maximum daily load (TMDL) implementation plans, watershed restoration and protection strategies (WRAPS), or local water management plans or their 2.9 equivalents. A portion of these funds may be used to seek administrative efficiencies through 2.10 shared resources by multiple local governmental units. 2.11 (c) \$15,000,000 in fiscal year 2019 is appropriated from the clean water fund to the 2.12 Board of Water and Soil Resources to purchase and restore permanent conservation sites 2.13 via easements or contracts to treat and store water on the land for water quality improvement 2.14 purposes and related technical assistance.
