The bonds may be paid from or secured by any funds available to the city of Northfield, including the tax authorized under 2.4 subdivision 1. The issuance of bonds under this subdivision is not subject to Minnesota 2.5 Statutes, sections 275.60 and 275.61. 2.6 2.7 (b) The bonds are not included in computing any debt limitation applicable to the city of Northfield, and any levy of taxes under Minnesota Statutes, section 475.61, to pay principal 2.8 and interest on the bonds is not subject to any levy limitation. A separate election to approve 2.9 the bonds under Minnesota Statutes, section 475.58, is not required. 2.10 2.11 Subd. 4. Termination of taxes.
