1.12 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.13 **ARTICLE 1**

1.14 **MINNESOTA HEALTH AND EDUCATION FACILITIES AUTHORITY**

1.15 Section 1. Minnesota Statutes 2022, section 136A.25, is amended to read:

1.16 **136A.25 CREATION.**

1.17 A state agency known as the Minnesota ~~Higher~~ Health and Education Facilities Authority

1.18 is hereby created.

1.19 Sec. 2. Minnesota Statutes 2022, section 136A.26, is amended to read:

1.20 **136A.26 MEMBERSHIPS; OFFICERS; COMPENSATION; REMOVAL.**

1.21 Subdivision 1. **Membership.** The Minnesota ~~Higher~~ Health and Education Facilities

1.22 Authority shall consist of ~~eight~~ nine members appointed by the governor with the advice

1.23 and consent of the senate, and a representative of the ~~office~~ Office of Higher Education.

2.1 All members to be appointed by the governor shall be residents of the state. At least two
 2.2 members must reside outside the metropolitan area as defined in section 473.121, subdivision
 2.3 2. At least one of the members shall be a person having a favorable reputation for skill,
 2.4 knowledge, and experience in the field of state and municipal finance; ~~and~~ at least one shall
 2.5 be a person having a favorable reputation for skill, knowledge, and experience in the building
 2.6 construction field; ~~and~~ at least one of the members shall be a trustee, director, officer, or
 2.7 employee of an institution of higher education; and at least one of the members shall be a
 2.8 trustee, director, officer, or employee of a health care organization.

2.9 Subd. 1a. **Private College Council member.** The president of the Minnesota Private
 2.10 College Council, or the president's designee, shall serve without compensation as an advisory,
 2.11 nonvoting member of the authority.

2.12 Subd. 1b. **Nonprofit health care association member.** The chief executive officer of
 2.13 a Minnesota nonprofit membership association whose members are primarily nonprofit
 2.14 health care organizations, or the chief executive officer's designee, shall serve without
 2.15 compensation as an advisory, nonvoting member of the authority. The identity of the
 2.16 Minnesota nonprofit membership association shall be determined and may be changed from
 2.17 time to time by the members of the authority in accordance with and as shall be provided
 2.18 in the bylaws of the authority.

2.19 Subd. 2. **Term; compensation; removal.** The membership terms, compensation, removal
 2.20 of members, and filling of vacancies for authority members other than the representative
 2.21 of the office, ~~and~~ the president of the Private College Council, or the chief executive officer
 2.22 of the Minnesota nonprofit membership association described in subdivision 1b shall be as
 2.23 provided in section 15.0575.

2.24 Sec. 3. Minnesota Statutes 2022, section 136A.27, is amended to read:

2.25 **136A.27 POLICY.**

2.26 It is hereby declared that for the benefit of the people of the state, the increase of their
 2.27 commerce, welfare and prosperity and the improvement of their health and living conditions
 2.28 it is essential that health care organizations within the state be provided with appropriate
 2.29 additional means to establish, acquire, construct, improve, and expand health care facilities
 2.30 in furtherance of their purposes; that this and future generations of youth be given the fullest
 2.31 opportunity to learn and to develop their intellectual and mental capacities; ~~that it is essential~~
 2.32 that institutions of higher education within the state be provided with appropriate additional
 2.33 means to assist such youth in achieving the required levels of learning and development of
 2.34 their intellectual and mental capacities; and that health care organizations and institutions

3.1 of higher education be enabled to refinance outstanding indebtedness incurred to provide
 3.2 existing facilities used for such purposes in order to preserve and enhance the utilization of
 3.3 facilities for purposes of health care and higher education, to extend or adjust maturities in
 3.4 relation to the resources available for their payment, and to save interest costs and thereby
 3.5 reduce health care costs or higher education tuition, fees, and charges; ~~and~~. It is hereby
 3.6 further declared that it is the purpose of sections 136A.25 to 136A.42 to provide a measure
 3.7 of assistance and an alternative method to enable health care organizations and institutions
 3.8 of higher education in the state to provide the facilities and structures which are sorely
 3.9 needed to accomplish the purposes of sections 136A.25 to 136A.42, all to the public benefit
 3.10 and good, to the extent and manner provided herein.

3.11 Sec. 4. Minnesota Statutes 2022, section 136A.28, is amended to read:

3.12 **136A.28 DEFINITIONS.**

3.13 Subdivision 1. **Scope.** In sections 136A.25 to 136A.42, the following words and terms
 3.14 shall, unless the context otherwise requires, have the meanings ascribed to them.

3.15 Subd. 1a. **Affiliate.** "Affiliate" means an entity that directly or indirectly controls, is
 3.16 controlled by, or is under common control with, another entity. For the purposes of this
 3.17 subdivision, "control" means either the power to elect a majority of the members of the
 3.18 governing body of an entity or the power, whether by contract or otherwise, to direct the
 3.19 management and policies of the entity. Affiliate also means an entity whose business or
 3.20 substantially all of whose property is operated under a lease, management agreement, or
 3.21 operating agreement by another entity, or an entity who operates the business or substantially
 3.22 all of the property of another entity under a lease, management agreement, or operating
 3.23 agreement.

3.24 Subd. 2. **Authority.** "Authority" means the ~~Higher~~ Health and Education Facilities
 3.25 Authority created by sections 136A.25 to 136A.42.

3.26 Subd. 3. **Project.** "Project" means ~~a structure or structures available for use as a dormitory~~
 3.27 ~~or other student housing facility, a dining hall, student union, administration building,~~
 3.28 ~~academic building, library, laboratory, research facility, classroom, athletic facility, health~~
 3.29 ~~care facility, child care facility, and maintenance, storage, or utility facility and other~~
 3.30 ~~structures or facilities related thereto or required or useful for the instruction of students or~~
 3.31 ~~the conducting of research or the operation of an institution of higher education, whether~~
 3.32 ~~proposed, under construction, or completed, including parking and other facilities or~~
 3.33 ~~structures essential or convenient for the orderly conduct of such institution for higher~~
 3.34 ~~education, and shall also include landscaping, site preparation, furniture, equipment and~~

4.1 ~~machinery, and other similar items necessary or convenient for the operation of a particular~~
 4.2 ~~facility or structure in the manner for which its use is intended but shall not include such~~
 4.3 ~~items as books, fuel, supplies, or other items the costs of which are customarily deemed to~~
 4.4 ~~result in a current operating charge, and shall~~ a health care facility or an education facility
 4.5 whether proposed, under construction, or completed, and includes land or interests in land,
 4.6 appurtenances, site preparation, landscaping, buildings and structures, systems, fixtures,
 4.7 furniture, machinery, equipment, and parking. Project also includes other structures, facilities,
 4.8 improvements, machinery, equipment, and means of transport of a capital nature that are
 4.9 necessary or convenient for the operation of the facility. Project does not include: (1) any
 4.10 facility used or to be used for sectarian instruction or as a place of religious worship nor;
 4.11 (2) any facility which is used or to be used primarily in connection with any part of the
 4.12 program of a school or department of divinity for any religious denomination; nor (3) any
 4.13 books, supplies, medicine, medical supplies, fuel, or other items, the cost of which are
 4.14 customarily deemed to result in a current operating charge.

4.15 Subd. 4. **Cost.** "Cost," as applied to a project or any portion thereof financed under the
 4.16 provisions of sections 136A.25 to 136A.42, means all or any part of the cost of construction,
 4.17 acquisition, alteration, enlargement, reconstruction and remodeling of a project including
 4.18 all lands, structures, real or personal property, rights, rights-of-way, franchises, easements
 4.19 and interests acquired or used for or in connection with a project, the cost of demolishing
 4.20 or removing any buildings or structures on land so acquired, including the cost of acquiring
 4.21 any lands to which ~~such~~ buildings or structures may be moved, the cost of all machinery
 4.22 and equipment, financing charges, interest prior to, during and for a period after completion
 4.23 of such construction and acquisition, provisions for reserves for principal and interest and
 4.24 for extensions, enlargements, additions and improvements, the cost of architectural,
 4.25 engineering, financial and legal services, plans, specifications, studies, surveys, estimates
 4.26 of cost and of revenues, administrative expenses, expenses necessary or incident to
 4.27 determining the feasibility or practicability of constructing the project and such other
 4.28 expenses as may be necessary or incident to the construction and acquisition of the project,
 4.29 the financing of such construction and acquisition and the placing of the project in operation.

4.30 Subd. 5. **Bonds.** "Bonds," or "revenue bonds" means revenue bonds of the authority
 4.31 issued under the provisions of sections 136A.25 to 136A.42, including revenue refunding
 4.32 bonds, notwithstanding that the same may be secured by mortgage or the full faith and credit
 4.33 of a participating institution ~~for higher education~~ or any other lawfully pledged security of
 4.34 a participating institution ~~for higher education~~.

5.1 Subd. 6. **Institution of higher education.** "Institution of higher education" means a
5.2 nonprofit educational institution within the state authorized to provide a program of education
5.3 beyond the high school level.

5.4 Subd. 6a. **Health care organization.** (a) "Health care organization" means a nonprofit
5.5 organization located within the state and authorized by law to operate a nonprofit health
5.6 care facility in the state. Health care organization also means a nonprofit affiliate of a health
5.7 care organization as defined under this paragraph, provided the affiliate is located within
5.8 the state or within a state that is geographically contiguous to Minnesota.

5.9 (b) Health care organization also means a nonprofit organization located within another
5.10 state that is geographically contiguous to Minnesota and authorized by law to operate a
5.11 nonprofit health care facility in that state, provided that the nonprofit organization located
5.12 within the contiguous state is an affiliate of a health care organization located within the
5.13 state.

5.14 Subd. 6b. **Education facility.** "Education facility" means a structure or structures
5.15 available for use as a dormitory or other student housing facility, dining hall, student union,
5.16 administration building, academic building, library, laboratory, research facility, classroom,
5.17 athletic facility, student health care facility, or child care facility, and includes other facilities
5.18 or structures related thereto essential or convenient for the orderly conduct of an institution
5.19 of higher education.

5.20 Subd. 6c. **Health care facility.** (a) "Health care facility" means a structure or structures
5.21 available for use within this state as a hospital, clinic, psychiatric residential treatment
5.22 facility, birth center, outpatient surgical center, comprehensive outpatient rehabilitation
5.23 facility, outpatient physical therapy or speech pathology facility, end-stage renal dialysis
5.24 facility, medical laboratory, pharmacy, radiation therapy facility, diagnostic imaging facility,
5.25 medical office building, residence for nurses or interns, nursing home, boarding care home,
5.26 assisted living facility, residential hospice, intermediate care facility for persons with
5.27 developmental disabilities, supervised living facility, housing with services establishment,
5.28 board and lodging establishment with special services, adult day care center, day services
5.29 facility, prescribed pediatric extended care facility, community residential setting, adult
5.30 foster home, or other facility related to medical or health care research, or the delivery or
5.31 administration of health care services, and includes other structures or facilities related
5.32 thereto essential or convenient for the orderly conduct of a health care organization.

6.1 (b) Health care facility also means a facility in a state that is geographically contiguous
6.2 to Minnesota operated by a health care organization that corresponds by purpose, function,
6.3 or use with a facility listed in paragraph (a).

6.4 Subd. 7. **Participating institution of higher education.** "Participating institution of
6.5 ~~higher education~~" means a health care organization or an institution of higher education
6.6 that, under the provisions of sections 136A.25 to 136A.42, undertakes the financing and
6.7 construction or acquisition of a project or undertakes the refunding or refinancing of
6.8 obligations or of a mortgage or of advances as provided in sections 136A.25 to 136A.42.
6.9 Community colleges and technical colleges may be considered participating institutions of
6.10 ~~higher education~~ for the purpose of financing and constructing child care facilities and
6.11 parking facilities.

6.12 Sec. 5. Minnesota Statutes 2022, section 136A.29, subdivision 1, is amended to read:

6.13 Subdivision 1. **Purpose.** The purpose of the authority shall be to assist health care
6.14 organizations and institutions of higher education in the construction, financing, and
6.15 refinancing of projects. The exercise by the authority of the powers conferred by sections
6.16 136A.25 to 136A.42, shall be deemed and held to be the performance of an essential public
6.17 function. For the purpose of sections 136A.25 to 136A.42, the authority shall have the
6.18 powers and duties set forth in subdivisions 2 to 23.

6.19 Sec. 6. Minnesota Statutes 2022, section 136A.29, subdivision 3, is amended to read:

6.20 Subd. 3. **Employees.** The authority is authorized and empowered to appoint and employ
6.21 employees as it may deem necessary to carry out its duties, determine the title of the
6.22 employees so employed, and fix the salary of ~~said~~ its employees. Employees of the authority
6.23 shall participate in retirement and other benefits in the same manner that employees in the
6.24 ~~unclassified service of the office~~ managerial plan under section 43A.18, subdivision 3,
6.25 participate.

6.26 Sec. 7. Minnesota Statutes 2022, section 136A.29, subdivision 6, is amended to read:

6.27 Subd. 6. **Projects; generally.** (a) The authority is authorized and empowered to determine
6.28 the location and character of any project to be financed under the provisions of sections
6.29 136A.25 to 136A.42, and to construct, reconstruct, remodel, maintain, manage, enlarge,
6.30 alter, add to, repair, operate, lease, as lessee or lessor, and regulate the same, to enter into
6.31 contracts for any or all of such purposes, to enter into contracts for the management and
6.32 operation of a project, and to designate a participating institution of ~~higher education~~ as its

7.1 agent to determine the location and character of a project undertaken by such participating
 7.2 institution ~~of higher education~~ under the provisions of sections 136A.25 to 136A.42 and as

 7.15 public contract or competitive bid law.

7.17 Subd. 9. **Revenue bonds; limit.** (a) The authority is authorized and empowered to issue

 7.19 \$4,000,000,000 and to issue notes, bond anticipation notes, and revenue refunding bonds
 7.20 of the authority under the provisions of sections 136A.25 to 136A.42, to provide funds for
 7.21 acquiring, constructing, reconstructing, enlarging, remodeling, renovating, improving,
 7.22 furnishing, or equipping one or more projects or parts thereof.

 7.30 participating institutions ~~of higher education~~ and thereby refinance outstanding indebtedness
 7.31 incurred by participating institutions ~~of higher education~~ to provide funds for the acquisition,
 7.32 construction or improvement of a facility before or after the enactment of sections 136A.25
 7.33 to 136A.42, but otherwise eligible to be and being a project thereunder, whenever the

 8.16 from issuing revenue bonds within and charged against the limitations provided in subdivision
