2.2 We, the undersigned conferees for S.F. No. 455 report that we have agreed upon the  
2.3 items in dispute and recommend as follows:

2.4 That the House recede from its amendments and that S.F. No. 455 be further  
2.5 amended as follows:

2.6 Delete everything after the enacting clause and insert:

2.7 **"ARTICLE 1**

2.8 **ELECTION ADMINISTRATION**

2.9 Section 1. Minnesota Statutes 2014, section 123B.09, subdivision 1, is amended to read:

2.10 Subdivision 1. **School board membership.** The care, management, and control of  
2.11 independent districts is vested in a board of directors, to be known as the school board.

2.12 The term of office of a member shall be four years commencing on the first Monday in  
2.13 January and until a successor qualifies. The membership of the board shall consist of six  
2.14 elected directors together with such ex officio member as may be provided by law. The  
2.15 board may submit to the electors at any school election the question whether the board  
2.16 shall consist of seven members. If a majority of those voting on the proposition favor a  
2.17 seven-member board, a seventh member shall be elected at the next election of directors  
2.18 for a four-year term and thereafter the board shall consist of seven members.

2.19 Those districts with a seven-member board may submit to the electors at any school  
2.20 election at least 150 days before the next election of three members of the board the  
2.21 question whether the board shall consist of six members. If a majority of those voting on  
2.22 the proposition favor a six-member board instead of a seven-member board, ~~two~~ three  
2.23 members instead of ~~three~~ four members shall be elected at the next election of the board of  
2.24 directors and thereafter the board shall consist of six members.

2.25 Sec. 2. Minnesota Statutes 2014, section 123B.09, is amended by adding a subdivision  
2.26 to read:

2.27 Subd. 5a. **Vacancies.** A vacancy other than a vacancy described in subdivision 4  
2.28 must be filled pursuant to section 123B.095.

2.29 Sec. 3. **[123B.095] VACANCY IN OFFICE OF SCHOOL BOARD MEMBER.**

2.30 Subdivision 1. **Option for filling vacancies; special election.** (a) Except as  
2.31 provided in section 123B.09, subdivision 4, a vacancy in the office of school board may be  
2.32 filled as provided in this subdivision and subdivision 2, or as provided in subdivision 3. If  
2.33 the vacancy is to be filled under this subdivision and subdivision 2, it must be filled at a

3.1 special election. The school board may by resolution call for a special election to be held  
3.2 according to the earliest of the following time schedules:

3.3 (1) not less than 120 days following the date the vacancy is declared, but no later  
3.4 than 12 weeks prior to the date of the next regularly scheduled primary election;

3.5 (2) concurrently with the next regularly scheduled primary election and general  
3.6 election; or

3.7 (3) no sooner than 120 days following the next regularly scheduled general election.

3.8 (b) The person elected at the special election shall take office immediately after  
3.9 receipt of the certificate of election and upon filing the bond and taking the oath of office  
3.10 and shall serve the remainder of the unexpired term.

3.11 Subd. 2. **When victor seated immediately.** If a vacancy for which a special  
3.12 election is required occurs less than 120 days before the general election preceding the  
3.13 end of the term, the vacancy shall be filled by the person elected at that election for the  
3.14 ensuing term who shall take office immediately after receiving the certificate of election,  
3.15 filing the bond and taking the oath of office.

3.16 Subd. 3. **Vacancies of less than one year; appointment option.** Except as provided  
3.17 in section 123B.09, subdivision 4, and as an alternative to the procedure provided in  
3.18 subdivisions 1 and 2, any other vacancy in the office of school board member may be  
3.19 filled by board appointment at a regular or special meeting. The appointment shall be  
3.20 evidenced by a resolution entered in the minutes and shall continue until an election is  
3.21 held under this subdivision. All elections to fill vacancies shall be for the unexpired term.  
3.22 If one year or more remains in the unexpired term, a special election must be held under  
3.23 subdivision 1. If less than one year remains in the unexpired term, the school board may  
3.24 appoint a person to fill the vacancy for the remainder of the unexpired term, unless the  
3.25 vacancy occurs within 90 days of the next school district general election, in which case  
3.26 an appointment shall not be made and the vacancy must be filled at the general election.  
3.27 The person elected to fill a vacancy at the general election takes office immediately in the  
3.28 same manner as for a special election under subdivision 1, and serves the remainder of the  
3.29 unexpired term and the new term for which the election was otherwise held.

3.30 Subd. 4. **School board vacancy appointment; public hearing.** Before making an  
3.31 appointment to fill a vacancy under subdivision 3, the school board must hold a public  
3.32 hearing not more than 30 days after the vacancy occurs with public notice given in the  
3.33 same manner as for a special meeting of the school board. At the public hearing, the board  
3.34 must invite public testimony from persons residing in the district in which the vacancy  
3.35 occurs relating to the qualifications of prospective appointees to fill the vacancy. Before  
3.36 making an appointment, the board also must notify public officials in the school district

4.1 on the appointment, including county commissioners, town supervisors, and city council  
4.2 members, and must enter into the record at the board meeting in which the appointment is  
4.3 made the names and addresses of the public officials notified. If, after the public hearing,  
4.4 the board is unable or decides not to make an appointment under subdivision 3, it must  
4.5 hold a special election under subdivision 1, but the time period in which the election must  
4.6 be held begins to run from the date of the public hearing.

4.7 Sec. 4. Minnesota Statutes 2014, section 200.02, subdivision 7, is amended to read:

4.8 Subd. 7. **Major political party.** (a) "Major political party" means a political party  
4.9 that maintains a party organization in the state, political division or precinct in question  
4.10 and that has presented at least one candidate for election to the office of:

4.11 (1) governor and lieutenant governor, secretary of state, state auditor, or attorney  
4.12 general at the last preceding state general election for those offices; or

4.13 (2) presidential elector or U.S. senator at the last preceding state general election for  
4.14 presidential electors; and

4.15 whose candidate received votes in each county in that election and received votes  
4.16 from not less than five percent of the total number of individuals who voted in that election.

4.17 (b) "Major political party" also means a political party that maintains a party  
4.18 organization in the state, political subdivision, or precinct in question and that has  
4.19 presented at least 45 candidates for election to the office of state representative, 23  
4.20 candidates for election to the office of state senator, four candidates for election to  
4.21 the office of representative in Congress, and one candidate for election to each of the  
4.22 following offices: governor and lieutenant governor, attorney general, secretary of state,  
4.23 and state auditor, at the last preceding state general election for those offices.

4.24 (c) "Major political party" also means a political party that maintains a party  
4.25 organization in the state, political subdivision, or precinct in question and whose members  
4.26 present to the secretary of state at any time before the close of filing for the state partisan  
4.27 primary ballot a petition for a place on the state partisan primary ballot, which petition  
4.28 contains valid signatures of a number of the party members equal to at least five percent  
4.29 of the total number of individuals who voted in the preceding state general election. A  
4.30 signature is valid only if signed no more than one year prior to the date the petition was filed.

4.31 (d) A political party whose candidate receives a sufficient number of votes at a state  
4.32 general election described in paragraph (a) or a political party that presents candidates at  
4.33 an election as required by paragraph (b) becomes a major political party as of January  
4.34 1 following that election and retains its major party status for at least two state general  
4.35 elections even if the party fails to present a candidate who receives the number and

5.1 percentage of votes required under paragraph (a) or fails to present candidates as required  
5.2 by paragraph (b) at subsequent state general elections.

5.3 (e) A major political party whose candidates fail to receive the number and  
5.4 percentage of votes required under paragraph (a) and that fails to present candidates as  
5.5 required by paragraph (b) at each of two consecutive state general elections described by  
5.6 paragraph (a) or (b), respectively, loses major party status as of December 31 following  
5.7 the later of the two consecutive state general elections.

5.8 Sec. 5. Minnesota Statutes 2014, section 200.02, subdivision 23, is amended to read:

5.9 Subd. 23. **Minor political party.** (a) "Minor political party" means a political party  
5.10 that has adopted a state constitution, designated a state party chair, held a state convention  
5.11 in the last two years, filed with the secretary of state no later than December 31 following  
5.12 the most recent state general election a certification that the party has met the foregoing  
5.13 requirements, and met the requirements of paragraph (b) or (e), as applicable.

5.14 (b) To be considered a minor party in all elections statewide, the political party must  
5.15 have presented at least one candidate for election to the office of:

5.16 (1) governor and lieutenant governor, secretary of state, state auditor, or attorney  
5.17 general, at the last preceding state general election for those offices; or

5.18 (2) presidential elector or U.S. senator at the preceding state general election for  
5.19 presidential electors; and

5.20 (3) who received votes in each county that in the aggregate equal at least one percent  
5.21 of the total number of individuals who voted in the election, or its members must have  
5.22 presented to the secretary of state at any time before the close of filing for the state  
5.23 partisan primary ballot a nominating petition in a form prescribed by the secretary of state  
5.24 containing the valid signatures of party members in a number equal to at least one percent  
5.25 of the total number of individuals who voted in the preceding state general election. A  
5.26 signature is valid only if signed no more than one year prior to the date the petition was filed.

5.27 (c) A political party whose candidate receives a sufficient number of votes at a  
5.28 state general election described in paragraph (b) becomes a minor political party as of  
5.29 January 1 following that election and retains its minor party status for at least two state  
5.30 general elections even if the party fails to present a candidate who receives the number  
5.31 and percentage of votes required under paragraph (b) at subsequent state general elections.

5.32 (d) A minor political party whose candidates fail to receive the number and  
5.33 percentage of votes required under paragraph (b) at each of two consecutive state general  
5.34 elections described by paragraph (b) loses minor party status as of December 31 following  
5.35 the later of the two consecutive state general elections.

6.1 (e) A minor party that qualifies to be a major party loses its status as a minor party  
6.2 at the time it becomes a major party. Votes received by the candidates of a major party  
6.3 must be counted in determining whether the party received sufficient votes to qualify as a  
6.4 minor party, notwithstanding that the party does not receive sufficient votes to retain its  
6.5 major party status. To be considered a minor party in an election in a legislative district,  
6.6 the political party must have presented at least one candidate for a legislative office in that  
6.7 district who received votes from at least ten percent of the total number of individuals  
6.8 who voted for that office, or its members must have presented to the secretary of state a  
6.9 nominating petition in a form prescribed by the secretary of state containing the valid  
6.10 signatures of party members in a number equal to at least ten percent of the total number of  
6.11 individuals who voted in the preceding state general election for that legislative office. A  
6.12 signature is valid only if signed no more than one year prior to the date the petition was filed.

6.13 Sec. 6. Minnesota Statutes 2014, section 200.02, is amended by adding a subdivision  
6.14 to read:

6.15 Subd. 27. **Partisan offices.** "Partisan offices" means federal offices, presidential  
6.16 electors, constitutional offices, and legislative offices.

6.17 Sec. 7. Minnesota Statutes 2014, section 200.02, is amended by adding a subdivision  
6.18 to read:

6.19 Subd. 28. **Nonpartisan offices.** "Nonpartisan offices" means all judicial, county,  
6.20 municipal, school district, and special district offices.

6.21 Sec. 8. Minnesota Statutes 2014, section 201.071, subdivision 1, is amended to read:

6.22 Subdivision 1. **Form.** Both paper and electronic voter registration applications must  
6.23 contain the same information unless otherwise provided by law. A voter registration  
6.24 application must contain spaces for the following required information: voter's first name,  
6.25 middle name, and last name; voter's previous name, if any; voter's current address; voter's  
6.26 previous address, if any; voter's date of birth; voter's municipality and county of residence;  
6.27 voter's telephone number, if provided by the voter; date of registration; current and valid  
6.28 Minnesota driver's license number or Minnesota state identification number, or if the voter  
6.29 has no current and valid Minnesota driver's license or Minnesota state identification, the  
6.30 last four digits of the voter's Social Security number; and voter's signature. The paper  
6.31 registration application may include the voter's e-mail address, if provided by the voter.  
6.32 The electronic voter registration application must include the voter's e-mail address. The  
6.33 registration application may include the voter's interest in serving as an election judge,

7.1 if indicated by the voter. The application must also contain the following certification  
7.2 of voter eligibility:

7.3 "I certify that I:

7.4 (1) will be at least 18 years old on election day;

7.5 (2) am a citizen of the United States;

7.6 (3) will have resided in Minnesota for 20 days immediately preceding election day;

7.7 (4) maintain residence at the address given on the registration form;

7.8 (5) am not under court-ordered guardianship in which the court order revokes my  
7.9 right to vote;

7.10 (6) have not been found by a court to be legally incompetent to vote;

7.11 (7) have the right to vote because, if I have been convicted of a felony, my felony  
7.12 sentence has expired (been completed) or I have been discharged from my sentence; and

7.13 (8) have read and understand the following statement: that giving false information  
7.14 is a felony punishable by not more than five years imprisonment or a fine of not more  
7.15 than \$10,000, or both."

7.16 The certification must include boxes for the voter to respond to the following  
7.17 questions:

7.18 "(1) Are you a citizen of the United States?" and

7.19 "(2) Will you be 18 years old on or before election day?"

7.20 And the instruction:

7.21 "If you checked 'no' to either of these questions, do not complete this form."

7.22 ~~A paper voter registration application must be of suitable size and weight for~~

7.23 ~~mailing.~~ The form of the voter registration application and the certification of voter  
7.24 eligibility must be as provided in this subdivision and approved by the secretary of state.

7.25 Voter registration forms authorized by the National Voter Registration Act must also be  
7.26 accepted as valid. The federal postcard application form must also be accepted as valid if  
7.27 it is not deficient and the voter is eligible to register in Minnesota.

7.28 An individual may use a voter registration application to apply to register to vote in  
7.29 Minnesota or to change information on an existing registration.

7.30 Sec. 9. Minnesota Statutes 2014, section 201.158, is amended to read:

7.31 **201.158 USE OF DEPARTMENT OF PUBLIC SAFETY DATA.**

7.32 As required by the Help America Vote Act of 2002, Public Law 107-252, the  
7.33 commissioner of public safety shall make electronic data on citizenship available to the  
7.34 secretary of state. The secretary of state must determine whether the data newly indicates  
7.35 that any individuals who have active records in the statewide voter registration system

8.1 are not citizens. The secretary of state shall prepare a list of those voters for each county  
8.2 auditor at least monthly. The county auditor shall change the status of those registrants in  
8.3 the statewide voter registration system to reflect that they are challenged based upon their  
8.4 citizenship and must notify the county attorney.

8.5 ~~In 2010, the secretary of state must make the determination and provide lists~~  
8.6 ~~to the county auditors between 30 and 60 days before the general election and again~~  
8.7 ~~between six and ten weeks after the election. In 2011, the secretary of state must make~~

8.11 **201.275 INVESTIGATIONS; PROSECUTIONS.**

8.12 (a) A law enforcement agency that is notified by affidavit of an alleged violation of  
8.13 this chapter shall promptly investigate. Upon receiving an affidavit alleging a violation  
8.14 of this chapter, a county attorney shall promptly forward it to a law enforcement agency  
8.15 with jurisdiction for investigation. If there is probable cause for instituting a prosecution,  
8.16 the county attorney shall proceed by complaint or present the charge, with whatever  
8.17 evidence has been found, to the grand jury according to the generally applicable standards  
8.18 regarding the prosecutorial functions and duties of a county attorney, provided that  
8.19 the county attorney is not required to proceed with the prosecution if the complainant  
8.20 withdraws the allegation. A county attorney who refuses or intentionally fails to faithfully

8.29 electronically through the secure Web site established in section 201.061, subdivision 1,  
8.30 alleged violations of this chapter may be investigated and prosecuted in the county in  
8.31 which the individual registered or attempted to register.

8.32 **EFFECTIVE DATE.** This section is effective the day following final enactment.

9.1 Subd. 3. **Military.** "Military" means the Army, Navy, Air Force, Marine Corps,

9.3 defined in United States Code, title ~~42, section 1973ff-6~~ 52, section 20310, and military  
9.4 forces as defined by section 190.05, subdivision 3.

9.5 Sec. 12. Minnesota Statutes 2014, section 203B.07, subdivision 1, is amended to read:

9.6 Subdivision 1. **Delivery of envelopes, directions.** The county auditor or the  
9.7 municipal clerk shall prepare, print, and transmit a return envelope, a ballot envelope, and  
9.8 a copy of the directions for casting an absentee ballot to each applicant whose application  
9.9 for absentee ballots is accepted pursuant to section 203B.04. The county auditor or  
9.10 municipal clerk shall provide first class postage for the return envelope. The directions  
9.11 for casting an absentee ballot shall be printed in at least 14-point bold type with heavy  
9.12 leading and may be printed on the ballot envelope. When a person requests the directions  
9.13 in Braille or on ~~eassette-tape~~ audio file, the county auditor or municipal clerk shall provide  
9.14 them in the form requested. The secretary of state shall prepare Braille and ~~eassette~~ audio

9.20 Subdivision 1. **Marking and return by voter.** An eligible voter who receives  
9.21 absentee ballots as provided in this chapter shall mark them in the manner specified in the  
9.22 directions for casting the absentee ballots. The return envelope containing marked ballots  
9.23 may be mailed as provided in the directions for casting the absentee ballots or may be  
9.24 left with the county auditor or municipal clerk who transmitted the absentee ballots to the  
9.25 voter. If delivered in person ~~by an agent~~, the return envelope must be submitted to the  
9.26 county auditor or municipal clerk by 3:00 p.m. on election day.

9.27 The voter may designate an agent to deliver in person the sealed absentee ballot  
9.28 return envelope to the county auditor or municipal clerk or to deposit the return envelope  
9.29 in the mail. An agent may deliver or mail the return envelopes of not more than three

10.1           Subd. 3. **Procedures on receipt of ballots.** When absentee ballots are returned to a  
10.2 county auditor or municipal clerk, that official shall stamp or initial and date the return  
10.3 envelope and place it in a secure location with other return envelopes received by that  
10.4 office. Within five days after receipt, the county auditor or municipal clerk shall deliver to  
10.5 the ballot board all ballots received, except that during the 14 days immediately preceding  
10.6 an election, the county auditor or municipal clerk shall deliver all ballots received to the  
10.7 ballot board within three days. Ballots received on election day either (1) after 3:00 p.m.,

10.12           Subd. 2. **Duties of ballot board; absentee ballots.** (a) The members of the ballot  
10.13 board shall take possession of all return envelopes delivered to them in accordance with  
10.14 section 203B.08. Upon receipt from the county auditor, municipal clerk, or school district  
10.15 clerk, two or more members of the ballot board shall examine each return envelope and  
10.16 shall mark it accepted or rejected in the manner provided in this subdivision. Election  
10.17 judges performing the duties in this section must be of different major political parties,  
10.18 unless they are exempt from that requirement under section 205.075, subdivision 4, or  
10.19 section 205A.10, subdivision 2.
