The secretary of state must determine whether the data newly indicates 6.5 that any individuals who have active records in the statewide voter registration system 6.6 are not citizens. The secretary of state shall prepare a list of those voters for each county 6.7 auditor at least monthly. The county auditor shall change the status of those registrants in 6.8 the statewide voter registration system to reflect that they are challenged based upon their 6.9 citizenship and must notify the county attorney. 6.10
