1.5	Section 1. THERMAL ENERGY NETWORK DEPLOYMENT WORK GROUP.
1.6	Subdivision 1. Direction. The Public Utilities Commission must establish a thermal
1.7	energy network deployment work group to examine the potential regulatory opportunities
1.8	for regulated natural gas utilities to deploy thermal energy networks and potential barriers
1.9	to development. The work group must examine the public benefits, costs, and impacts of
1.10	deployment of thermal energy networks, as well as examine rate design options.
