1.5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.6	Section 1. [175.46] YOUTH SKILLS TRAINING PROGRAM.
1.7	Subdivision 1. Program established. The commissioner shall administer a youth skills
1.8	training program established for the purpose of providing work-based skills training for
1.9	student learners ages 16 and 17. The commissioner shall award grants to local partnerships
1.10	for the implementation and coordination of local youth skills training programs as provided
1.11	in this section.
1.12	Subd. 2. Definitions. (a) For purposes of this section, the terms in this subdivision have
1.13	the meanings given.
1.14	(b) "Local partnership" means one or more school districts, or any combination of one
1.15	or more school districts, other public agencies, nonprofit organizations, or individuals who
1.16	have agreed to be responsible for implementing and coordinating a local youth skills training
1.17	program.
1.18	(c) "Public agency" means a city, county, town, school district, postsecondary institution,
1.19	or the administrative entity of a local workforce development area.
1.20	(d) "Student learner" means a student who is employed on a part-time basis to obtain
1.21	both academic credit and employment training under a youth skills training program approved
1.22	under this section and the employment is subject to a written agreement, which provides

2.26	from any provisions of chapter 181A for the student learners participating in training

2.28	not limited to, provisions relating to hazardous occupations, time of day, and maximum
2.29	hours.
2.30	Subd. 5. Other apprenticeship programs. (a) The youth skills training program under
2.31	this section shall not affect any apprenticeship program that is governed by section 124D.47.

3.6	(b) A local partnership shall include in its grant application:

4.16	\$500,000 is appropriated in fiscal year 2018 from the workforce development fund to
4.17	the commissioner of labor and industry to implement the youth skills training program under
4.18	Minnesota Statutes, section 175.46. The commissioner shall award up to five grants to local
4.19	partnerships located throughout the state, not to exceed \$ per local partnership grant.
4.20	The commissioner may expend up to five percent of this appropriation for administration
4.21	of the program.
