1.2 reporting, and other regulatory provisions; making technical, clarifying, and
1.3 conforming changes; amending Minnesota Statutes 2014, sections 349.12,
1.4 subdivisions 3c, 18; 349.16, by adding a subdivision; 349.161, by adding
1.5 a subdivision; 349.163, by adding a subdivision; 349.1635, by adding a

1.11 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.12 Section 1. Minnesota Statutes 2014, section 349.12, subdivision 3c, is amended to read:

1.13 Subd. 3c. **Bar bingo.** "Bar bingo" is a bingo occasion conducted at a permitted
1.14 premises in an area where intoxicating liquor or on-sale 3.2 percent malt beverages are
1.15 sold and where ~~the~~ a licensed organization conducts another form of lawful gambling. Bar
1.16 bingo does not include bingo games linked to other permitted premises.

1.17 **EFFECTIVE DATE.** This section is effective July 1, 2015.

1.18 Sec. 2. Minnesota Statutes 2014, section 349.12, subdivision 18, is amended to read:

1.19 Subd. 18. **Gambling equipment.** "Gambling equipment" means gambling
1.20 equipment that is either disposable or permanent gambling equipment.

1.21 (a) Disposable gambling equipment includes the following:

1.22 (1) bingo hard cards or paper sheets, including linked bingo paper sheets;

1.23 (2) paper and electronic pull-tabs;

1.24 (3) jar tickets;

1.25 (4) paddle tickets and paddle ticket cards;

2.1 (5) tipboards and tipboard tickets; ~~and~~
 2.2 (6) promotional tickets that mimic a pull-tab or tipboard; and
 2.3 (7) application software and those computer programs provided by a licensed
 2.4 manufacturer in the production, play, and reporting of board-approved electronic pull-tab
 2.5 games or electronic bingo games.

2.6 (b) Permanent gambling equipment includes the following:

2.7 (1) devices for selecting bingo numbers;

2.8 (2) electronic bingo devices;

2.9 (3) electronic pull-tab devices;

2.10 (4) pull-tab dispensing devices;

2.11 (5) programmable electronic devices that have no effect on the outcome of a game
 2.12 and are used to provide a visual or auditory enhancement of a game;

2.13 (6) paddlewheels; and

2.14 (7) paddlewheel tables.

2.15 **EFFECTIVE DATE.** This section is effective July 1, 2015.

2.16 Sec. 3. Minnesota Statutes 2014, section 349.16, is amended by adding a subdivision
 2.17 to read:

2.18 **Subd. 2a. Merged organizations.** If two or more organizations merge or otherwise
 2.19 join together to form a new organization and at least one of the organizations has an active
 2.20 lawful gambling license, the board shall consider the new organization to have been in
 2.21 existence for the most recent three years if all other requirements of subdivision 2 are met.

2.22 **EFFECTIVE DATE.** This section is effective July 1, 2015.

2.23 Sec. 4. Minnesota Statutes 2014, section 349.161, is amended by adding a subdivision
 2.24 to read:

2.25 **Subd. 9. Distributor license termination plan.** (a) A licensed distributor that
 2.26 surrenders, withdraws, or otherwise terminates its license must submit to the board, in
 2.27 writing, a termination plan. Termination of a license may occur due to revocation or
 2.28 denial of the license by the board, or by the distributor voluntarily quitting its business.
 2.29 Termination plans must be approved by the executive director.

2.30 (b) The termination plan must include a certified physical inventory in a format
 2.31 prescribed by the board. The certified physical inventory must also be submitted to the
 2.32 commissioner of revenue. The certified physical inventory must include the following
 2.33 information:

3.1 (1) an inventory of all gambling equipment as of the date the form is prepared,
3.2 including name, form number, bar code information, and quantity of all gambling
3.3 equipment in the distributor's inventory; and

3.4 (2) plans for disposal of all gambling equipment by the date of termination. After
3.5 the date on which a license is terminated, it is illegal for a distributor to possess gambling
3.6 equipment.

3.7 (c) The distributor or its designated agent must keep all invoices and other required
3.8 documentation related to the sale or disposal of equipment for 3-1/2 years after the license
3.9 has been terminated.

3.10 **EFFECTIVE DATE.** This section is effective July 1, 2015.

3.11 Sec. 5. Minnesota Statutes 2014, section 349.163, is amended by adding a subdivision
3.12 to read:

3.13 **Subd. 10. Manufacturer license termination plan.** (a) A manufacturer that
3.14 surrenders, withdraws, or otherwise terminates its license must submit to the board, in
3.15 writing, a termination plan. Termination of a license may occur due to revocation or
3.16 denial of the license by the board, or by the manufacturer voluntarily quitting its business.
3.17 Termination plans must be approved by the executive director.

3.18 (b) The license termination plan must include the manufacturer's agreement to
3.19 accept returned equipment and issue credit for defective products up to six months after
3.20 the license termination date.

3.21 (c) The manufacturer or its designated agent must keep all invoices and other
3.22 required documentation related to the sale or disposal of gambling equipment for 3-1/2
3.23 years after the license has been terminated.

3.24 **EFFECTIVE DATE.** This section is effective July 1, 2015.

3.25 Sec. 6. Minnesota Statutes 2014, section 349.1635, is amended by adding a subdivision
3.26 to read:

3.27 **Subd. 6. Linked bingo game provider license termination plan.** (a) A linked
3.28 bingo game provider that surrenders, withdraws, or otherwise terminates its license must
3.29 submit to the board, in writing, a termination plan. Termination of a license may occur
3.30 due to revocation or denial of the license by the board, or by the linked bingo game
3.31 provider voluntarily quitting its business. Termination plans must be approved by the
3.32 executive director.

4.1 (b) The license termination plan must include the reconciliation and refund of all
4.2 unredeemed prize pool contributions to organizations and the disposal of equipment.

4.3 (c) The linked bingo game provider or its designated agent must keep all invoices
4.4 and other required documentation related to the sale or disposal of gambling equipment
4.5 for 3-1/2 years after the license has been terminated.

4.6 **EFFECTIVE DATE.** This section is effective July 1, 2015.

4.7 Sec. 7. Minnesota Statutes 2014, section 349.1641, is amended to read:

4.8 **349.1641 LICENSES; SUMMARY SUSPENSION.**

4.9 (a) The board may (1) summarily suspend the license of an organization that is more
4.10 than 45 days late in filing a monthly report required to be submitted to the board under this
4.11 chapter or board rule or a tax return or in paying a tax required under chapter 297E and
4.12 may keep the suspension in effect until all required returns are filed and required taxes are
4.13 paid; (2) summarily suspend for not more than 90 days any license issued by the board or
4.14 director for what the board determines are actions detrimental to the integrity of lawful
4.15 gambling in Minnesota; (3) summarily suspend the license of a gambling manager who
4.16 has failed to receive the training required under section 349.167, subdivision 4, clause (2),
4.17 and may keep the suspension in effect until the gambling manager passes an examination
4.18 prepared and administered by the board. The examination does not qualify as continuing
4.19 education credit for the next calendar year; and (4) summarily suspend the license of an
4.20 organization that fails to pay the fees required under section 349.16, 349.165, or 349.167,
4.21 and may keep the suspension in effect until all required fees are paid.

4.22 (b) The board must notify the licensee at least 14 days before suspending the license
4.23 under this section. If a license is summarily suspended under this section, a contested
4.24 case hearing on the merits must be held within 20 days of the issuance of the order
4.25 of suspension, unless the parties agree to a later hearing date. The administrative law
4.26 judge's report must be issued within 20 days after the close of the hearing record. In all
4.27 cases involving summary suspension, the board must issue its final decision within 30
4.28 days after receipt of the report of the administrative law judge and subsequent exceptions
4.29 and argument under section 14.61. When an organization's license is suspended under
4.30 this section, the board shall within three days notify all municipalities in which the
4.31 organization's gambling premises are located and all licensed distributors in the state.

5.1 Subd. 5. **Off-site permits.** (a) Except as allowed under subdivision 5a, a licensed
 5.2 organization may conduct lawful gambling on a premises other than the organization's
 5.3 permitted premises if it has first submitted to the board an application and a lease on
 5.4 forms provided by the board, obtained authorization required under section 349.213, and
 5.5 received a permit from the board for each event up to 12 events in a calendar year ~~in~~
 5.6 ~~connection with a county fair, the State Fair, a church festival, or a civic celebration~~, not
 5.7 to exceed three days per event.

5.8 (b) No lease is required for the conduct of a raffle.

5.9 (c) No fee may be assessed for an off-site permit by the board or by local authority
 5.10 under section 349.213.

5.11 **EFFECTIVE DATE.** This section is effective July 1, 2015.

5.12 Sec. 9. Minnesota Statutes 2014, section 349.166, is amended to read:

5.13 **349.166 EXCLUSIONS; EXEMPTIONS.**

5.14 Subdivision 1. **Exclusions.** (a) Bingo, with the exception of linked bingo games, may
 5.15 be conducted without a license and without complying with sections 349.168, subdivisions
 5.16 1 and 2; 349.17, subdivisions 4 and 5; 349.18, subdivision 1; and 349.19, if it is conducted:

5.17 (1) by an organization in connection with a county fair, the state fair, or a civic
 5.18 celebration and is not conducted for more than 12 consecutive days and is limited to no more
 5.19 than four separate applications for activities applied for and approved in a calendar year; or

5.20 (2) by an organization that conducts bingo on four or fewer days in a calendar year.

5.21 An organization that holds a license to conduct lawful gambling under this chapter
 5.22 may not conduct bingo under this subdivision.

5.23 (b) Bingo may be conducted within a nursing home or a senior citizen housing project
 5.24 or by a senior citizen organization if the prizes for a single bingo game do not exceed \$10,
 5.25 total prizes awarded at a single bingo occasion do not exceed \$200, ~~no more than two~~
 5.26 ~~bingo occasions are held by the organization or at the facility each week~~, only members of
 5.27 the organization or residents and their guests of the nursing home or housing project are
 5.28 allowed to play in a bingo game, no compensation is paid for any persons who conduct the
 5.29 bingo, and a manager is appointed to supervise the bingo. Bingo conducted under this
 5.30 paragraph is exempt from sections 349.11 to 349.23, and the board may not require an
 5.31 organization that conducts bingo under this paragraph, or the manager who supervises the
 5.32 bingo, to register or file a report with the board. The gross receipts from bingo conducted
 5.33 under the limitations of this subdivision are exempt from taxation under chapter 297A.

6.1 (c) Raffles may be conducted by an organization without registering with the board
6.2 if the value of all raffle prizes awarded by the organization in a calendar year does not
6.3 exceed \$1,500 or, if the organization is a 501(c)(3) organization, if the value of all raffle
6.4 prizes awarded by the organization at one event in a calendar year does not exceed \$5,000.

6.5 (d) Except as provided in paragraph (b), the organization must maintain all required
6.6 records of excluded gambling activity for 3-1/2 years.

6.7 Subd. 2. **Exemptions.** (a) Lawful gambling, with the exception of linked bingo
6.8 games, may be conducted by an organization without a license and without complying
6.9 with sections 349.168, subdivisions 1 and 2; 349.17, subdivision 4; 349.18, subdivision 1;
6.10 and 349.19 if:

6.11 (1) the organization conducts lawful gambling on five or fewer days in a calendar year;

6.12 (2) the organization does not award more than \$50,000 in prizes for lawful gambling
6.13 in a calendar year;

6.14 (3) the organization submits a board-prescribed application and pays a fee of \$50 to
6.15 the board for each gambling occasion, and receives an exempt permit number from the
6.16 board. If the application is postmarked or received less than 30 days before the gambling
6.17 occasion, the fee is \$100 for that application. The application must include the date and
6.18 location of the occasion, the types of lawful gambling to be conducted, and the prizes
6.19 to be awarded;

6.20 (4) the organization notifies the local government unit 30 days before the lawful
6.21 gambling occasion, or 60 days for an occasion held in a city of the first class;

6.22 (5) the organization purchases all gambling equipment and supplies from a licensed
6.23 distributor; and

6.24 (6) the organization reports to the board, on a single-page form prescribed by the
6.25 board, within 30 days of each gambling occasion, the gross receipts, prizes, expenses,
6.26 expenditures of net profits from the occasion, and the identification of the licensed
6.27 distributor from whom all gambling equipment was purchased.

6.28 (b) No more than one organization exempted or excluded from licensing
6.29 requirements may conduct an individual raffle.

6.30 (1) Exempted or excluded organizations may not combine the use of raffle tickets.

6.31 (2) Raffle tickets must not be attached to or combined with other exempted or
6.32 excluded organizations' raffle tickets and must be sold separately from other exempted
6.33 or excluded organizations' raffle tickets.

6.34 ~~(b)~~ (c) If the organization fails to file a timely report as required by paragraph (a),
6.35 clause (6), the board shall not issue any authorization, license, or permit to the organization
6.36 to conduct lawful gambling on an exempt, excluded, or licensed basis until the report has

7.1 been filed and the organization may be subject to penalty as determined by the board. The
7.2 board may refuse to issue any authorization, license, or permit if a report or application is
7.3 determined to be incomplete or knowingly contains false or inaccurate information.

7.4 ~~(e)~~ (d) Merchandise prizes must be valued at their fair market value.

7.5 ~~(d)~~ (e) Organizations that qualify to conduct exempt raffles under paragraph (a);
7.6 are exempt from section 349.173, paragraph (b), clause (2), if the raffle tickets are sold
7.7 only in combination with an organization's membership or a ticket for an organization's
7.8 membership dinner and are not included with any other raffle conducted under the exempt
7.9 permit.

7.10 ~~(e)~~ (f) Unused pull-tab and tipboard deals must be returned to the distributor within
7.11 seven working days after the end of the lawful gambling occasion. The distributor must
7.12 accept and pay a refund for all returns of unopened and undamaged deals returned under
7.13 this paragraph.

7.14 ~~(f)~~ (g) The organization must maintain all required records of exempt gambling
7.15 activity for 3-1/2 years.

7.16 **EFFECTIVE DATE.** This section is effective for all permits with an effective date
7.17 of July 1, 2015, or later.

7.18 Sec. 10. Minnesota Statutes 2014, section 349.168, subdivision 8, is amended to read:

7.19 Subd. 8. **Compensation paid.** (a) A licensed organization may pay a percentage of
7.20 the gross profit from raffle ticket sales to a nonprofit organization that sells raffle tickets
7.21 for the licensed organization.

7.22 (b) A licensed organization may compensate an employee of the organization for
7.23 the sale of gambling equipment at a bar operation if the frequency of the activity is one
7.24 day or less per week and the games are limited to 32 chances or less per game. For
7.25 purposes of this paragraph, an employee must not be a lessor, employee of the lessor, or an
7.26 immediate family member of the lessor.

7.27 (c) An organization that leases a premises may not pay compensation to the lessor,
7.28 a member of the lessor's immediate family, or the lessor's employees, other than as a
7.29 seller of pull-tabs and tipboards within a booth operation on the premises. An employee
7.30 of the lessor or a member of the lessor's immediate family may be compensated by an
7.31 organization for the conduct of gambling at other sites not owned by the lessor.

7.32 **EFFECTIVE DATE.** This section is effective July 1, 2015.

8.1 Sec. 11. Minnesota Statutes 2014, section 349.169, is amended to read:

8.2 **349.169 FILING OF ~~PRICES~~ INVENTORY AND DISCOUNTS.**

8.3 Subdivision 1. **Filing required.** When required by the board, manufacturers,
8.4 distributors, and linked bingo game providers must file with the director the ~~prices~~
8.5 inventory at which the manufacturer, distributor, or linked bingo game provider ~~will sell~~
8.6 sold or leased all gambling equipment ~~currently offered for sale by that manufacturer,~~
8.7 ~~distributor, or linked bingo game provider~~ on a monthly basis. The filing must be in
8.8 a format the director prescribes.

8.9 Subd. 2. **Copies.** The director shall provide copies of ~~price~~ filings to any person
8.10 requesting them and may charge a reasonable fee for the copies. Any person may examine

8.23 awarded and delivered the same day on which the bingo occasion is conducted, except that
8.24 payment for a ~~progressive prize or a linked bingo prize~~ of \$200 or more must be delivered
8.25 within three business days of the day on which the occasion was conducted.

8.26 **EFFECTIVE DATE.** This section is effective July 1, 2015.

8.27 Sec. 13. Minnesota Statutes 2014, section 349.17, subdivision 7, is amended to read:

8.28 Subd. 7. **Bar bingo.** An organization may conduct bar bingo subject to the

9.8 (a) The permitted premises must be:

9.9 (1) a premises licensed for the on-sale ~~or off-sale~~ of intoxicating liquor or on-sale
9.10 3.2 percent malt beverages, ~~except for a general food store or drug store permitted to sell~~
9.11 ~~alcoholic beverages under section 340A.405, subdivision 1;~~ or

9.14 (b) The number of electronic bingo devices is limited to:

9.18 primary business.

9.19 Seating capacity is determined as specified under the local fire code.

9.20 (c) Prior to a bingo occasion, the linked bingo game provider, on behalf of the
9.21 participating organizations, must provide to the board a bingo program in a format
9.22 prescribed by the board.

9.23 (d) Before participating in the play of a linked bingo game, a player must present ~~and~~
9.24 ~~register~~ a valid picture identification card that includes the player's ~~address and~~ date of birth.

9.25 (e) A licensed organization must require each person cashing out an electronic
9.26 linked bingo device with \$600 or more in credits to present identification in the form of
9.27 a driver's license, Minnesota identification card, or other identification the board deems
9.28 sufficient to allow the identification and tracking of the winner. The organization must
9.29 retain the winner's identification in the form of a prize receipt for 3-1/2 years. A prize
9.30 receipt for electronic linked bingo must include the same information as is required in

 10.8 subdivision 12b.

10.9 (a) The use of any electronic pull-tab device may only be at a permitted premises
 10.10 that is:

10.11 (1) a premises licensed for the on-sale ~~or off-sale~~ of intoxicating liquor or on-sale
 10.12 3.2 percent malt beverages, ~~except for a general food store or drug store permitted to sell~~
 10.13 ~~alcoholic beverages under section 340A.405, subdivision 1;~~ or

10.14 (2) a premises where bingo is conducted as the primary business and has a seating
 10.15 capacity of at least 100; and

10.16 (3) where ~~the~~ a licensed organization sells paper pull-tabs.

10.17 (b) The number of electronic pull-tab devices is limited to:

10.18 (1) no more than six devices in play at any permitted premises with 200 seats or less;

10.19 (2) no more than 12 devices in play at any permitted premises with 201 seats
 10.20 or more; and

10.21 (3) no more than 50 devices in play at any permitted premises where the primary
 10.22 business is bingo.

10.23 Seating capacity is determined as specified under the local fire code.

10.24 (c) The hours of operation for the devices are limited to 8:00 a.m. to 2:00 a.m.

10.25 (d) All electronic pull-tab games must be sold and played on the permitted premises
 10.26 and may not be linked to other permitted premises.

10.27 (e) Electronic pull-tab games may not be transferred electronically or otherwise to
 10.28 any other location by the licensed organization.

10.29 (f) Electronic pull-tab games may be commingled if the games are from the same
 10.30 family of games and manufacturer and contain the same game name, form number, type
 10.31 of game, ticket count, prize amounts, and prize denominations. Each commingled game
 10.32 must have a unique serial number.

11.1 (g) An organization may remove from play a device that a player has not maintained
 11.2 in an activated mode for a specified period of time determined by the organization. The
 11.3 organization must provide the notice in its house rules.

11.4 (h) Before participating in the play of an electronic pull-tab game, a player must
 11.5 present ~~and register~~ a valid picture identification card that includes the player's address
 11.6 ~~and~~ date of birth.

11.7 (i) A licensed organization must require each person cashing out an electronic
 11.8 pull-tab device with \$600 or more in credits to present identification in the form of a
 11.9 driver's license, Minnesota identification card, or other identification the board deems

11.20 (a) Raffle tickets or certificates of participation at a minimum must list the three most
 11.21 expensive prizes to be awarded and include the location, date, and time of the selection
 11.22 of the winning entries. If additional prizes will be awarded, a complete list of additional

Subd. 9b. **Accounting manual.** The board must prepare and distribute to each organization licensed under this chapter a manual designed to facilitate compliance with section 349.19, subdivision 9a. The manual must include a clear description of the processes needed to maintain the records required in section 349.19, subdivision 9a. The board may contract for preparation of the manual.
