1.8	Subdivision 1. Establishment. The senior care workforce innovation grant program is
1.9	established to assist eligible applicants to fund pilot programs or expand existing programs
1.10	that increase the pool of caregivers working in the field of senior care services.
1.11	Subd. 2. Competitive grants. The commissioner shall make competitive grants available
1.12	to eligible applicants to expand the workforce for senior care services.
1.13	Subd. 3. Eligibility. (a) Eligible applicants must recruit and train individuals to work

1.15	(1) a home and community-based setting, including housing with services establishments
