[299A.477] HOMETOWN HEROES ASSISTANCE PROGRAM. 1.7 Subdivision 1. **Definitions.** (a) The definitions in this subdivision apply to this section. 1.8 (b) "Firefighter" means a volunteer, paid on-call, part-time, or full-time firefighter serving 1.9 a general population within the boundaries of the state. 1.10 (c) "Minnesota Firefighter Initiative" means a collaborative that is established by major 1.11 fire service organizations in Minnesota, is a nonprofit organization, and is tax exempt under 1.12 section 501(c)(3) of the Internal Revenue Code. 1.13 Subd. 2.
