1.9	Section 1. Minnesota Statutes 2010, section 120A.22, subdivision 11, is amended to
1.10	read:
1.11	Subd. 11. Assessment of performance. (a) Each year the performance of
1.12	every child who is not enrolled in a public school must be assessed using a nationally
1.13	norm-referenced standardized achievement examination. The superintendent of the
1.14	district in which the child receives instruction and the person in charge of the child's
1.15	instruction must agree about the specific examination to be used and the administration
1.16	and location of the examination or a nationally recognized college entrance exam.
1.17	(b) To the extent the examination in paragraph (a) does not provide assessment in
1.18	all of the subject areas in subdivision 9, the parent must assess the child's performance
1.19	in the applicable subject area. This requirement applies only to a parent who provides
1.20	instruction and does not meet the requirements of subdivision 10, clause (1), (2), or (3).
1.21	(c) If the results of the assessments in paragraphs (a) and (b) indicate that the
1.22	child's performance on the total battery score is at or below the 30th percentile or one
1.23	grade level below the performance level for children of the same age, the parent must

3.34	with the commissioner for all persons within the district receiving instruction in a home
3.35	school in compliance with sections 120A.22 and 120A.24. The parent of persons receiving

instruction in a home school shall submit the statements as required by subdivisions 1, 2, 4.1 3, and 4 to the superintendent of the district in which the person resides by October 1 of 4.2 each school year the first year of their homeschooling and the grade 7 year. 4.35 in a nonpublic school with enrollment that exceeds 15 students, the local districts or

5.1 intermediary service areas must purchase or otherwise acquire textbooks, individualized 5.2 instructional or cooperative learning materials, and standardized tests and loan or provide 5.3 them for use by children enrolled in that nonpublic school. These textbooks, individualized 5.4 instructional or cooperative learning materials, and standardized tests must be loaned or 5.5 provided free to the children for the school year for which requested.
