1.2 A bill for an act

1.3 relating to human services; establishing the Minnesota African American Family  
1.4 Preservation and Child Welfare Disproportionality Act; modifying child welfare

1.13 We, the undersigned conferees for S.F. No. 716 report that we have agreed upon the  
1.14 items in dispute and recommend as follows:

1.15 That the House recede from its amendments and that S.F. No. 716 be further amended  
1.16 as follows:

1.17 Delete everything after the enacting clause and insert:

1.18 "Section 1. [260.61] CITATION.

1.19 Sections 260.61 to 260.693 may be cited as the "Minnesota African American Family  
1.20 Preservation and Child Welfare Disproportionality Act."

1.21 EFFECTIVE DATE. This section is effective January 1, 2027, except as provided  
1.22 under section 20.

1.23 Sec. 2. [260.62] PURPOSES.

1.24 (a) The purposes of the Minnesota African American Family Preservation and Child  
1.25 Welfare Disproportionality Act are to:

2.1 (1) protect the best interests of African American and disproportionately represented  
2.2 children;

2.3 (2) promote the stability and security of African American and disproportionately  
2.4 represented children and their families by establishing minimum standards to prevent the  
2.5 arbitrary and unnecessary removal of African American and disproportionately represented  
2.6 children from their families; and

2.7 (3) improve permanency outcomes, including family reunification, for African American  
2.8 and disproportionately represented children.

2.9 (b) Nothing in this legislation is intended to interfere with the protections of the Indian  
2.10 Child Welfare Act of 1978, United States Code, title 25, sections 1901 to 1963, or the  
2.11 Minnesota Indian Family Preservation Act, sections 260.751 to 260.835. The federal Indian  
2.12 Child Welfare Act and the Minnesota Indian Family Preservation Act apply in any child  
2.13 placement proceeding, as defined in section 260.755, subdivision 3, involving an Indian  
2.14 child, as defined in section 260.755, subdivision 8.

2.15 **EFFECTIVE DATE.** This section is effective January 1, 2027, except as provided  
2.16 under section 20.

2.17 **Sec. 3. [260.63] DEFINITIONS.**

2.18 Subdivision 1. **Scope.** The definitions in this section apply to sections 260.61 to 260.693.

2.19 Subd. 2. **Active efforts.** "Active efforts" means a rigorous and concerted level of effort  
2.20 that the responsible social services agency must continuously make throughout the time  
2.21 that the responsible social services agency is involved with an African American or a  
2.22 disproportionately represented child and the child's family. To provide active efforts to  
2.23 preserve an African American or a disproportionately represented child's family, the  
2.24 responsible social services agency must continuously involve an African American or a  
2.25 disproportionately represented child's family in all services for the family, including case  
2.26 planning and choosing services and providers, and inform the family of the ability to file a  
2.27 report of noncompliance with this act with the commissioner through the child welfare  
2.28 compliance and feedback portal. When providing active efforts, a responsible social services  
2.29 agency must consider an African American or a disproportionately represented child's  
2.30 family's social and cultural values at all times while providing services to the African  
2.31 American or disproportionately represented child and the child's family. Active efforts  
2.32 includes continuous efforts to preserve an African American or a disproportionately  
2.33 represented child's family and to prevent the out-of-home placement of an African American

3.1 or a disproportionately represented child. If an African American or a disproportionately  
3.2 represented child enters out-of-home placement, the responsible social services agency must  
3.3 make active efforts to reunify the African American or disproportionately represented child  
3.4 with the child's family as soon as possible. Active efforts sets a higher standard for the  
3.5 responsible social services agency than reasonable efforts to preserve the child's family,  
3.6 prevent the child's out-of-home placement, and reunify the child with the child's family.  
3.7 Active efforts includes the provision of reasonable efforts as required by Title IV-E of the  
3.8 Social Security Act, United States Code, title 42, sections 670 to 679c.

3.9 Subd. 3. **Adoptive placement.** "Adoptive placement" means the permanent placement  
3.10 of an African American or a disproportionately represented child made by the responsible  
3.11 social services agency upon a fully executed adoption placement agreement, including the  
3.12 signatures of the adopting parent, the responsible social services agency, and the  
3.13 commissioner of human services according to section 260C.613, subdivision 1.

3.14 Subd. 4. **African American child.** "African American child" means a person under 18  
3.15 years of age having origins in Africa, including a child of two or more races who has at  
3.16 least one parent with origins in Africa. Whether a child or parent has origins in Africa is  
3.17 based upon self-identification or identification of the child's origins by the parent or guardian.

3.18 Subd. 5. **Best interests of the African American or disproportionately represented**  
3.19 **child.** The "best interests of the African American or disproportionately represented child"  
3.20 means providing a culturally informed practice lens that acknowledges, utilizes, and embraces  
3.21 the African American or disproportionately represented child's community and cultural  
3.22 norms and allows the child to remain safely at home with the child's family. The best interests  
3.23 of the African American or disproportionately represented child support the child's sense  
3.24 of belonging to the child's family, extended family, kin, and cultural community.

3.25 Subd. 6. **Child placement proceeding.** (a) "Child placement proceeding" means any  
3.26 judicial proceeding that could result in:

- 3.27 (1) an adoptive placement;  
3.28 (2) a foster care placement;  
3.29 (3) a preadoptive placement; or  
3.30 (4) a termination of parental rights.

3.31 (b) Judicial proceedings under this subdivision include a child's placement based upon  
3.32 a child's juvenile status offense but do not include a child's placement based upon:

- 3.33 (1) an act which if committed by an adult would be deemed a crime; or

4.1 (2) an award of child custody in a divorce proceeding to one of the child's parents.

4.2 Subd. 7. **Commissioner.** "Commissioner" means the commissioner of human services  
4.3 or the commissioner's designee.

4.4 Subd. 8. **Custodian.** "Custodian" means any person who is under a legal obligation to  
4.5 provide care and support for an African American or a disproportionately represented child,  
4.6 or who is in fact providing daily care and support for an African American or a  
4.7 disproportionately represented child. This subdivision does not impose a legal obligation  
4.8 upon a person who is not otherwise legally obligated to provide a child with necessary food,  
4.9 clothing, shelter, education, or medical care.

4.10 Subd. 9. **Disproportionality.** "Disproportionality" means the overrepresentation of  
4.11 African American children and other disproportionately represented children in Minnesota's  
4.12 child welfare system population as compared to the representation of those children in  
4.13 Minnesota's total child population.

4.14 Subd. 10. **Disproportionately represented child.** "Disproportionately represented child"  
4.15 means a person who is under the age of 18 and who is a member of a community whose  
4.16 race, culture, ethnicity, disability status, or low-income socioeconomic status is  
4.17 disproportionately encountered, engaged, or identified in the child welfare system as  
4.18 compared to the representation in the state's total child population, as determined on an  
4.19 annual basis by the commissioner. A child's race, culture, or ethnicity is determined based  
4.20 upon a child's self-identification or identification of a child's race, culture, or ethnicity as  
4.21 reported by the child's parent or guardian.

4.22 Subd. 11. **Egregious harm.** "Egregious harm" has the meaning given in section 260E.03,  
4.23 subdivision 5.

4.24 Subd. 12. **Foster care placement.** "Foster care placement" means the temporary  
4.25 placement of an African American or a disproportionately represented child in foster care  
4.26 as defined in section 260C.007, subdivision 18, following the court-ordered removal of the  
4.27 child when the parent or legal custodian cannot have the child returned upon demand.

4.28 Subd. 13. **Imminent physical damage or harm.** "Imminent physical damage or harm"  
4.29 means that a child is threatened with immediate and present conditions that are  
4.30 life-threatening or likely to result in abandonment, sexual abuse, or serious physical injury.  
4.31 The existence of community or family poverty, isolation, single parenthood, age of the  
4.32 parent, crowded or inadequate housing, substance use, prenatal drug or alcohol exposure,  
4.33 mental illness, disability or special needs of the parent or child, or nonconforming social  
4.34 behavior does not by itself constitute imminent physical damage or harm.

5.1 Subd. 14. **Responsible social services agency.** "Responsible social services agency"  
5.2 has the meaning given in section 260C.007, subdivision 27a.

5.3 Subd. 15. **Parent.** "Parent" means the biological parent of an African American or a  
5.4 disproportionately represented child or any person who has legally adopted an African  
5.5 American or a disproportionately represented child. Parent includes an unmarried father  
5.6 whose paternity has been acknowledged or established and a putative father. Paternity has  
5.7 been acknowledged when an unmarried father takes any action to hold himself out as the  
5.8 biological father of a child.

5.9 Subd. 16. **Preadoptive placement.** "Preadoptive placement" means a responsible social  
5.10 services agency's placement of an African American or a disproportionately represented  
5.11 child when the child is under the guardianship of the commissioner for the purpose of  
5.12 adoption but an adoptive placement agreement for the child has not been fully executed.

5.13 Subd. 17. **Relative.** "Relative" has the meaning given in section 260C.007, subdivision  
5.14 27.

5.15 Subd. 18. **Safety network.** "Safety network" means a group of individuals identified by  
5.16 the parent and child, when appropriate, that is accountable for developing, implementing,  
5.17 sustaining, supporting, or improving a safety plan to protect the safety and well-being of a  
5.18 child.

5.19 Subd. 19. **Sexual abuse.** "Sexual abuse" has the meaning given in section 260E.03,  
5.20 subdivision 20.

5.21 Subd. 20. **Termination of parental rights.** "Termination of parental rights" means an  
5.22 action resulting in the termination of the parent-child relationship under section 260C.301.

5.23 **EFFECTIVE DATE.** This section is effective January 1, 2027, except as provided  
5.24 under section 20.

5.25 Sec. 4. **[260.64] DUTY TO PREVENT OUT-OF-HOME PLACEMENT AND**  
5.26 **PROMOTE FAMILY REUNIFICATION.**

5.27 Subdivision 1. **Active efforts.** A responsible social services agency shall make active  
5.28 efforts to prevent the out-of-home placement of an African American or a disproportionately  
5.29 represented child, eliminate the need for a child's removal from the child's home, and reunify  
5.30 an African American or a disproportionately represented child with the child's family as  
5.31 soon as practicable.

6.1 Subd. 2. **Safety plan.** (a) Prior to petitioning the court to remove an African American  
6.2 or a disproportionately represented child from the child's home under section 260.66, a  
6.3 responsible social services agency must work with the child's family to allow the child to  
6.4 remain in the child's home while implementing a safety plan based on the family's needs.  
6.5 The responsible social services agency must:

6.6 (1) make active efforts to engage the child's parent or custodian and the child, when  
6.7 appropriate;

6.8 (2) assess the family's cultural and economic needs and, if applicable, needs and services  
6.9 related to the child's disability;

6.10 (3) hold a family group consultation meeting and connect the family with supports to  
6.11 establish a safety network for the family; and

6.12 (4) provide support, guidance, and input to assist the family and the family's safety  
6.13 network with developing the safety plan.

6.14 (b) The safety plan must:

6.15 (1) address the specific allegations impacting the child's safety in the home. If neglect  
6.16 is alleged, the safety plan must incorporate economic services and supports for the child  
6.17 and the child's family, if eligible, to address the family's specific needs and prevent neglect;

6.18 (2) incorporate family and community support to ensure the child's safety while keeping  
6.19 the family intact; and

6.20 (3) be adjusted as needed to address the child's and family's ongoing needs and support.

6.21 (c) The responsible social services agency is not required to establish a safety plan:

6.22 (1) in a case with allegations of sexual abuse or egregious harm;

6.23 (2) when the parent is not willing to follow a safety plan;

6.24 (3) when the parent has abandoned the child or is unavailable to follow a safety plan;

6.25 or

6.26 (4) when the parent has chronic substance use disorder issues and is unable to parent  
6.27 the child.

6.28 Subd. 3. **Out-of-home placement prohibited.** Unless the court finds by clear and  
6.29 convincing evidence that the child would be at risk of serious emotional damage or serious  
6.30 physical damage if the child were to remain in the child's home, a court shall not order a  
6.31 foster care or permanent out-of-home placement of an African American or a

7.1 disproportionately represented child alleged to be in need of protection or services. At each  
7.2 hearing regarding an African American or a disproportionately represented child who is  
7.3 alleged or adjudicated to be in need of child protective services, the court shall review  
7.4 whether the responsible social services agency has provided active efforts to the child and  
7.5 the child's family and shall require the responsible social services agency to provide evidence  
7.6 and documentation that demonstrate that the agency is providing culturally informed,  
7.7 strength-based, community-involved, and community-based services to the child and the  
7.8 child's family.

7.9 Subd. 4. **Required findings that active efforts were provided.** When determining  
7.10 whether the responsible social services agency has made active efforts to preserve the child's  
7.11 family, the court shall make findings regarding whether the responsible social services  
7.12 agency made appropriate and meaningful services available to the child's family based upon  
7.13 the family's specific needs. If a court determines that the responsible social services agency  
7.14 did not make active efforts to preserve the family as required by this section, the court shall  
7.15 order the responsible social services agency to immediately provide active efforts to the  
7.16 child and child's family to preserve the family.

7.17 **EFFECTIVE DATE.** This section is effective January 1, 2027, except as provided  
7.18 under section 20.

7.19 Sec. 5. **[260.641] ENSURING FREQUENT VISITATION FOR AFRICAN**  
7.20 **AMERICAN AND DISPROPORTIONATELY REPRESENTED CHILDREN IN**  
7.21 **OUT-OF-HOME PLACEMENT.**

7.22 A responsible social services agency must engage in best practices related to visitation  
7.23 when an African American or a disproportionately represented child is in out-of-home  
7.24 placement. When the child is in out-of-home placement, the responsible social services  
7.25 agency shall make active efforts to facilitate regular and frequent visitation between the  
7.26 child and the child's parents or custodians, the child's siblings, and the child's relatives. If  
7.27 visitation is infrequent between the child and the child's parents, custodians, siblings, or  
7.28 relatives, the responsible social services agency shall make active efforts to increase the  
7.29 frequency of visitation and address any barriers to visitation.

7.30 **EFFECTIVE DATE.** This section is effective January 1, 2027, except as provided  
7.31 under section 20.

8.1        **Sec. 6. [260.65] NONCUSTODIAL PARENTS; RELATIVE PLACEMENT.**

8.2        (a) Prior to the removal of an African American or a disproportionately represented child  
8.3 from the child's home, the responsible social services agency must make active efforts to  
8.4 identify and locate the child's noncustodial or nonadjudicated parent and the child's relatives  
8.5 to notify the child's parent and relatives that the child is or will be placed in foster care, and  
8.6 provide the child's parent and relatives with a list of legal resources. The notice to the child's  
8.7 noncustodial or nonadjudicated parent and relatives must also include the information  
8.8 required under section 260C.221, subdivision 2, paragraph (b). The responsible social  
8.9 services agency must maintain detailed records of the agency's efforts to notify parents and  
8.10 relatives under this section.

8.11       (b) Notwithstanding the provisions of section 260C.219, the responsible social services  
8.12 agency must assess an African American or a disproportionately represented child's  
8.13 noncustodial or nonadjudicated parent's ability to care for the child before placing the child  
8.14 in foster care. If a child's noncustodial or nonadjudicated parent is willing and able to provide  
8.15 daily care for the African American or disproportionately represented child temporarily or  
8.16 permanently, the court shall order that the child be placed in the home of the noncustodial  
8.17 or nonadjudicated parent pursuant to section 260C.178 or 260C.201, subdivision 1. The  
8.18 responsible social services agency must make active efforts to assist a noncustodial or  
8.19 nonadjudicated parent with remedying any issues that may prevent the child from being  
8.20 placed with the noncustodial or nonadjudicated parent.

8.21       (c) The relative search, notice, engagement, and placement consideration requirements  
8.22 under section 260C.221 apply under this act.

8.23       **EFFECTIVE DATE.** This section is effective January 1, 2027, except as provided  
8.24 under section 20.

8.25       **Sec. 7. [260.66] EMERGENCY REMOVAL.**

8.26       Subdivision 1. **Emergency removal or placement permitted.** Nothing in this section  
8.27 shall be construed to prevent the emergency removal of an African American or a  
8.28 disproportionately represented child's parent or custodian or the emergency placement of  
8.29 the child in a foster setting in order to prevent imminent physical damage or harm to the  
8.30 child.

8.31       Subd. 2. **Petition for emergency removal; placement requirements.** A petition for a  
8.32 court order authorizing the emergency removal or continued emergency placement of an  
8.33 African American or a disproportionately represented child or the petition's accompanying



9.1 documents must contain a statement of the risk of imminent physical damage or harm to  
9.2 the African American or disproportionately represented child and any evidence that the  
9.3 emergency removal or placement continues to be necessary to prevent imminent physical  
9.4 damage or harm to the child. The petition or its accompanying documents must also contain  
9.5 the following information:

9.6 (1) the name, age, and last known address of the child;

9.7 (2) the name and address of the child's parents and custodians or, if unknown, a detailed  
9.8 explanation of efforts made to locate and contact them;

9.9 (3) the steps taken to provide notice to the child's parents and custodians about the  
9.10 emergency proceeding;

9.11 (4) a specific and detailed account of the circumstances that led the agency responsible  
9.12 for the emergency removal of the child to take that action; and

9.13 (5) a statement of the efforts that have been taken to assist the child's parents or custodians  
9.14 so that the child may safely be returned to their custody.

9.15 Subd. 3. **Emergency proceeding requirements.** (a) The court shall hold a hearing no  
9.16 later than 72 hours, excluding weekends and holidays, after the emergency removal of the  
9.17 African American or disproportionately represented child. The court shall determine whether  
9.18 the emergency removal continues to be necessary to prevent imminent physical damage or  
9.19 harm to the child and whether, after considering the child's particular circumstances, the  
9.20 imminent physical damage or harm to the child outweighs the harm that the child will  
9.21 experience as a result of continuing the emergency removal.

9.22 (b) The court shall hold additional hearings whenever new information indicates that  
9.23 the emergency situation has ended. The court shall consider all such new information at  
9.24 any court hearing after the emergency proceeding to determine whether the emergency  
9.25 removal or placement is no longer necessary to prevent imminent physical damage or harm  
9.26 to the child.

9.27 (c) Notwithstanding section 260C.163, subdivision 3, and the provisions of Minnesota  
9.28 Rules of Juvenile Protection Procedure, rule 25, a parent or custodian of an African American  
9.29 or a disproportionately represented child who is subject to an emergency hearing under this  
9.30 section and Minnesota Rules of Juvenile Protection Procedure, rule 30, has a right to counsel  
9.31 appointed by the court. The court must appoint qualified counsel to represent a parent if the  
9.32 parent meets the eligibility requirements in section 611.17.

10.1 Subd. 4. Termination of emergency removal or placement. (a) An emergency removal  
10.2 or placement of an African American or a disproportionately represented child must  
10.3 immediately terminate once the responsible social services agency or court possesses  
10.4 sufficient evidence to determine that the emergency removal or placement is no longer  
10.5 necessary to prevent imminent physical damage or harm to the child and the child shall be  
10.6 immediately returned to the custody of the child's parent or custodian. The responsible social  
10.7 services agency or court shall ensure that the emergency removal or placement terminates  
10.8 immediately when the removal or placement is no longer necessary to prevent imminent  
10.9 physical damage or harm to the African American or disproportionately represented child.

10.10 (b) An emergency removal or placement ends when the court orders, after service upon  
10.11 the African American or disproportionately represented child's parents or custodians, that  
10.12 the child shall be placed in foster care upon a determination supported by clear and  
10.13 convincing evidence that custody of the child by the child's parent or custodian is likely to  
10.14 result in serious emotional or physical damage to the child.

10.15 (c) In no instance shall emergency removal or emergency placement of an African  
10.16 American or a disproportionately represented child extend beyond 30 days unless the court  
10.17 finds by a showing of clear and convincing evidence that:

10.18 (1) continued emergency removal or placement is necessary to prevent imminent physical  
10.19 damage or harm to the child; and

10.20 (2) it has not been possible to initiate a child placement proceeding with all of the  
10.21 protections under sections 260.61 to 260.68.

10.22 **EFFECTIVE DATE.** This section is effective January 1, 2027, except as provided  
10.23 under section 20.

10.24 Sec. 8. **[260.67] TRANSFER OF PERMANENT LEGAL AND PHYSICAL**  
10.25 **CUSTODY; TERMINATION OF PARENTAL RIGHTS; CHILD PLACEMENT**  
10.26 **PROCEEDINGS.**

10.27 Subdivision 1. **Preference for permanency placement with a relative.** Consistent with  
10.28 section 260C.513, if an African American or disproportionately represented child cannot  
10.29 be returned to the child's parent, permanency placement with a relative is preferred. The  
10.30 court shall consider the requirements of and responsibilities under section 260.012, paragraph  
10.31 (a), and, if possible and if requirements under section 260C.515, subdivision 4, are met,  
10.32 transfer permanent legal and physical custody of the child to:

11.1 (1) a noncustodial parent under section 260C.515, subdivision 4, if the child cannot  
11.2 return to the care of the parent or custodian from whom the child was removed or who had  
11.3 legal custody at the time that the child was placed in foster care; or

11.4 (2) a willing and able relative, according to the requirements of section 260C.515,  
11.5 subdivision 4. When the responsible social services agency is the petitioner, prior to the  
11.6 court ordering a transfer of permanent legal and physical custody to a relative, the responsible  
11.7 social services agency must inform the relative of Northstar kinship assistance benefits and  
11.8 eligibility requirements and of the relative's ability to apply for benefits on behalf of the  
11.9 child under chapter 256N.

11.10 Subd. 2. **Termination of parental rights restrictions.** (a) A court shall not terminate  
11.11 the parental rights of a parent of an African American or a disproportionately represented  
11.12 child based solely on the parent's failure to complete case plan requirements.

11.13 (b) Except as provided in paragraph (c), a court shall not terminate the parental rights  
11.14 of a parent of an African American or a disproportionately represented child in a child  
11.15 placement proceeding unless the allegations against the parent involve sexual abuse;  
11.16 egregious harm as defined in section 260C.007, subdivision 14; murder in the first, second,  
11.17 or third degree under section 609.185, 609.19, or 609.195; murder of an unborn child in the  
11.18 first, second, or third degree under section 609.2661, 609.2662, or 609.2663; manslaughter  
11.19 of an unborn child in the first or second degree under section 609.2664 or 609.2665; domestic  
11.20 assault by strangulation under section 609.2247; felony domestic assault under section  
11.21 609.2242 or 609.2243; kidnapping under section 609.25; solicitation, inducement, and  
11.22 promotion of prostitution under section 609.322, subdivision 1, and subdivision 1a if one  
11.23 or more aggravating factors are present; criminal sexual conduct under sections 609.342 to  
11.24 609.3451; engaging in, hiring, or agreeing to hire a minor to engage in prostitution under  
11.25 section 609.324, subdivision 1; solicitation of children to engage in sexual conduct under  
11.26 section 609.352; possession of pornographic work involving minors under section 617.247;  
11.27 malicious punishment or neglect or endangerment of a child under section 609.377 or  
11.28 609.378; use of a minor in sexual performance under section 617.246; or failing to protect  
11.29 a child from an overt act or condition that constitutes egregious harm.

11.30 Subd. 3. **Termination of parental rights; exceptions.** (a) The court may terminate the  
11.31 parental rights of a parent of an African American or a disproportionately represented child  
11.32 if a transfer of permanent legal and physical custody under subdivision 1 is not possible  
11.33 because the child has no willing or able noncustodial parent or relative to whom custody  
11.34 can be transferred, if it finds that one or more of the following conditions exist:

12.1 (1) that the parent has abandoned the child;

12.2 (2) that a parent is palpably unfit to be a party to the parent and child relationship because  
12.3 of a consistent pattern of specific conduct before the child or of specific conditions directly  
12.4 relating to the parent and child relationship, either of which are determined by the court to  
12.5 be of a duration or nature that renders the parent unable, for the reasonably foreseeable  
12.6 future, to care appropriately for the ongoing physical, mental, or emotional needs of the  
12.7 child;

12.8 (3) that following the child's placement out of the home, active efforts, under the direction  
12.9 of the court, have failed to correct the conditions leading to the child's placement. It is  
12.10 presumed that active efforts under this clause have failed upon a showing that:

12.11 (i) a child has resided out of the parental home under court order for a cumulative period  
12.12 of 12 months within the preceding 22 months. In the case of a child under age eight at the

24.8 **Sec. 19. DIRECTION TO COMMISSIONER; COMPLIANCE SYSTEM REVIEW**  
24.9 **DEVELOPMENT.**

24.10 (a) By January 1, 2026, the commissioner of human services, in consultation with counties  
24.11 and the working group established under section 21, must develop a system to review county  
24.12 compliance with the Minnesota African American Family Preservation and Child Welfare  
24.13 Disproportionality Act. The system may include but is not limited to the cases to be reviewed,  
24.14 the criteria to be reviewed to demonstrate compliance, the rate of noncompliance and the  
24.15 coordinating penalty, the program improvement plan, and training.

24.16 (b) By January 1, 2026, the commissioner of human services must provide a report to

24.23 (a) The commissioner of human services must establish a phase-in program that  
24.24 implements sections 1 to 17 in Hennepin and Ramsey Counties. The commissioner may  
24.25 allow additional counties to participate in the phase-in program upon the request of the  
24.26 counties.

24.27 (b) The commissioner of human services must report on the outcomes of the phase-in  
24.28 program, including the number of participating families, the rate of children in out-of-home  
24.29 placement, and the measures taken to prevent out-of-home placement for each participating  
24.30 family, to the chairs and ranking minority members of the legislative committees with  
24.31 jurisdiction over child welfare.

25.8 (a) The commissioner of human services must establish a working group to provide  
25.9 guidance and oversight for the Minnesota African American Family Preservation and Child  
25.10 Welfare Disproportionality Act phase-in program.

25.11 (b) The members of the working group must include representatives from the Minnesota  
25.12 Association of County Social Service Administrators, the Association of Minnesota Counties,  
25.13 the Minnesota Inter-County Association, the Minnesota County Attorneys Association,  
25.14 Hennepin County, Ramsey County, the Department of Human Services, and community  
25.15 organizations with experience in child welfare. The legislature may provide recommendations  
25.16 to the commissioner on the selection of the representatives from the community organizations.

25.17 (c) The working group must provide oversight of the phase-in program and evaluate the

26.4 commissioner of human services for grants to Hennepin and Ramsey Counties to implement  
26.5 the Minnesota African American Family Preservation and Child Welfare Disproportionality  
26.6 Act phase-in program. Of this amount, \$2,500,000 must be provided to Hennepin County  
26.7 and \$2,500,000 must be provided to Ramsey County. This is a onetime appropriation and

26.17 fiscal year 2026 and \$3,110,000 in fiscal year 2027."
