1.8	Subd. 6. Grants. (a) The commissioner of mediation services may make grants					
1.9	to private nonprofit entities that assist in resolution of disputes. The commissioner					
1.10	shall establish a grant review committee to assist the commissioner in review of grant					
1.11	applications under this subdivision.					
1.12	(b) To be eligible for a grant under this subdivision, a nonprofit organization must					
1.13	meet the requirements of section 494.05, subdivision 1, clauses (1), (2), (4), and (5).					
1.14	(c) A grant agreement may include performance-based standards that apply to a					
1.15	specified percentage of the potential grant amount. A grant may include a requirement for					
1.16	a matching contribution from a nonstate source.					
1.17	(d) A nonprofit entity receiving a grant must, as a condition of the grant, agree to					
1.18	comply with guidelines adopted by the state court administrator under section 494.015,
