10.9 certificates and special license plates issued to physically disabled persons;

10.10 (2) other data on holders of a disability certificate under section 169.345, except that (i)
10.11 data that are not medical data may be released to law enforcement agencies, and (ii) data
10.12 necessary for enforcement of sections 169.345 and 169.346 may be released to parking
10.13 enforcement employees or parking enforcement agents of statutory or home rule charter
10.14 cities and towns;

10.15 (3) Social Security numbers in driver's license and motor vehicle registration records,
10.16 except that Social Security numbers must be provided to the Department of Revenue for
10.17 purposes of tax administration, the Department of Labor and Industry for purposes of
10.18 workers' compensation administration and enforcement, the judicial branch for purposes of
10.19 debt collection, and the Department of Natural Resources for purposes of license application
10.20 administration; and

10.27 the need to care for a child of the license holder.

10.29 and must not sell or otherwise provide individual Social Security numbers or lists of Social
10.30 Security numbers for any other purpose.

11.8 (i) the issue is a denial of a current year application for the homestead classification for
