1.5	Section 1. [168.1287] CANCER AWARENESS PLATES.
1.6	Subdivision 1. Issuance of plates. The commissioner must issue cancer awareness
1.7	special plates or a single motorcycle plate to an applicant who:
1.8	(1) is a registered owner of a passenger automobile, noncommercial one-ton pickup
1.9	truck, motorcycle, or recreational motor vehicle;
1.10	(2) pays the registration tax as required under section 168.013;
1.11	(3) pays a fee in the amount specified under section 168.12, subdivision 5, for each set
1.12	of plates, along with any other fees required by this chapter;

2.6	established in the special revenue fund. Money in the account is annually appropriated to
2.7	the commissioner. This appropriation is first for the annual cost of administering the account
2.8	funds, and the remaining funds are for distribution to organizations in Minnesota dedicated
2.9	to cancer awareness and advocacy to further their missions in this state.
