1.6	WHEREAS, BNSF Railway Company and Canadian Pacific railroad each own track that
1.7	intersects in the city of Crystal, Minnesota, and have commenced a project to construct connector
1.8	track at the site of the intersection; and
1.9	WHEREAS, such railroad connector track allows alternative routing of unit trains having a
1.10	total length of over one mile and carrying volatile oil products currently transported through the
1.11	Twin Cities metropolitan area; and
1.12	WHEREAS, resulting rerouting due to new railroad connector track provides a new
1.13	transportation route for unit trains carrying volatile oil products, which poses numerous
1.14	potentially negative safety and environmental effects in several cities, including Crystal, Golden
1.15	Valley, Minneapolis, New Hope, and Robbinsdale; and
1.16	WHEREAS, such effects include potential blockage of multiple adjacent at-grade
1.17	highway-rail crossings by a single unit train in the cities of Crystal and Robbinsdale, which
1.18	can result in (1) drastically reduced response capabilities of emergency first responders such as
1.19	firefighters and police due to long diversion of route, and (2) congestion; and
1.20	WHEREAS, such effects also include passage of unit trains directly adjacent to
1.21	environmentally sensitive areas including parks, trails, and wetlands; and
1.22	WHEREAS, such effects also include noise and safety impacts to residences and businesses
