1.35 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

ARTICLE 1

GENERAL EDUCATION

Section 1. Minnesota Statutes 2010, section 11A.16, subdivision 5, is amended to read:

Subd. 5. **Calculation of income.** As of the end of each fiscal year, the state board shall calculate the investment income earned by the permanent school fund. The investment income earned by the fund shall equal the amount of interest on debt securities ~~and~~ dividends on equity securities, and interest earned on certified monthly earnings prior to the transfer to the Department of Education. Gains and losses arising from the sale of securities shall be apportioned as follows:

(a) If the sale of securities results in a net gain during a fiscal year, the gain shall be apportioned in equal installments over the next ten fiscal years to offset net losses in those years. If any portion of an installment is not needed to recover subsequent losses identified in paragraph (b) it shall be added to the principal of the fund.

(b) If the sale of securities results in a net loss during a fiscal year, the net loss shall be recovered first from the gains in paragraph (a) apportioned to that fiscal year. If these gains are insufficient, any remaining net loss shall be recovered from interest and dividend income in equal installments over the following ten fiscal years.

EFFECTIVE DATE. This section is effective the day following final enactment.

Sec. 2. Minnesota Statutes 2010, section 120A.22, subdivision 11, is amended to read:

Subd. 11. **Assessment of performance.** (a) Each year the performance of every child who is not enrolled in a public school must be assessed using a nationally norm-referenced standardized achievement examination. ~~The superintendent of the district in which the child receives instruction and the person in charge of the child's instruction must agree about the specific examination to be used and the administration and location of the examination~~ or a nationally recognized college entrance exam.

~~(b) To the extent the examination in paragraph (a) does not provide assessment in all of the subject areas in subdivision 9, the parent must assess the child's performance in the applicable subject area. This requirement applies only to a parent who provides instruction and does not meet the requirements of subdivision 10, clause (1), (2), or (3).~~

~~(c) If the results of the assessments in paragraphs (a) and (b) indicate that the child's performance on the total battery score is at or below the 30th percentile or one grade level below the performance level for children of the same age, the parent must obtain additional evaluation of the child's abilities and performance for the purpose of determining whether the child has learning problems.~~

3.1 ~~(d)~~ (b) A child receiving instruction from a nonpublic school, person, or institution
3.2 that is accredited by an accrediting agency, recognized according to section 123B.445, or
3.3 recognized by the commissioner, is exempt from the requirements of this subdivision.

3.6 Subdivision 1. **Reports to superintendent.** (a) The person in charge of providing

3.8 district in which the child resides the name, birth date, and address of the child; the annual
3.9 tests intended to be used under section 120A.22, subdivision 11, if required; the name of
3.10 each instructor; and evidence of compliance with one of the requirements specified in
3.11 section 120A.22, subdivision 10:

3.12 (1) by October 1 of ~~each~~ the first school year, ~~the name, birth date, and address~~
3.13 ~~of each child receiving instruction~~ the child receives instruction after reaching the age

3.28 any changes to the information required in paragraph (a) for each student.

3.29 (c) The superintendent may collect the required information under this section
3.30 through an electronic or Web-based format, but must not require electronic submission
3.31 of information under this section from the person in charge of reporting under this
3.32 subdivision.

3.33 Subd. 2. **Availability of documentation.** (a) The person in charge of providing
3.34 instruction to a child must ~~make available~~ maintain documentation indicating that the
3.35 subjects required in section 120A.22, subdivision 9, are being taught and proof that the

4.1 tests under section 120A.22, subdivision 11, have been administered. This documentation
4.2 must include class schedules, copies of materials used for instruction, and descriptions of
4.3 methods used to assess student achievement.

4.4 (b) The parent of a child who enrolls full time in public school after having been
4.5 enrolled in a home school under section 120A.22, subdivision 6, must provide the
4.6 enrolling public school or school district with the child's scores on any tests administered
4.7 to the child under section 120A.22, subdivision 11, and other education-related documents
4.8 the enrolling school or district requires to determine where the child is placed in school
4.9 and what course requirements apply. This paragraph does not apply to a shared time
4.10 student who does not seek a public school diploma.

4.11 (c) The person in charge of providing instruction to a child must make the
4.12 documentation in this subdivision available to the county attorney when a case is
4.13 commenced under section 120A.26, subdivision 5; chapter 260C; or when diverted under
4.14 chapter 260A.

4.15 Subd. 3. **Exemptions.** A nonpublic school, person, or other institution that is
4.16 accredited by an accrediting agency, recognized according to section 123B.445, or
4.17 recognized by the commissioner, is exempt from the requirements in ~~subdivisions 1 and~~
4.18 ~~subdivision 2, except for the requirement in subdivision 1, clause (1).~~

4.19 Subd. 4. **Reports to the state.** A superintendent must make an annual report to the
4.20 commissioner of education by December 1 of the total number of nonpublic children
4.21 reported as residing in the district. ~~The report must include the following information:~~

4.22 ~~(1) the number of children residing in the district attending nonpublic schools or~~
4.23 ~~receiving instruction from persons or institutions other than a public school;~~

4.31 **120B.07 EARLY GRADUATION.**

4.32 (a) Notwithstanding any law to the contrary, any secondary school student who has
4.33 completed all required courses or standards may, with the approval of the student, the
4.34 student's parent or guardian, and local school officials, graduate before the completion
4.35 of the school year.

5.1 (b) General education revenue attributable to the student must be paid as though the
5.2 student was in attendance for the entire year unless the student participates in the early
5.3 graduation achievement scholarship program under section 120B.08.

5.4 **EFFECTIVE DATE.** This section is effective July 1, 2011.

5.5 Sec. 5. **[120B.08] EARLY GRADUATION ACHIEVEMENT SCHOLARSHIP**
5.6 **PROGRAM.**

5.7 Subdivision 1. **Participation.** A student who qualifies for early graduation under
5.8 section 120B.07 is eligible to participate in the early graduation achievement scholarship
5.9 program.

5.10 Subd. 2. **Scholarship amounts.** A student who participates in the early graduation
5.11 achievement scholarship program is eligible for a scholarship of \$2,500 if the student
5.12 qualifies for graduation one semester or two trimesters early, \$5,000 if the student qualifies
5.13 for graduation two semesters or three or four trimesters early, or \$7,500 if the student
5.14 qualifies for graduation three or more semesters or five or more trimesters early.

5.15 Subd. 3. **Scholarship uses.** An early graduation achievement scholarship may be
5.16 used at any accredited institution of higher education.

5.17 Subd. 4. **Application.** A qualifying student may apply to the commissioner of
5.18 education for an early graduation achievement scholarship. The application must be in
5.19 the form and manner specified by the commissioner. Upon verification of the qualifying
5.20 student's course completion necessary for graduation, the department must issue the
5.21 student a certificate showing the student's scholarship amount.

5.22 Subd. 5. **Enrollment verification.** A student who qualifies under this section
5.23 and enrolls in an accredited higher education institution must submit a form to the
5.24 commissioner verifying the student's enrollment in the higher education institution and the
5.25 tuition charges for that semester. Within 15 days of receipt of a student's enrollment and
5.26 tuition verification form, the commissioner must issue a scholarship check to the student in
5.27 the lesser of the tuition amount for that semester or the maximum amount of the student's
5.28 early graduation achievement scholarship. A student may continue to submit enrollment
5.29 verification forms to the commissioner until the student has used the full amount of the
5.30 student's graduation achievement scholarship.

5.31 Subd. 6. **General education money transferred.** The commissioner must transfer
5.32 the amounts necessary to fund the early graduation achievement scholarships from the
5.33 general education aid appropriation for that year.

5.34 **EFFECTIVE DATE.** This section is effective for fiscal year 2012 and later.

6.1 Sec. 6. Minnesota Statutes 2010, section 121A.15, subdivision 8, is amended to read:

6.2 Subd. 8. **Report.** The administrator or other person having general control and
6.3 supervision of the elementary or secondary school shall file a report with the commissioner
6.4 on all persons enrolled in the school. The superintendent of each district shall file a report
6.5 with the commissioner for all persons within the district receiving instruction in a home
6.6 school in compliance with sections 120A.22 and 120A.24. The parent of persons receiving
6.7 instruction in a home school shall submit the statements as required by subdivisions 1, 2,
6.8 3, ~~and 4, and 12~~ to the superintendent of the district in which the person resides by October
6.9 1 of ~~each school year~~ the first year of their homeschooling in Minnesota and the grade 7
6.10 year. The school report must be prepared on forms developed jointly by the commissioner
6.11 of health and the commissioner of education and be distributed to the local districts by the
6.12 commissioner of health. The school report must state the number of persons attending the
6.13 school, the number of persons who have not been immunized according to subdivision 1 or
6.14 2, and the number of persons who received an exemption under subdivision 3, clause (c)
6.15 or (d). The school report must be filed with the commissioner of education within 60 days
6.16 of the commencement of each new school term. Upon request, a district must be given a
6.17 60-day extension for filing the school report. The commissioner of education shall forward
6.18 the report, or a copy thereof, to the commissioner of health who shall provide summary
6.19 reports to boards of health as defined in section 145A.02, subdivision 2. The administrator
6.20 or other person having general control and supervision of the child care facility shall file a
6.21 report with the commissioner of human services on all persons enrolled in the child care
6.22 facility. The child care facility report must be prepared on forms developed jointly by
6.23 the commissioner of health and the commissioner of human services and be distributed
6.24 to child care facilities by the commissioner of health. The child care facility report
6.25 must state the number of persons enrolled in the facility, the number of persons with no
6.26 immunizations, the number of persons who received an exemption under subdivision 3,
6.27 clause (c) or (d), and the number of persons with partial or full immunization histories.
6.28 The child care facility report must be filed with the commissioner of human services by
6.29 November 1 of each year. The commissioner of human services shall forward the report,
6.30 or a copy thereof, to the commissioner of health who shall provide summary reports to
6.31 boards of health as defined in section 145A.02, subdivision 2. The report required by this
6.32 subdivision is not required of a family child care or group family child care facility, for
6.33 prekindergarten children enrolled in any elementary or secondary school provided services
6.34 according to sections 125A.05 and 125A.06, nor for child care facilities in which at least
6.35 75 percent of children in the facility participate on a onetime only or occasional basis to a
6.36 maximum of 45 hours per child, per month.

7.1 Sec. 7. Minnesota Statutes 2010, section 123B.42, subdivision 1, is amended to read:

7.2 Subdivision 1. **Providing education materials and tests.** The commissioner of
7.3 education shall promulgate rules under the provisions of chapter 14 requiring that in
7.4 each school year, based upon formal requests by or on behalf of nonpublic school pupils
7.5 in a nonpublic school with enrollment that exceeds ten students, the local districts or
7.6 intermediary service areas must purchase or otherwise acquire textbooks, individualized
7.7 instructional or cooperative learning materials, and standardized tests and loan or provide
7.8 them for use by children enrolled in that nonpublic school. These textbooks, individualized
7.9 instructional or cooperative learning materials, and standardized tests must be loaned or
7.10 provided free to the children for the school year for which requested. The loan or provision
7.11 of the textbooks, individualized instructional or cooperative learning materials, and

7.14 Subdivision 1. **Provided services.** The commissioner of education shall promulgate
7.15 rules under the provisions of chapter 14 requiring each district or other intermediary
7.16 service area: (a) to provide each year upon formal request by a specific date by or on
7.17 behalf of a nonpublic school pupil enrolled in a nonpublic school located in that district or
7.18 area with a total enrollment of more than ten pupils, the same specific health services as
7.19 are provided for public school pupils by the district where the nonpublic school is located;
7.20 and (b) to provide each year upon formal request by a specific date by or on behalf of a
7.21 nonpublic school secondary pupil enrolled in a nonpublic school located in that district

8.1 Subd. 2. **Pupil of limited English proficiency.** (a) "Pupil of limited English
8.2 proficiency" means a pupil in kindergarten through grade 12 who meets the following
8.3 requirements:

8.4 (1) the pupil, as declared by a parent or guardian first learned a language other than
8.5 English, comes from a home where the language usually spoken is other than English, or
8.6 usually speaks a language other than English; and

8.7 (2) the pupil is determined by developmentally appropriate measures, which might
8.8 include observations, teacher judgment, parent recommendations, or developmentally
8.9 appropriate assessment instruments, to lack the necessary English skills to participate
8.10 fully in classes taught in English.

9.7 section 126C.05, subdivision 3. Revenue shall be paid to the district and must be allocated
9.8 according to section 126C.15, subdivision 2.

10.5 (2) the secondary average daily membership of pupils served in the high school,
