1.7	Section 1. Minnesota Statutes 2018, section 62A.671, subdivision 6, is amended to read:
1.8	Subd. 6. Licensed health care provider. "Licensed health care provider" means a health
1.9	care provider who is:
1.10	(1) licensed under chapter 147, 147A, 148, 148B, 148E, 148F, 150A, or 153; a mental
1.11	health professional as defined under section 245.462, subdivision 18, or 245.4871,
1.12	subdivision 27; a community health worker meeting the criteria specified in section
1.13	256B.0625, subdivision 49, paragraph (a); or vendor of medical care defined in section
1.14	256B.02, subdivision 7; and
1.15	(2) authorized within their respective scope of practice to provide the particular service
1.16	with no supervision or under general supervision.

1.18	Subd. 3b. Telemedicine services. (a) Medical assistance covers medically necessary

1.22	in paragraph (f). Telemedicine services shall be paid at the full allowable rate.

2.1	(b) The commissioner shall establish criteria that a health care provider must attest to
2.2	in order to demonstrate the safety or efficacy of delivering a particular service via
2.3	telemedicine. The attestation may include that the health care provider:
2.4	(1) has identified the categories or types of services the health care provider will provide
2.5	via telemedicine;
2.6	(2) has written policies and procedures specific to telemedicine services that are regularly
2.7	reviewed and updated;
2.8	(3) has policies and procedures that adequately address patient safety before, during,
2.9	and after the telemedicine service is rendered;
2.10	(4) has established protocols addressing how and when to discontinue telemedicine
