BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA: 1.4 Section 1. Minnesota Statutes 2018, section 169.011, subdivision 94, is amended to read: 1.5 Subd. 94. Wireless communications device. "Wireless communications device" means 1.6 (1) a cellular phone, or (2) a portable electronic device that is capable of receiving and transmitting data, including but not limited to text messages and e-mail, without an access 1.8 1.9 line for service. A wireless communications device does not include a device that is permanently affixed to the vehicle, or a global positioning system or navigation system 1 10 when the system is used exclusively for navigation purposes that is physically integrated 1.11 into the vehicle. 1.12 Sec. 2. of a cellular phone that is temporarily affixed to the vehicle to listen to audio-based content.
