(a) In addition to the taxes imposed under 1.7 subdivision 1, a tax is imposed on the combined net receipts of the organization. As used 18 in this section, "combined net receipts" is the sum of the organization's gross receipts from 19 lawful gambling less gross receipts directly derived from the conduct of paper bingo, raffles, 1.10 and paddlewheels, as defined in section 297E.01, subdivision 8, and less the net prizes 1.11 actually paid, other than prizes actually paid for paper bingo, raffles, and paddlewheels, and 1.12 less the amounts actually expended for lawful purpose contributions under section 349.12, 1.13 subdivision 25, paragraph (a), clauses (1) to (7) and (9) to (26), for the fiscal year. (b) On or before April 1, 2016, the commissioner shall estimate the total amount of revenue, including interest and penalties, that will be collected for fiscal year 2016 from taxes imposed under this chapter. If the amount estimated by the commissioner equals or exceeds \$94,800,000, the commissioner shall certify that effective July 1, 2016, the rates under this paragraph apply in lieu of the rates under paragraph (a) and shall publish a notice to that effect in the State Register and notify each taxpayer by June 1, 2016. (e) (b) Gross receipts derived from sports-themed tipboards are exempt from taxation under this section. For purposes of this paragraph, a sports-themed tipboard means a sports-themed tipboard as defined in section 349.12, subdivision 34, under which the winning numbers are determined by the numerical outcome of a professional sporting event.
