BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

- 1.5 Section 1. Minnesota Statutes 2018, section 290.0685, subdivision 1, is amended to read:
- Subdivision 1. **Credit allowed.** (a) An <u>eligible</u> individual is allowed a credit against the tax imposed by this chapter equal to \$2,000 for each <u>birth</u> for which a certificate of birth resulting in stillbirth has been issued under section 144.2151 stillbirth. The credit under this section is allowed only in the taxable year in which the stillbirth occurred and if the child would have been a dependent of the taxpayer as defined in section 152 of the Internal Revenue Code.
- (b) For a nonresident or part-year resident, the credit must be allocated based on the percentage calculated under section 290.06, subdivision 2c, paragraph (e).
- EFFECTIVE DATE. This section is effective retroactively for taxable years beginning after December 31, 2015.
