Minnesota Statutes 2018, section 119B.011, subdivision 20, is amended to read: 1.13 Subd. 20. Transition year families. Minnesota Statutes 2018, section 119B.025, subdivision 1, is amended to read: 2.2 Subdivision 1. **Applications.** (a) Except as provided in paragraph (c), clause (4), the 23 county shall verify the following at all initial child care applications using the universal 2.4 application: 2.5 (1) identity of adults; 2.6 (2) presence of the minor child in the home, if questionable; 2.7 (3) relationship of minor child to the parent, stepparent, legal guardian, eligible relative 2.8 caretaker, or the spouses of any of the foregoing; 2.9 2.10 (4) age; (5) immigration status, if related to eligibility; 2.11 2.12 (6) Social Security number, if given; (7) counted income; 2.13 2.14 (8) spousal support and child support payments made to persons outside the household; (9) residence; and 2.15 2.16 (10) inconsistent information, if related to eligibility. At the 3.11 end of each allocation period, any unspent funds in the portability pool must be used for 3.12 assistance under the basic sliding fee program. Subd. 3. Assistance for persons who are homeless. An applicant who is homeless and
eligible for child care assistance is exempt from the activity participation requirements under
this chapter for three months. The applicant is eligible for 60 hours of child care assistance
per service period for three months from the date the county receives the application.
Additional hours may be authorized as needed based on the applicant's participation in
employment, education, or MFIP or DWP employment plans. To continue receiving child
care assistance after the initial three months, the applicant must verify that the applicant

meets eligibility and activity requirements for child care assistance under this chapter.
