1.4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.5	Section 1. PARENTAL LEAVE WORK GROUP.
1.6	Subdivision 1. Composition of work group. The commissioner of human services shall
1.7	establish, appoint, and convene a parental leave work group consisting of 15 members who
1.8	provide equal representation from:
1.9	(1) single, married, and divorced working parents from the metro area and greater
1.10	Minnesota;
1.11	(2) families with one parent who works and one parent who does not work;
1.12	(3) employers with different types of parental leave programs, including no parental
1.13	leave program; and
1.14	(4) professionals with expertise in child psychology, child development, or family
1.15	counseling.
1.16	Subd. 2. Duties. (a) The commissioner of human services or the commissioner's designee
1.17	must convene the initial meeting of the parental leave work group. The parental leave work
1.18	group shall meet on a regular basis to perform the following duties:
1.19	(1) review and report on the needs of working parents and their children for parental
