1.2 1.3 1.4	relating to taxation; exempting certain improvements made by a qualified business; amending Minnesota Statutes 2018, sections 116J.8738, subdivisions 2, 4; 275.025, subdivisions 2, 4.
1.5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.6	Section 1. Minnesota Statutes 2018, section 116J.8738, subdivision 2, is amended to read:
1.7	Subd. 2. Qualified business. (a) A business is a qualified business if it satisfies the
1.8	requirement of this paragraph and is not disqualified under the provisions of paragraph (b).
1.9	To qualify, the business must:
1.10	(1) have operated its trade or business in a city or cities in greater Minnesota for at least
1.11	one year before applying under subdivision 3;
1.12	(2) be operating its trade or business in a city or cities in greater Minnesota at the time
1.13	of applying under subdivision 3;
1.14	(3) pay or agree to pay in the future each employee compensation, including benefits
1.15	not mandated by law, that on an annualized basis equal at least 120 percent of the federal
1.16	poverty level for a family of four;
1.17	(3) (4) plan and agree to expand its employment in one or more cities in greater Minnesota
1.18	by the minimum number of employees required under subdivision 3, paragraph (c); and
1.19	(4) (5) have received certification from the commissioner under subdivision 3 that it is
1.20	a qualified business.
1.21	(b) A business is not a qualified business if it is either:

- 2.1 (1) primarily engaged in making retail sales to purchasers who are physically present at
 2.2 the business's location or locations in greater Minnesota;
- 2.3 (2) a public utility, as defined in section 336B.01; or

2.4 (3) primarily engaged in lobbying; gambling; entertainment; professional sports; political
2.5 consulting; leisure; hospitality; or professional services provided by attorneys, accountants,
2.6 business consultants, physicians, or health care consultants.

2.7 (c) The requirements in paragraph (a) that the business's operations and expansion be
2.8 located in a city do not apply to an agricultural processing facility or a project designed to
2.9 qualify under section 41A.20.

2.10 **EFFECTIVE DATE.** This section is effective August 1, 2019.

2.11 Sec. 2. Minnesota Statutes 2018, section 116J.8738, subdivision 4, is amended to read:

2.12 Subd. 4. Available tax incentives. (a) A qualified business is entitled to a sales tax

exemption, up to \$5,000,000 annually and \$40,000,000 during the total period of the

agreement, as provided in section 297A.68, subdivision 44, for purchases made during the

2.15 period the business was certified as a qualified business under this section. The commissioner

2.16 has discretion to set the maximum amounts of the annual and total sales tax exemption

2.17 allowed for each qualifying business as part of the business subsidy agreement.

(b) Any improvements to real property owned or leased by a qualified business during
 the period the business is certified as a qualified business under this section is not subject
 to the state general tax under section 275.025, provided that the improvement is used in the
 conduct of the trade or business of the qualified business.

2.22 **EFFECTIVE DATE.** This section is effective for assessments beginning in 2019.

2.23 Sec. 3. Minnesota Statutes 2018, section 275.025, subdivision 2, is amended to read:

2.24 Subd. 2. Commercial-industrial tax capacity. For the purposes of this section,

2.25 "commercial-industrial tax capacity" means the tax capacity of all taxable property classified
2.26 as class 3 or class 5(1) under section 273.13, excluding:

(1) the tax capacity attributable to the first \$100,000 of market value of each parcel of
commercial-industrial property as defined under section 273.13, subdivision 24, clauses (1)
and (2);

- 2.30 (2) electric generation attached machinery under class 3; and
- 2.31 (3) property described in section 473.625-; and

(4) property described in section 116J.8738, subdivision 4, paragraph (b).

County commercial-industrial tax capacity amounts are not adjusted for the captured 3.2 net tax capacity of a tax increment financing district under section 469.177, subdivision 2, 3.3 the net tax capacity of transmission lines deducted from a local government's total net tax 3.4 capacity under section 273.425, or fiscal disparities contribution and distribution net tax 3.5 capacities under chapter 276A or 473F. For purposes of this subdivision, the procedures 3.6 for determining eligibility for tier 1 under section 273.13, subdivision 24, clauses (1) and 3.7 (2), shall apply in determining the portion of a property eligible to be considered within the 3.8 first \$100,000 of market value. 3.9

EFFECTIVE DATE. This section is effective for assessments beginning in 2019.

3.11 Sec. 4. Minnesota Statutes 2018, section 275.025, subdivision 4, is amended to read:

Subd. 4. Apportionment and levy of state general tax. The state general tax must be 3.12 levied by applying a uniform rate to all commercial-industrial tax capacity and a uniform 3.13 rate to all seasonal residential recreational tax capacity. The commercial-industrial share of 3.14 the levy must be reduced by a fraction equal to the tax capacity of property defined under 3.15 section 116J.8738, subdivision 4, paragraph (b), divided by the sum of (1) total statewide 3.16 commercial-industrial tax capacity, plus (2) the tax capacity of property defined under 3.17 section 116J.8738, subdivision 4, paragraph (b). On or before October 1 each year, the 3.18 commissioner of revenue shall certify the preliminary state general levy rates to each county 3.19 auditor that must be used to prepare the notices of proposed property taxes for taxes payable 3.20 in the following year. By January 1 of each year, the commissioner shall certify the final 3.21 state general levy rates to each county auditor that shall be used in spreading taxes. 3.22
