1.6	Section 1. Minnesota Statutes 2018, section 477A.013, subdivision 1, is amended to read:
1.7	Subdivision 1. Towns. (a) In 2014 and thereafter, Each town is eligible for a distribution
1.8	under this subdivision equal to the product of (i) its agricultural property factor, (ii) its town
1.9	area factor, (iii) its population factor, and (iv) 0.0045 for 2014 through 2020 or 0.009 for
1.10	2021 and thereafter. As used in this subdivision, the following terms have the meanings
1.11	given them:
1.12	(1) "agricultural property factor" means the ratio of the adjusted net tax capacity of
1.13	agricultural property located in a town, to the adjusted net tax capacity of all other property

(4) "population factor" means the square root of the towns' population.
(b) If the sum of the aids payable to all towns under this subdivision exceeds the limit under section 477A.03, subdivision 2c, the distribution to each town must be reduced proportionately so that the total amount of aids distributed under this subdivision does not exceed the limit in section 477A.03, subdivision 2c.
(c) Data used in calculating aids to towns under this subdivision, other than acreage, shall be the most recently available data as of January 1 in the year in which the aid is calculated.
