1.5	Section 1. Minnesota Statutes 2014, section 290.06, subdivision 2c, is amended to read:
1.6	Subd. 2c. Schedules of rates for individuals, estates, and trusts. (a) The income
1.7	taxes imposed by this chapter upon married individuals filing joint returns and surviving
1.8	spouses as defined in section 2(a) of the Internal Revenue Code must be computed by
1.9	applying to their taxable net income the following schedule of rates:
1.10	(1) On the first \$35,480 \$36,820, 5.35 percent;
1.11	(2) On all over $\frac{35,480}{36,820}$ , but not over $\frac{140,960,7.05}{146,270,6.45}$ percent;
1.12	(3) On all over <u>\$140,960</u> <u>\$146,270</u> , but not over <u>\$250,000</u> <u>\$259,420</u> , 7.85 percent;
1.13	(4) On all over <del>\$250,000</del> <u>\$259,420</u> , 9.85 percent.
1.14	Married individuals filing separate returns, estates, and trusts must compute their
1.15	income tax by applying the above rates to their taxable income, except that the income

2.2 as a head of household as defined in section 2(b) of the Internal Revenue Code must be

more than \$100. The amount of tax for each bracket shall be computed at the rates set
forth in this subdivision, provided that the commissioner may disregard a fractional part of
a dollar unless it amounts to 50 cents or more, in which case it may be increased to \$1.

(e) An individual who is not a Minnesota resident for the entire year must compute
the individual's Minnesota income tax as provided in this subdivision. After the
application of the nonrefundable credits provided in this chapter, the tax liability must
then be multiplied by a fraction in which:

(1) the numerator is the individual's Minnesota source federal adjusted gross income 2.19 as defined in section 62 of the Internal Revenue Code and increased by the additions 2.20 required under section 290.01, subdivision 19a, clauses (1), (5), (6), (7), (8), (9), and (11) 2.21 to (14), and reduced by the Minnesota assignable portion of the subtraction for United 2.22 States government interest under section 290.01, subdivision 19b, clause (1), and the 2.23 subtractions under section 290.01, subdivision 19b, clauses (8), (9), (13), (14), (16), 2.24 and (17), after applying the allocation and assignability provisions of section 290.081, 2.25 clause (a), or 290.17; and 2.26

(2) the denominator is the individual's federal adjusted gross income as defined in
section 62 of the Internal Revenue Code of 1986, increased by the amounts specified in
section 290.01, subdivision 19a, clauses (1), (5), (6), (7), (8), (9), and (11) to (14), and
reduced by the amounts specified in section 290.01, subdivision 19b, clauses (1), (8), (9),
(13), (14), (16), and (17).

3.1	Subd. 2d. Inflation adjustment of brackets. (a) For taxable years beginning after
3.2	December 31, 2013 2016, the minimum and maximum dollar amounts for each rate
3.3	bracket for which a tax is imposed in subdivision 2c shall be adjusted for inflation by the
3.4	percentage determined under paragraph (b). For the purpose of making the adjustment as
3.5	provided in this subdivision all of the rate brackets provided in subdivision 2c shall be the
3.6	rate brackets as they existed for taxable years beginning after December 31, 2012 2015,
3.7	and before January 1, 2014 2017. The rate applicable to any rate bracket must not be
3.8	changed. The dollar amounts setting forth the tax shall be adjusted to reflect the changes
