- 1.8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
- 1.9 Section 1. Minnesota Statutes 2018, section 256B.0659, subdivision 1, is amended to read:
- 1.10 Subdivision 1. **Definitions.** (a) For the purposes of this section, the terms defined in
- 1.11 paragraphs (b) to (r) have the meanings given unless otherwise provided in text.
- 1.12 (b) "Activities of daily living" means grooming, dressing, bathing, transferring, mobility,
- 1.13 positioning, eating, and toileting.
- 1.14 (c) "Behavior," effective January 1, 2010, means a category to determine the home care
- 1.15 rating and is based on the criteria found in this section. "Level I behavior" means physical
- 1.16 aggression towards self, others, or destruction of property that requires the immediate
- 1.17 response of another person.
- 1.18 (d) "Complex health-related needs," effective January 1, 2010, means a category to
- 1.19 determine the home care rating and is based on the criteria found in this section.
- 1.20 (e) "Commissioner" means the commissioner of human services.
- 1.21 (f) "Component value" means underlying factors that are built into the rate methodology
- 1.22 to calculate service rates and that are part of the cost of providing services.

2.1 (g) "Critical activities of daily living," effective January 1, 2010, means transferring,
2.2 mobility, eating, and toileting.

2.3 ~~(h)~~ (h) "Dependency in activities of daily living" means a person requires assistance to
2.4 begin and complete one or more of the activities of daily living.

2.5 (i) "Enhanced care personal care assistance services" means personal care assistance
2.6 services included in a care plan developed according to subdivision 7 provided to a recipient
2.7 who qualifies for ten or more hours per day of personal care assistance services by a personal
2.8 care assistant who satisfies the requirements of subdivision 11, paragraph (d).

2.9 ~~(j)~~ (j) "Extended personal care assistance service" means personal care assistance services
2.10 or enhanced care personal care assistance services included in a service plan under one of
2.11 the home and community-based services waivers authorized under sections 256B.0915,
2.12 256B.092, subdivision 5, and 256B.49, which exceed the amount, duration, and frequency
2.13 of the state plan personal care assistance services or enhanced care personal care assistance
2.14 services for participants who:

2.15 (1) need assistance provided periodically during a week, but less than daily will not be
2.16 able to remain in their homes without the assistance, and other replacement services are
2.17 more expensive or are not available when personal care assistance services or enhanced
2.18 care personal care assistance services are to be reduced; or

2.19 (2) need additional personal care assistance services or enhanced care personal care
2.20 assistance services beyond the amount authorized by the state plan personal care assistance
2.21 assessment in order to ensure that their safety, health, and welfare are provided for in their
2.22 homes.

2.23 ~~(k)~~ (k) "Health-related procedures and tasks" means procedures and tasks that can be
2.24 delegated or assigned by a licensed health care professional under state law to be performed
2.25 by a personal care assistant.

2.26 ~~(l)~~ (l) "Instrumental activities of daily living" means activities to include meal planning
2.27 and preparation; basic assistance with paying bills; shopping for food, clothing, and other
2.28 essential items; performing household tasks integral to the personal care assistance services;
2.29 communication by telephone and other media; and traveling, including to medical
2.30 appointments and to participate in the community.

2.31 ~~(m)~~ (m) "Managing employee" has the same definition as Code of Federal Regulations,
2.32 title 42, section 455.

3.1 (n) "Median" means the amount that divides distribution between two equal groups,
 3.2 one-half above the median and one-half below the median.

3.3 ~~(k)~~ (o) "Qualified professional" means a professional providing supervision of personal
 3.4 care assistance services and staff as defined in section 256B.0625, subdivision 19c.

3.5 (p) "Qualified professional service" means supervision of personal care assistance services
 3.6 and personal care assistants provided by a qualified professional under section 256B.0625,
 3.7 subdivision 19c.

3.8 ~~(h)~~ (q) "Personal care assistance provider agency" means a medical assistance enrolled
 3.9 provider that provides or assists with providing personal care assistance services and includes
 3.10 a personal care assistance provider organization, personal care assistance choice agency,
 3.11 class A licensed nursing agency, and Medicare-certified home health agency.

3.12 ~~(m)~~ (r) "Personal care assistant" or "PCA" means an individual employed by a personal
 3.13 care assistance agency who provides personal care assistance services.

3.14 ~~(n)~~ (s) "Personal care assistance care plan" means a written description of personal care
 3.15 assistance services developed by the personal care assistance provider according to the
 3.16 service plan.

3.17 ~~(o)~~ (t) "Responsible party" means an individual who is capable of providing the support
 3.18 necessary to assist the recipient to live in the community.

3.19 ~~(p)~~ (u) "Self-administered medication" means medication taken orally, by injection,
 3.20 nebulizer, or insertion, or applied topically without the need for assistance.

3.21 ~~(q)~~ (v) "Service plan" means a written summary of the assessment and description of
 3.22 the services needed by the recipient.

3.23 ~~(r)~~ (w) "Wages and benefits" means wages and salaries, the employer's share of FICA
 3.24 taxes, Medicare taxes, state and federal unemployment taxes, workers' compensation, mileage
 3.25 reimbursement, health and dental insurance, life insurance, disability insurance, long-term
 3.26 care insurance, uniform allowance, and contributions to employee retirement accounts.

3.27 **EFFECTIVE DATE.** This section is effective January 1, 2020, or upon federal approval,
 3.28 whichever is later. The commissioner of human services shall notify the revisor of statutes
 3.29 when approval is obtained.

3.30 Sec. 2. Minnesota Statutes 2018, section 256B.0659, subdivision 11, is amended to read:

3.31 Subd. 11. **Personal care assistant; requirements.** (a) A personal care assistant must
 3.32 meet the following requirements:

4.1 (1) be at least 18 years of age with the exception of persons who are 16 or 17 years of
4.2 age with these additional requirements:

4.3 (i) supervision by a qualified professional every 60 days; and

4.4 (ii) employment by only one personal care assistance provider agency responsible for
4.5 compliance with current labor laws;

4.6 (2) be employed by a personal care assistance provider agency;

4.7 (3) enroll with the department as a personal care assistant after clearing a background
4.8 study. Except as provided in subdivision 11a, before a personal care assistant provides
4.9 services, the personal care assistance provider agency must initiate a background study on
4.10 the personal care assistant under chapter 245C, and the personal care assistance provider
4.11 agency must have received a notice from the commissioner that the personal care assistant
4.12 is:

4.13 (i) not disqualified under section 245C.14; or

4.14 (ii) is disqualified, but the personal care assistant has received a set aside of the
4.15 disqualification under section 245C.22;

4.16 (4) be able to effectively communicate with the recipient and personal care assistance
4.17 provider agency;

4.18 (5) be able to provide covered personal care assistance services according to the recipient's
4.19 personal care assistance care plan, respond appropriately to recipient needs, and report
4.20 changes in the recipient's condition to the supervising qualified professional or physician;

4.21 (6) not be a consumer of personal care assistance services;

4.22 (7) maintain daily written records including, but not limited to, time sheets under
4.23 subdivision 12;

4.24 (8) effective January 1, 2010, complete standardized training as determined by the
4.25 commissioner before completing enrollment. The training must be available in languages
4.26 other than English and to those who need accommodations due to disabilities. Personal care
4.27 assistant training must include successful completion of the following training components:
4.28 basic first aid, vulnerable adult, child maltreatment, OSHA universal precautions, basic
4.29 roles and responsibilities of personal care assistants including information about assistance
4.30 with lifting and transfers for recipients, emergency preparedness, orientation to positive
4.31 behavioral practices, fraud issues, and completion of time sheets. Upon completion of the

5.1 training components, the personal care assistant must demonstrate the competency to provide
5.2 assistance to recipients;

5.3 (9) complete training and orientation on the needs of the recipient; and

5.4 (10) be limited to providing and being paid for up to 275 hours per month of personal
5.5 care assistance services regardless of the number of recipients being served or the number
5.6 of personal care assistance provider agencies enrolled with. The number of hours worked
5.7 per day shall not be disallowed by the department unless in violation of the law.

5.8 (b) A legal guardian may be a personal care assistant if the guardian is not being paid
5.9 for the guardian services and meets the criteria for personal care assistants in paragraph (a).

5.10 (c) Persons who do not qualify as a personal care assistant include parents, stepparents,
5.11 and legal guardians of minors; spouses; paid legal guardians of adults; family foster care
5.12 providers, except as otherwise allowed in section 256B.0625, subdivision 19a; and staff of
5.13 a residential setting.

5.14 (d) Personal care assistants providing enhanced care personal care services must satisfy
5.15 the current requirements of Medicare for training and competency or competency evaluation
5.16 of home health aides or nursing assistants, as provided in Code of Federal Regulations, title
5.17 42, section 483.141 or 484.36, or alternative state-approved training or competency
5.18 requirements.

5.19 **EFFECTIVE DATE.** This section is effective January 1, 2020, or upon federal approval,
5.20 whichever is later. The commissioner of human services shall notify the revisor of statutes
5.21 when approval is obtained.

5.22 Sec. 3. Minnesota Statutes 2018, section 256B.0659, subdivision 21, is amended to read:

5.23 Subd. 21. **Requirements for provider enrollment of personal care assistance provider**
5.24 **agencies.** (a) All personal care assistance provider agencies must provide, at the time of
5.25 enrollment, reenrollment, and revalidation as a personal care assistance provider agency in
5.26 a format determined by the commissioner, information and documentation that includes,
5.27 but is not limited to, the following:

5.28 (1) the personal care assistance provider agency's current contact information including
5.29 address, telephone number, and e-mail address;

5.30 (2) proof of surety bond coverage. Upon new enrollment, or if the provider's Medicaid
5.31 revenue in the previous calendar year is up to and including \$300,000, the provider agency
5.32 must purchase a surety bond of \$50,000. If the Medicaid revenue in the previous year is

6.1 over \$300,000, the provider agency must purchase a surety bond of \$100,000. The surety
6.2 bond must be in a form approved by the commissioner, must be renewed annually, and must
6.3 allow for recovery of costs and fees in pursuing a claim on the bond;

6.4 (3) proof of fidelity bond coverage in the amount of \$20,000;

6.5 (4) proof of workers' compensation insurance coverage;

6.6 (5) proof of liability insurance;

6.7 (6) a description of the personal care assistance provider agency's organization identifying

6.9 of the directors, owners, or staff to other service providers;

6.10 (7) a copy of the personal care assistance provider agency's written policies and
6.11 procedures including: hiring of employees; training requirements; service delivery; and
6.12 employee and consumer safety including process for notification and resolution of consumer
6.13 grievances, identification and prevention of communicable diseases, and employee
6.14 misconduct;

6.15 (8) copies of all other forms the personal care assistance provider agency uses in the
6.16 course of daily business including, but not limited to:

6.17 (i) a copy of the personal care assistance provider agency's time sheet if the time sheet
6.18 varies from the standard time sheet for personal care assistance services approved by the
6.19 commissioner, and a letter requesting approval of the personal care assistance provider
6.20 agency's nonstandard time sheet;

6.21 (ii) the personal care assistance provider agency's template for the personal care assistance
6.22 care plan; and

6.23 (iii) the personal care assistance provider agency's template for the written agreement
6.24 in subdivision 20 for recipients using the personal care assistance choice option, if applicable;

6.25 (9) a list of all training and classes that the personal care assistance provider agency
6.26 requires of its staff providing personal care assistance services;

6.27 (10) documentation that the personal care assistance provider agency and staff have
6.28 successfully completed all the training required by this section, including the requirements
6.29 under subdivision 11, paragraph (d), if enhanced care personal care services are provided
6.30 and submitted for reimbursement under this section;

6.31 (11) documentation of the agency's marketing practices;

7.1 (12) disclosure of ownership, leasing, or management of all residential properties that
7.2 is used or could be used for providing home care services;

7.3 (13) documentation that the agency will use the following percentages of revenue
7.4 generated from the medical assistance rate paid for personal care assistance services for
7.5 employee personal care assistant wages and benefits: 72.5 percent of revenue in the personal
7.6 care assistance choice option and 72.5 percent of revenue from other personal care assistance
7.7 providers. The revenue generated by the qualified professional and the reasonable costs
7.8 associated with the qualified professional shall not be used in making this calculation; and

7.9 (14) effective May 15, 2010, documentation that the agency does not burden recipients'
7.10 free exercise of their right to choose service providers by requiring personal care assistants
7.11 to sign an agreement not to work with any particular personal care assistance recipient or
7.12 for another personal care assistance provider agency after leaving the agency and that the
7.13 agency is not taking action on any such agreements or requirements regardless of the date
7.14 signed.

7.15 (b) Personal care assistance provider agencies shall provide the information specified
7.16 in paragraph (a) to the commissioner at the time the personal care assistance provider agency
7.17 enrolls as a vendor or upon request from the commissioner. The commissioner shall collect
7.18 the information specified in paragraph (a) from all personal care assistance providers
7.19 beginning July 1, 2009.

7.20 (c) All personal care assistance provider agencies shall require all employees in
7.21 management and supervisory positions and owners of the agency who are active in the
7.22 day-to-day management and operations of the agency to complete mandatory training as
7.23 determined by the commissioner before enrollment of the agency as a provider. Employees
7.24 in management and supervisory positions and owners who are active in the day-to-day
7.25 operations of an agency who have completed the required training as an employee with a
7.26 personal care assistance provider agency do not need to repeat the required training if they
7.27 are hired by another agency, if they have completed the training within the past three years.
7.28 By September 1, 2010, the required training must be available with meaningful access
7.29 according to title VI of the Civil Rights Act and federal regulations adopted under that law
7.30 or any guidance from the United States Health and Human Services Department. The
7.31 required training must be available online or by electronic remote connection. The required
7.32 training must provide for competency testing. Personal care assistance provider agency
7.33 billing staff shall complete training about personal care assistance program financial
7.34 management. This training is effective July 1, 2009. Any personal care assistance provider
7.35 agency enrolled before that date shall, if it has not already, complete the provider training

8.1 within 18 months of July 1, 2009. Any new owners or employees in management and
8.2 supervisory positions involved in the day-to-day operations are required to complete
8.3 mandatory training as a requisite of working for the agency. Personal care assistance provider
8.4 agencies certified for participation in Medicare as home health agencies are exempt from
8.5 the training required in this subdivision. When available, Medicare-certified home health
8.6 agency owners, supervisors, or managers must successfully complete the competency test.

8.11 Subd. 24. **Personal care assistance provider agency; general duties.** A personal care
8.12 assistance provider agency shall:

8.13 (1) enroll as a Medicaid provider meeting all provider standards, including completion
8.14 of the required provider training;

8.15 (2) comply with general medical assistance coverage requirements;

8.16 (3) demonstrate compliance with law and policies of the personal care assistance program
8.17 to be determined by the commissioner;

8.18 (4) comply with background study requirements;

8.19 (5) verify and keep records of hours worked by the personal care assistant and qualified
8.20 professional;

8.21 (6) not engage in any agency-initiated direct contact or marketing in person, by phone,
8.22 or other electronic means to potential recipients, guardians, or family members;

11.14 for the standard occupational classification (SOC) codes published by the Bureau of Labor
11.15 Statistics in the most recent edition of the Occupational Handbook. The commissioner shall
11.16 calculate the wage component values as follows:

11.17 (1) for personal care assistance services, the base wage component value shall be the
11.18 median wage for personal care aide (SOC code 39-9021);

11.19 (2) for enhanced care personal care assistance services, the base wage component value
11.20 shall be the sum of 50 percent of the median wage for personal care aide (SOC code 39-9021)

12.5 The product is the total wage component value.

12.6 (b) For personal care assistance services and for enhanced care personal care assistance
12.7 services, the initial competitive workforce factor is eight percent.

12.8 (c) For qualified professional services, the competitive workforce factor is zero.
