1.7	Section 1. Minnesota Statutes 2018, section 120B.024, subdivision 1, is amended to read:
1.8	Subdivision 1. Graduation requirements. Students beginning 9th grade in the 2011-2012
1.9	school year and later must successfully complete the following high school level credits for
1.10	graduation:
1.11	(1) four credits of language arts sufficient to satisfy all of the academic standards in
1.12	English language arts;
1.13	(2) three credits of mathematics, including an algebra II credit or its equivalent, sufficient

(d) Expectations of schools, districts, and the state for career or college readiness under
this subdivision must be comparable in rigor, clarity of purpose, and rates of student
completion.

A student under paragraph (c), clause (1), must receive targeted, relevant, academically 5.7 rigorous, and resourced instruction, which may include a targeted instruction and intervention 5.8 plan focused on improving the student's knowledge and skills in core subjects so that the 5.9 student has a reasonable chance to succeed in a career or college without need for 5.10 postsecondary remediation. and other performance measures are accessible to them and they may seek postsecondary
education or employment without need for postsecondary remediation. When administering
formative or summative assessments used to measure the academic progress, including the
oral academic development, of English learners and inform their instruction, schools must
ensure that the assessments are accessible to the students and students have the modifications
and supports they need to sufficiently understand the assessments.

(g) Districts and schools, on an annual basis, must use career exploration elements to 6.7 help students, beginning no later than grade 9, and their families explore and plan for 6.8 postsecondary education or careers based on the students' interests, aptitudes, and aspirations. 6.9 Districts and schools must use timely regional labor market information and partnerships, 6.10 among other resources, to help students and their families successfully develop, pursue, 6.11 review, and revise an individualized plan for postsecondary education or a career. that extend beyond course grades.
