The legislature hereby finds and declares the following: 1.8 (1) that the authority to use deadly force, conferred on peace officers by this section, is 1.9 a critical responsibility that shall be exercised judiciously and with respect for human rights 1.10 and dignity and for the sanctity of every human life. The legislature further finds and declares 1.11 that every person has a right to be free from excessive use of force by officers acting under 1.12 color of law; 1.13 (2) as set forth below, it is the intent of the legislature that peace officers use deadly 1.14 force only when necessary in defense of human life.
