- (2) certify that the damage or loss was (i) sustained within a county that was the subject of a state or federal disaster declaration  $\frac{\partial F_2}{\partial F_2}$  (ii) due to the confirmed presence of the highly pathogenic avian influenza in a commercial poultry or game flock located in Minnesota; or (iii) due to an emergency as determined by the authority;
  - (3) demonstrate an ability to repay the loan; and
